Check the boxes below:

**I. UNDER HOOD**

- ENGINE** – Oil is at prescribed level and free of contamination or discoloration – block, cylinder heads, intake and exhaust manifolds are free of cracks, and all seals and gaskets are free of fluid seepage or leaks.
- AUTOMATIC TRANSMISSION FLUID** is at the prescribed level and free of contamination or discoloration.
- POWER STEERING** pump reservoir and gear box are at the prescribed level and free of contamination or discoloration.
- COOLING FAN** is working correctly
- BRAKE MASTER CYLINDER** is at the prescribed level and all seals and gaskets are free of fluid seepage or leaks.
- RADIATOR** is free of leaks and at the prescribed level. **COOLANT** is free of contamination.
- BELTS, HOSES, AND VACUUM LINES** are free of cracks/fluid seepage or leaks.
- ALTERNATOR, BATTERY AND CHARGING SYSTEM** are working correctly.

**II. UNDER VEHICLE**

- TRANSMISSION CASE** is free of cracks and all seals and gaskets are free of fluid seepage or leaks.
- STANDARD TRANSMISSION FLUID** is at the prescribed level and free of contamination or discoloration (also transfer case on 4x4s) and all seals and gaskets are free of fluid seepage or leaks.
- REAR AXLE FLUID** is at the prescribed level (also front axle on 4x4s) and all seals, gaskets and housing are free of fluid seepage or leaks.
- FRAME/UNIBODY** - and all structural components are free from damage.
- EXHAUST SYSTEM / CATALYTIC CONVERTER** are in place and free from damage.

**III. ROAD TEST**

- ENGINE** is operating properly and shows no obvious signs of problems (i.e. excessive smoking, poor performance, etc.)
- ENGINE OIL PRESSURE AND OPERATING TEMPERATURES** are within normal range levels.
- AUTOMATIC TRANSMISSION** is shifting smoothly and quietly .
- STANDARD TRANSMISSION** is shifting properly and quietly (also transfer case 4x4s).
- VIBRATION** in the drive line, if any, must be corrected. **COMMENTS:** \_\_\_\_\_
- UNUSUAL NOISES** – Conditions causing unusual noises in the engine, transmission, drive shaft, universal joints, or rear axle have been corrected. **COMMENTS:** \_\_\_\_\_

- SUN ROOF, CONVERTIBLE TOP, WINDSHIELD WIPERS (FRONT & BACK)** are working correctly.
- SEAT MOTOR, POWER WINDOWS, POWER MIRROR MOTOR, AND HEATED BACK GLASS** are working correctly.
