- 3.1 Proposed site area. 3.8 ha.
- 3.2 Can the proposed LGS site be considered an "extensive tract of land"? Medium size area surrounded by grassland, species-rich hedgerows, Woodland, scrub, mature trees and surviving ridge & furrow.
- 3.3 Can this proposed LGS been considered "local in character", if so why? Immediately adjacent to the current Limits to Development boundary off Bullfurlong Lane. Highly valued by the local community living close by, evidenced by the many additional informal footpaths over the western part.



Target note 87 - SP438916 Hedgerow, no close access, viewed with binoculars. Species recorded: Corylus avellana, Fraxinus excelsior, Sambucus nigra, Ulmus sp., Rosa sp., Crataegus monogyna, Prunus sp. Reasonably varied. Small gaps.

Target note 90 Burbage SP436915 Hedgerow. Species recorded: Ulmus sp., Sambucus nigra, Crataegus monogyna, Fraxinus excelsior, Acer campestre, Ilex aquifolium, Rosa sp., Prunus spinosa, Quercus cerris, Cornus sanguine a, Malus sp., Rosa sp. Varied. cLWS

Target note 101 - SP435916 Standing water. Pond under trees, shaded. Almost dried out, small area of shallow water remaining. Small stand of Iris pseudacorus. No other aquatic vegetation. Lots of bare mud. Banks shallow. Second smaller pond to north over bank, also dry.
