Approval for the Reopening of Sugar Boat Charters Inc.

The Ministry of Tourism, Information and Broadcasting, Culture and Creative Industries and the Department of Health and Wellness, having jointly conducted a training session in COVID-19 Health and Safety Protocols submits the following for your attention:

A. Recommendation:

Based on an assessment of the vessel for compliance with the protocols for dayboat operators and in accordance with Section 30 of the COVID-19 (Prevention and Control) Act No. 9 of 2020, the Ministry hereby approves the reopening of Sugar Boat Charters Inc. subject to the following:

B. Conditions:

That the management of Sugar Boat Charters Inc:

- a. Shall at NO time permit a mix of local, regional (travel bubble) and international guests on board the vessel;
- b. Shall NOT exceed capacity requirements stipulated in the conditions of the licence as approved by the Saint Lucia Air and Sea Port Authority;

- c. Undertakes daily logging of body temperatures for staff and guests;
- d. Adheres to all other protocols established by the Department of Health and Wellness; and
- e. Fully complies with all other relevant laws of Saint Lucia.
