

ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY

This document will affect your legal rights and liabilities. You are waiving your right to legal action including lawsuit.

Please read carefully.

The Undersigned assumes the unavoidable risks inherent in all horse-related activities, including but not limited to bodily injury and physical harm to horse, rider, and spectator. Accordingly, I/we agree that any activity engaged in by me/us on the premises, relating to horses or otherwise, is done at my/our own risk.

_____ RISKS/ASSUMPTION OF RISK. I understand that anyone riding, handling, or even near a horse or pony (these animals will hereafter be referred to as "equine" in this document) can suffer bodily and other injuries at any time and without warning. Among other things, equine are unpredictable by nature. For example, when frightened, angry or under stress, the natural instincts of equine are to jump forward or sideways, back up quickly, or run away from danger by trotting or galloping. Equine are also known to kick, buck, rear up, spin around, strike, or bite. I know that equine can do any of these things without warning. I also understand that all equine, even if they have no history of inflicting injury, are powerful and have the potential to be dangerous to people and animals that are on, near, or around them.

_____ Further, I understand that riding, handling, or being near an equine and/or receiving instruction or guidance on or around equine can expose me to numerous hazards, which could include, for example: the propensity of an equine to behave in ways that may result in injury, harm, or death to persons on or around them; the unpredictability of an equine's reaction to sounds, sudden movement, and unfamiliar objects, persons, or other animals; certain hazards such as surface or subsurface conditions on, near, or off of the property; and/or collisions with other equine, animals, or objects. I understand these risks and dangers inherent in equine activities and I agree to assume each and every one of them. I also understand that these are just some of the risks, and I agree to assume others that are not mentioned above. I am not relying on anyone to list all possible equine-related risks for me in this document or at any time, now or in the future.

_____ In consideration, therefore, for the privilege of riding and/or working around horses on the private property of Preston Scott Baggerly and Diane M. Baggerly located at 5601 N. Equestrian Terrace, Crystal River, Florida 34428, the Undersigned does hereby agree to hold harmless and indemnify Preston Scott Baggerly and Diane M. Baggerly (husband and wife); Faith Haven Christian Retreat Center, Inc. (a Florida 501(C)3 Corporation) along with its Board of Directors; and any and all persons or entities who are guarantors or indemnitors of the above, all agents, employees, promoters, sponsors, other horse riders, horse owners, advertisers, sales persons, photographers, volunteers (hereinafter called Releasees) and further release them from any liability or responsibility for accident, damage, injury, or illness to the Undersigned or to any horse owned by the Undersigned or to any family member or spectator accompanying the Undersigned on the premises.

_____ I/we agree not to sue any Releasees, and I/we release and agree to indemnify for the Releasees from and for all liability for the undersigned, his/her person, representatives, assignees, heirs, and demands therefore on account of injury to her person or property, or death of undersigned whether caused by the negligence of the Releasees or otherwise.

_____ I/we agree that this release is intended to be as broad and inclusive as is permitted by the law of the State of Florida, where the activities are conducted, and if any part hereof is held invalid, it is agreed that the balance shall continue of full force and effect.

_____ All lesson riders will be dressed properly to ride: long pants, preferably jeans; and riding boots. No open shoes. No sandals. No exceptions.

_____ I/we have read and voluntarily signed this ASSUMPTION OF RISK, WAIVER AND RELEASE OF LIABILITY and further agree that no oral representations, statements, or inducements apart from the foregoing written agreements have been made nor shall be made except by a written and signed addendum.

WARNING
