## What information do we collect?

ALL MAVEN Inc. collects information from you when you fill out an application online or via regular mail or fax, register on our site, place an order, subscribe to our newsletter, respond to a survey, fill out a form or complete a poll.

When applying to be a client, ordering products or services, or registering on our site, as appropriate, you may be asked to enter your: name, business information, Tax ID/EIN, e-mail address, mailing address, phone number or bank account/credit card information. You may, however, visit our site anonymously.

Google, as a third party vendor, uses cookies to serve ads on your site. Google's use of the DART cookie enables it to serve ads to your users based on their visit to your sites and other sites on the Internet. ## What do we use your information for?

Any of the information we collect from you may be used in one or more of the following ways:

## How do we protect your information?

ALL MAVEN Inc. implements a variety of security measures to maintain the safety of your personal information when you place an order or enter, submit, or access your personal information.

We offer the use of a secure server. All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our Payment gateway providers database only to be accessible by those authorized with special access rights to such systems, and are required to keep the information confidential.

After a transaction, your private information (credit cards, social security numbers, financials, etc.) will not be stored on our servers, unless a recurring billing or subscription plan has been set in place.

## Do we use cookies?
