- 2 We believe that there is one God, eternally existent in three persons: Father, Son and Holy Spirit.
- 3 We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death through His shed blood, in His bodily resurrection, in His ascension to the right hand of the Father and in His personal return in power and glory.
- 4 We believe that for the salvation of lost and sinful man, regeneration by the Holy Spirit through faith in Jesus Christ is absolutely essential.
- 5 We believe in the baptism in the Holy Spirit with the evidence of speaking in other tongues as the Spirit gives utterance according to Acts 2:4, and in the operation of the spiritual gifts and ministries.
- 6 We believe in the ministry of the Holy Spirit by whose indwelling the Christian is enabled to live a Godly life.
