

Rental Agreement

Deposit/Credit Card Authorization A deposit equal to the replacement cost of the equipment is required; **If the gear is not returned within 2-3 days of the agreed upon rental period, the card will be charged for the replacement value of the gear.** The renter also agrees that authorized funds may be used to pay for repairs to the gear in case of damage. A Visa, Mastercard, American Express, Discover card or cash may be used for this deposit. A credit card pre-authorization for the dollar amount of gear will be held until gear is returned upon which time the rental rate will be charged and the pre authorization will be released. **This agreement authorizes Englewood Camera to use a credit card on file for any loss, damage or repair to the equipment rented.** A credit card pre-authorization holds the required amount on the renters account until the pre-auth is released. The renter cannot access the authorized amount in your account until the authorization hold expires without being finalized or is settled and the banking system transfers the funds. **This may result in unavailable funds on your credit card if you have a low credit amount available or have a high balance.** A valid driver's license is also required.

Rental Period All prices are "Per Day". Each rental period runs from 10:30 am until 10am on the days agreed upon. Equipment returned after the due time often creates problems for the next renter(s). Therefore, a \$10 late fee will be assessed once the equipment is half an hour late. If it is one or more hours late, additional day(s) will be charged at the full day rate. Rentals returned more than one day late will be billed at 1.5x the daily rate. Please contact us immediately at 303-797-0700 if you expect a late return. Maximum rental period is 5 days. Fifth day is free with a 4 day rental. A one day fee is minimum for any piece of rented equipment. One day rental charges may be used towards purchase of comparable new unit within two weeks of rental.

Insurance is Not Provided Renter of equipment accepts full liability for any loss or cost of repair. Insurance coverage is the responsibility of the renter. Englewood Camera will charge the renter at the full day rate until reimbursed for the replacement cost. The required rental deposit may be secured on Visa, Mastercard, American Express or Discover. Cash for the full retail amount of the product rented (fully refundable when rental is returned in agreed upon conditions) is also acceptable. Maximum value of gear to be rented will not exceed \$5000.00.

Renter Responsibilities All rental equipment is checked by our staff to insure proper working conditions prior to leaving the premises. Englewood Camera must be notified immediately in the case of equipment difficulties at 303-797-0700. Failure to do so may result in a full rental charge. Englewood Camera assumes no liability for equipment failure, availability and/or loss of income due to equipment failure. The renter is responsible for the proper care and operation of the equipment, as well as the technical knowledge to use the gear effectively.

Initial _____

Pickups Customers are welcome to pickup rental equipment between 4:30 pm and 6:00 pm the day before their rental begins for free. Because it is possible that someone else may have the item already reserved, **we can not guarantee early pickup availability. If you absolutely need an item in the morning before the store opens, we recommend renting the item for an additional day.** Because rental availability can change frequently, we recommend calling in advance to verify early pickup availability. **We are closed Sundays weekend rentals are charged 1 days rental fees.** If you have questions regarding the early pickup policy, please contact a member of our rental department by calling 303-797-0700

Calibrations We do not calibrate rental lenses to your camera on an individual basis. Lenses are tested regularly for sharpness on our in house cameras. If you are concerned about calibrations, please check the rented lens with your body prior to your rental period.

Cleaning A \$25 cleaning fee will be charged for equipment that is returned dirty. If excessive cleaning is required, additional fees may be assessed at the discretion of Englewood Camera rental employees. Please do not remove filters from lenses. If removed, additional cleaning fee will apply.
