AVAILABLE: In municipalities and unincorporated communities in which the District is engaged in the distribution and sale of electric energy and the community or District owns the complete street lighting system. (Available to communities taking service under this schedule prior to March 1, 1980. No new fixtures will be allowed under this Rate Schedule).

APPLICABLE: To all night alley lighting (dusk to daylight) from existing overhead systems conforming to the District's standard specifications.

CHARACTER OF SERVICE: The District will install, operate, and maintain (on existing poles) the complete system and furnish alley lighting service from dusk to daylight, or approximately 4,000 hours per year.

TERMS AND CONDITIONS:

- 1. Service will be furnished under the District's Retail Service Rules and Regulations.
- Extensions made for service under this schedule are subject to the provisions of the District's "General Extension Policy for Retail Electric Services and Facilities."
- 3. The District's General Customer Service Charges, Schedule CS, shall apply.
- 4. Usage shall be prorated for application of a change in rate. Such proration shall be accomplished by fractionalizing according to the number of days of service corresponding to each time period by using the District's billing system.
- 5. For billing purposes, usage shall be normalized to 30 days when actual days of service is less than 27 days or exceeds 35 days in any given billing period.
- 6. The District retains and reserves the right, power and authority to modify, revise, amend, replace, repeal or cancel this Rate Schedule, at any time and in whole or in part, by resolution adopted by the District's Board of Directors.
