**DAY CAMP 2019**

We would like to welcome you and your children to the 2019 Somers Day Camp. We are committed to providing a quality program for our residents and dedicated to making your children's Camp experience a safe, rewarding and enjoyable one.

Day Camp is for children in the Somers community age 4 through entering 6<sup>th</sup> grade in the fall. Camp runs for 6 weeks Monday through Friday 9:00 a.m. - 3:00 p.m. from July 1<sup>st</sup> to August 9<sup>th</sup> with no camp **7/4 & 7/5**. Our Camp is a place where "kids" can be kids, as they learn and grow through social interaction with their peers and counselors.

Our Tot Group is for children ages 4 & 5 years old **not** entering Kindergarten. This is **half day ONLY**, 9:00 a.m. to 12:00 p.m. **Please note: All registrants must be 4 years old by the start of camp, 7/1, and completely potty trained.**

Campers will be divided into groups according to the grade they will be entering in September 2019. The Tot Group & Kindergarten groups will be co-ed; all other groups will be divided by gender. In the event we do not have enough children in one grade to form a group, grades may be combined.

Our program offers a variety of activities, from sports to arts and crafts, to field play, to weekly special events. We also will have an on-site inflatable **waterslide**.

For those looking to add trips to their summer camp experience (except for Tot Group), we offer trips to a local bowling alley, trampoline park, movie theatre, etc. All trips are at an additional fee which will include admission and transportation.

To run our Camp, we must obtain a permit to operate from the State of New York and the Westchester County Health Department. Per their regulations, we must have one staff member per 200 Campers certified in First Aid and one staff member per 200 Campers certified in CPR. We must maintain a ratio of one (1) staff member to twelve (12) children for on-site activities and one (1) staff member to ten (10) children for off-site activities. All staff must be at least 15 years of age (CIT) prior to the beginning of Camp to be employed, and must attend an extensive orientation and training program. The Camp is inspected twice seasonally by the Health Department. The Town of Somers, Department of Parks and Recreation Summer Day Camp meets or exceeds these requirements.
