


The Program

Club Card Program

- ♦ Steps:
- ◆ Dealer contacts 4-H or animal *non-profit* (501c3) clubs in area and informs them of the club card program
- Club signs up for program
- ◆ Registration form given to dealer along with non-profit certificate
- Dealer returns registration form to Poulin Grain
- ◆ All non profit clubs must be approved by Poulin Grain
- ◆ Poulin Grain sends the dealer club kit consisting of club punch cards, box to hold cards and membership cards
- ◆ Dealer issues club card to all club participants
- Each participant gets a membership card
- ◆ Each participant get a punch card, card must stay at store
- ◆ Each time the 4-H or club participant buys feed punch a hole for each bag
- Each punch is worth \$.25
- ♦ Once the card is full send cards on a monthly basis to Poulin Grain.
- Poulin Grain redeems the card and sends check to club.
