Notice is hereby given of a Meeting of the **Planning & Zoning Commission of Burkburnett** to be held on **Monday, June 7, 2021, at 6:00 p.m.** at City Hall-Council Chambers, 501 Sheppard Road, Burkburnett, Texas to consider the following agenda items. The Commission may discuss and take action on any item on this agenda. The Commission reserves the right to meet in a closed session on any agenda item should the need arise and, if applicable pursuant to authorization by Title 5, Chapter 551, of the Texas Government Code.

Due to Governor Abbott's reduction in COVID-19 restrictions, the Council Chamber will reopen to the public's in-person attendance. As such, there is no access to the meeting through a call bridge.

PUBLIC COMMENTS ON AGENDA ITEMS

All persons desiring to address a specific agenda item must submit a "*Public Comments*" form to the Planning Director, Sarah Culp, before the reading of the agenda item. Comments will be limited to three (3) minutes with a maximum of a two (2) minute extension following approval by a majority of the Commissioners.


ITEM 11. COMMISSIONERS' COMMENTS
