**Sub: DRDM - Issuance of 'Permanent Integrated Certificate' -
Modifications in the existing Certificate format-Reg.**

**Ref: G.O.Ms.No.13 dated 24.02.2007 of Department of Revenue and
Disaster Management.**

Orders have been issued *vide* Government order cited above for issuance of 'Permanent Integrated Certificate' and the certificate format has also been communicated. In the existing 'Permanent Integrated Certificate' format, provisions have been made for re-validating the currency of the Residence and Income certificates with an endorsement provision. In the footnote of the Residence and Income Certificates, with single and double asterisk marks respectively, the following words appear " **valid for a period of ONE YEAR from the date of issue OR the date of endorsement as mentioned below**". Also, under the heading **ENDORSEMENT PROVISIONS** the following words appear " **Revalidation for further period of ONE YEAR from the date of re-verification in respect of Residence and Income Certificates**".


The above provisions have been embedded in the Certificate format since the Residence and Income status are liable to change. However, this has lead to a misconception among the people that the 'Permanent Integrated Certificate' has to be compulsorily re-validated every year.

The Hon'ble Revenue Minister had assured on the Floor of the House that steps will be taken to remove from the certificate format, the portion that mandates annual re-validation of Income and Residence Status.

Therefore, the words “ valid for a period of ONE YEAR from the date of issue OR the date of endorsement as mentioned below” and under the heading **ENDORSEMENT PROVISIONS** the words “Revalidation for further period of ONE YEAR from the date of re-verification in respect of Residence and Income Certificates” and the asterisk marks correspondingly above the Residence Certificate and Income Certificate shall be removed from the existing format of ‘Permanent Integrated Certificate’. Accordingly the revised ‘Permanent Integrated Certificate’ format is enclosed for adherence with immediate effect.

The certificate holder may revalidate the Residence Certificate and Income Certificate in case of any change in the residential status and income status as and when the necessity for the certificates arise.
