### **1. Opening and Welcome**

Chairman, Jared Feehely, opened the meeting at 0907 and welcomed members and observers to the October meeting.

The Chair asked the Committee if there were any comments on the previous meeting minutes. The minutes were accepted by the committee.

The Chair received a letter from Observer Pat Tate and has incorporated the suggestions within the letter.

### **6. General Aviation Update**

Peter Long provided an update to the committee.

GA movements are down from the GA peak season of May, there have been no noise complaints from the local community. Peter noted that there have been issues raised at other airports such as Casino who don't hold a Fly Neighbourly Policy. Tweed Council have introduced landing fees which may have some effect on movements at Murwillumbah. ILS training has been working well, this training has been shared between GCA and Amberly. To train an ILS approach the flight school has to book it via the national booking centre. For ANZAC day a curfew exemption was sought for the fly past, no issues were raised so the same will be propositioned for next year.

### **7. Department of Infrastructure**

Russell McArthur provided an update, unfortunately the report was unable to be sent out prior to the meeting due to the latest data being unavailable due to collection time frames. Discussion around dispensation and curfew exemptions with GA aircraft. Russell also discussed the regulation changes to update some drafting errors.

## **8. Airservices Reporting**

Anthony provided an update in his presentation; his presentation will be provided to the committee. Anthony advised of recent management changes in AsA and introduced Chris McCormack who will be attending future ANACC and CACC meetings. It was noted that due to technical issues the online noise reporting data was unavailable, data should be available by the end of the month.

JF thanked Anthony Nugent for his time in the committee.

### **Question/Discussion**

#### ***ILS***

It was asked how often the ILS training has to occur for GA pilots?

PL advised that it is once every 12 months for the pilot's proficiency exams, each student uses the ILS 5-6-times, half of those times are in a simulator and physical approaches are shared with Amberly.

It was noted that only summary data was provided, where previously tabulated data was presented.

AN advised that due to AsA mathematicians process summary reports will be provided, this will also include weather data.

For purposes of transparency and confidence that the orders of AAT are being followed the committee requests that detailed tabulated ILS usage data be provided at each of the ANACC meetings.

It was asked if smoke affects the visibility.

AN advised that due to the bushfires BNE have been using instrument approaches more than normal.

#### ***Kingscliff Flights***

It was asked why flights are departing over Kingscliff when there is no flight path over them when there appears to be no conflict in the air.

AN advised that there is a radar departure over Kingscliff and safety is paramount so they will use the Kingscliff track for separation.

**Action:** JM to provide specific examples to the secretariat as they occur so investigation can be completed early.

It was requested to see the percentages of planes over Kingscliff vs Fingal.

AN will show the meeting where the information is located on the Airservices Australia website.

#### ***Noise Monitors***

Concerns were raised around noise monitoring for the ILS being restricted to 3 months. As we are heading into drought period concerned that there may not have many ILS uses during the monitoring period.

AN advised that the 3-month period is a minimum, and the contract with the service provider can allow it to extend to 6 months should the situation as described arise.

## 9. Strategic Work Program (SWP)

### 4.11 Management of increasing RPT movements at GCA – paper submitted by John Hicks.

John Hicks provided an overview of his paper, Chair asked for a group consensus on the approach to the issue. The committee approved.

1 – GCA flight path maps were displayed on screen.

JM advised that after discussions with the Ombudsmen that confirmed that the flight paths over Kingscliff are wrong in the Master Plan. AsA advised that they are splays not flight paths or tracks.

2 – GCA flight path usage numbers were displayed on screen from the AsA website

3 – GCA Noise Abatement Procedures were provided and displayed on the AsA website.

4 – Track maps were displayed on the AsA website

5 – Kingscliff tracks, a graphic has been previously provided for a 12-month period. request was made for a week of data

6 – N70 Noise Contour Maps are available online in the GCA Master Plan document.

7 – Policy and Procedure Documents were displayed on the AsA website.

8 – Fact sheets were displayed on the AsA website. RM advised that AsA legal obligations are managed under their EMS management system and looks at the obligations under the Environmental Management Act.

9 – Lease Conditions, Jared advised that GCA won't be sharing lease documents/extracts as it's a commercial and confidential document. Can confirm that there is an obligation to meet the need and demand of the community and region.

**Action:** Jared to enquire if a portion of the lease document could be released.

10 – Nil

AN advised that Airservices design procedures on current infrastructure, there is no strategy for planning for planned growth. As an example, Brisbane Airports new runway has been in the works for at least 12 years, but it was not until it was approved that AsA got involved to design new procedures.

RM advised that capacity for the airport is demonstrated as part of the Master Plan ANEF's. Ultimate capacity ANEF documents are developed saying that this would be the extent of the infrastructure's capability. BNE had an ultimate capacity ANEF and then developed the plans for the second runway.

Wouldn't be future flight paths without public consultation as part of the AsA Environmental Management of Changes to Aircraft Operations and under the *Environment Protection and Biodiversity Conservation Act 1999*.

It was asked for a map of the designated flight path, AN advised that there are many procedures that don't include a flight path.

It was asked who looks at the future of growth?

MB advised that there is a lot that goes into scheduling between airports and airlines. Level of detail being requested is too significant and impractical to provide.

It was requested that this item stays open for discussion, members to consult together and come back in the new year with an update.

### **3.1 No validation of noise exposure models used in the Master Plan**

Since this document was compiled Ron Brent has provided a presentation on ANEF's and the item may need to be revised. JH believes that the N60 and N70 contours should also be validated.

It was advised that ANACC used to be provided with tabled data of the noise monitor data. That way they can review and check the changes to Flight Paths. RM advised that the ANEF is used as a land use planning tool used as part of the safe guarding framework. The N60 and N70 contours would be more accurate.

It was asked if they could have confirmation that what is presented in the drawings is being adhered to. RM advised the granularity of the data that was requested isn't available, they are completed under modelling.

## **10. General Business**

### **Banora Point & District Residents Association Letter**

John Sweeney discussed the letter that was sent from observer Pat Tate to the ANACC Chair. The main points raised were:

- During the meeting of 6 June. A member took 48 scheduled minutes to talk through the ILS. During the same meeting AsA procedure design presentation went for an hour in total. Instead of one person having all of the say should we go around the room to get consensus.
- Equal representation from north and south. There have been 5 members north and 5 members south. With the appointment of another northern member the numbers are uneven again. We don't have a representative from Bilambil on the committee.
- Meeting dates clashing with NSW School Holidays.
- Put forward a request for someone from CASA to attend the meetings

Jared has responded by letter to Pat Tate outlining the changes that have been made and discussed this with the committee.
