2) THE EVALUATION TASK FORCE UTILIZES A WIDE RANGE OF INPUT INCLUDING COMMUNITY VOICES AND EMPIRICAL DATA TO EVALUATE THE EFFECTIVENESS OF NBT'S PROGRAMS. THE PROGRAM INCLUDES PERIODIC RESIDENT SURVEYS PERFORMED BY THE EAGLETON INSTITUTE.

3) THE NEW BRUNSWICK FAITH-BASED COALITION HAS BEEN ENGAGED IN A STRATEGIC PLANNING PROCESS TO IDENTIFY CRITICAL COMMUNITY ISSUES TO ADDRESS. THE COALITION GROUP INCLUDES PARTICIPATION OF MORE THAN 50 HOUSES OF WORSHIP IN NEW BRUNSWICK. IN 2016, THE NBT'S EFFORTS WITH THIS COALITION CAME TO A CLOSE.
