CSR POLICY

FOLLOWING CSR POLICY WAS APPROVED BY THE BOARD OF DIRECTORS IN THEIR MEETING HELD ON 07/08/2021

Corporate Social Responsibility Policy

1) Legal Provisions :-

1.1 : Section 135 of the Companies Act, 2013.

Every Company having net worth of rupees

- five hundred crore 500 cr or more or
- turnover of rupees one thousand crore 1000 Cr or more or
- a net profit of rupees five crore 5 Cr or more

During the immediately preceding financial year shall constitute a Corporate Social Responsibility Committee of the Board consisting of three or more directors out of which at least one director shall be an independent director.

The Board of every company referred to in sub section (1)(*liable to CSR*) shall ensure that the company spends in every financial years at least two percent of the average net profits of the company made during the three immediately preceding financial years in pursuance of its Corporate Social Responsibility Policy.

1.2 : Corporate Social Responsibility Rules, 2016

The CSR Policy of the Company shall inter alia include the following namely --

- (a) A list of CSR Project or Programs which a company plans to undertake areas or subjects specified in the Schedule VII of the Act specifying modalities of execution of such project or programs and implementation schedules for the same ,and
- (b) Monitoring process of such projects or programs.

The Board of Directors of the company shall after taking into account the recommendation of CSR Committee Approve the CSR Policy for the company and disclose contents of such policy in its reports and the same shall be displayed on the company's website. If any, as per the particulars specified in the Annexure.

2) Authorization :-

2.1: The CSR policy of the company is approved vide Board Resolution Dated 7th August, 2021

Approval of CSR Policy (Resolution No.2):

"Resolved that pursuant to the provisions of Section 135 (3) of the Companies Act, 2013 read with rule 5 of the Companies (Corporate Social Responsibility) Rules 2014 and any other applicable provisions of the Acts & Rules made there under, the draft policy on CSR activities to be undertaken by the company, as placed before the board duly initialed by the chairman, be and is hereby approved and adopted as the Company's CSR policy."

"Resolved further that the approval of the Board is also hereby given to take up the following two projects as the specific area of CSR activity to be executed over next 2 years in progressive manner:

1 Supporting Armed Forces Veterans, war widows and their dependent's by sponsoring their education, higher education, skill development, vocational training or by contributing to approved organizations undertaking such support activities or such other approved method;

2 Promoting Target Shooting Sports by building avenues for easy access and training, by facilitating and/or sponsoring participation, equipment, travel of budding national or international players or by contributing to the development of the sport by any alternative means allowable under approved CSR activity from time to time

The CSR committee formed by the BOARD is as under

4) Areas of Charity:-

4.1 Out of the list of the eligible activities in Schedule VII the following activities are proposed to be taken up

:Promoting Target Shooting Sports by building avenues for easy access and training,

:Supporting Armed Forces Veterans, war widows and their dependent's

:Donating to any approved organization for any of the activity approved under Schedule VII of the Companies Act, 2013 as an eligible CSR activity.

4.2 :-Justification for selecting the above scope of CSR

The committee considered the activities listed in Sch VII and the evaluated the capability of the company to undertake/ execute activities in those areas. It was felt that donation to either a government approve NGO or a government company engaged in approved CSR activity is not desired since there will be little control over the actual spending of funds. The CSR committee also noted that in next 3 years the amount of contribution would be substantial and therefore their proper use is very important. The other aspect was that the related company of the PRECIHOLE group was also liable for CSR spending. Put together the amount would be sizable enough to fund a needed cause or activity.

Therefore the CSR committee decided to recommend those areas of activity which the company directors could carry out with some help and about which they had some background knowledge. It was also decided to form a Section 8 charitable company to carry out the CSR activity.

The Company is engaged in manufacture of customized machines and group company is engaged in manufacture of Sports Guns. All directors are technocrats and having experience and expertise in their field of activity. Under the above circumstances all the areas of charity listed in Sch VII were evaluated as under :-

On Evaluation of the above tabled activities the CSR Committee conclude that

- I. If the company has to actually involve in any CSR activity The must be in such an area wherein the directors have at least some ideas or
- II. The company will have to contribute to one of the activity by donating to an approved organization which undertakes any of the charts listed in Sch VII.

The Committee ruled in favor of active involvement instead of Passive contribution.

5) Project for each of the shortlisted activity:-

5.1:- Promoting target shooting sports: One of the group company director has been a national level shooter in the past and is well aware of the challenges faced by budding shooters infrastructure & professional guidance. It is therefore proposed to facilitate National level Shooters to graduate to international levels by providing:-

- a) Shooting Range by purchasing time slots in existing ranges & sponsoring budding players.
- b) Providing guidance / advice through reputed coaches.
- c) Sponsoring the diet & implement of players with requisite spark in them.
- d) Sponsoring their expenses of tournaments, national or international.

5.2:- Supporting Armed forces Veterans

5.2.1: Another activity taken up as a project is to finance the sports careers or school/college education of War veterans, war widows and their Children through appropriate scholarships.

5.2.2: The CSR fund may be also be used to sponsor any higher education or vocation or skill development Programs of war widows or their children.

6) Project Cost :-

6.1:- Out of total Contribution received to the CSR fund it is proposed that –

70% funds will be used for objective 1 i.e. sports activities

25% for objective 2- War veterans/ widows and their family assistance

5 % for direct donation to any of the charitable activity listed in Sch VII.

7) Project Execution :-

The CSR Committee has recommended the execution of the CSR expenditure through a new section 8 company formed for the purpose jointly with a related company PMT. The intent is to control the end use of funds and keep all records of the receipts and their application to charitable objects, which can be achieved if separate accounts are kept. Another reason for recommendation is that the amount to be contributed for CSR Activities by Precihole group companies is expected to be Substantial and hence donating it to another organization and having no control over the utilization was not found to be desirable

8) Time Frame :-

The activity undertaken for CSR are such that they are recurring and more or less permanent / regular in nature
The board would therefore only ensure that funds are spent within 3 years on the ongoing project to comply with the law

9) Conclusion :-

The CSR Committee is unanimous that the policy shall be followed in letter & so that the company is able to give backs to the society a part of its profits as to be objective of CSR

Draft of approved

Project 1 : To promote Target Shooting Sports & Sportsmen

Area : Thane / Municipal Region

Scope : To promote the sports by the following means:

Action: 1

- a) Identify budding potential talen & target shooting by issuing sponsorship offer in the seminar & part performance evaluation.
- b) To arrange a Seminar by calling a leading shooter as guest speaker for sharing information, experience & guidance to budding sportsmen.

Action:2

- c) To book time sports or similar arrangement with established shooting ranges and make them available to the shortlisted shooters.
- d) To sponsor a coach for the shortlisted shooters for guidance.
- e) To provide equipment & accessories as per identified need.

Action:3

- f) To arrange meetings / guidance meets with leading national / international shooter.
- g) To sponsor the participation in national/international competitions.

Time Frame:

Action 1: 6 months from action plan approval

Action2: Ongoing & continues within 6 months of action plan

Action3: 1 year from action plan.

Project 2 : To support war veterans & their families.

Project 2 to start after completing action 1 stage of Project 1.
