Thank you for choosing TTD BOOKKEEPING SERVICES LLP to assist with the 2014 taxes for Operation Phantom Support Inc. This letter confirms the terms of the engagement and outlines the nature and extent of the services we will provide.

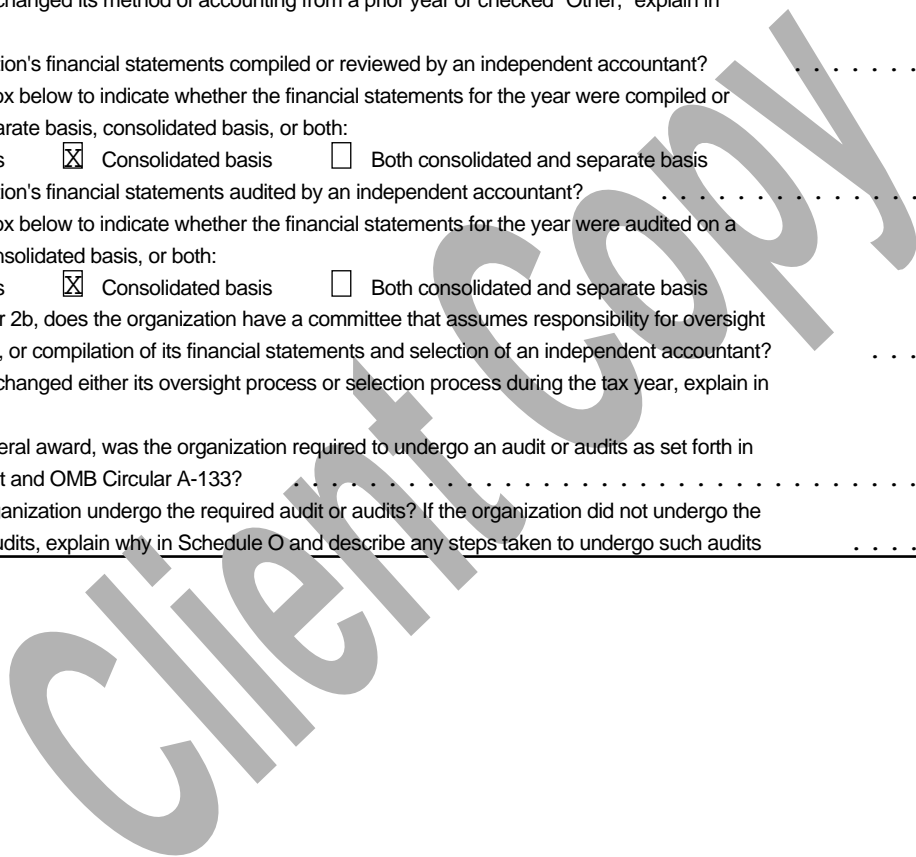
