Rules and Regulations for Lots at Above-Ground Monuments, Mausoleums and Flat Markers

These rules are supplemental to the General Standards and Regulations on file in the Cemetery Office. Rules and Regulations are subject to change at any time without prior written notice. They are established with the intention of ensuring a uniform and dignified respect for all interments at Beaver Cemetery. Beaver Cemetery is not liable for any theft or vandalism of any floral tribute or personal item left at the site of an interment property. Any and all non-conforming or unsightly floral arrangements or decorations may be removed and discarded at any time by the Maintenance Staff or Management of Beaver Cemetery and Mausoleum. In order to insure proper care and assure the continued beauty and dignity of the Beaver Cemetery, we ask that you observe the following regulations for above-ground monuments, mausoleums and flat markers:

- Confine plantings to one foot in front of the headstone and flush with the surrounding grass. This is
  required for cemetery employees to safely move equipment between the monuments. Nothing is to be
  placed outside of the established area. Note: Vigil lights, tribute flags to military veterans and firefighters
  are permitted in the established planting area.
- 2. Tribute items that are placed on above-ground monuments are permitted. Tributes placed on the ground and/ or on flat markers will be removed and discarded. Items placed on the ground and considered to be hazardous to maintenance operations will also be removed; these include glass containers, gravel, brick or stone pavers, landscape edging, stuffed animals, sports memorabilia or similar items.
- 3. Between May 1 and October 31 annually, only live floral arrangements are permitted. Between November 1 and April 30 annually, artificial floral arrangements are permitted. All artificial Christmas arrangements will be removed March 15 and discarded by the maintenance staff. All other artificial floral arrangements not removed by the owner as of April 30 will be removed and discarded. Notice of removals will be posted throughout the Cemetery and on the Cemetery website. Note: All tribute items placed at ground level will be removed by the maintenance staff and discarded at the same time.
- 4. The management shall have the authority to remove any and all trees, shrubs or plants of any kind, as soon as in the judgment of the management, they become unsightly, oversized or diseased or when they do not conform to Beaver Cemetery standards. Rose bushes in particular are not permitted. Please discuss any proposed plantings with the manager.
- 5. Pine blankets are not permitted.
- 6. Fencing of any type around graves or lots is not permitted.
- 7. All monument foundations will be installed by Beaver Cemetery.
- 8. Prior to placing tribute item(s) on graves with no memorial, these item(s) shall be reviewed and approved by the manager within six (6) months of interment.

Cemetery Visiting Hours: Daily, dawn until dusk.
