### Step 4 – Feedback

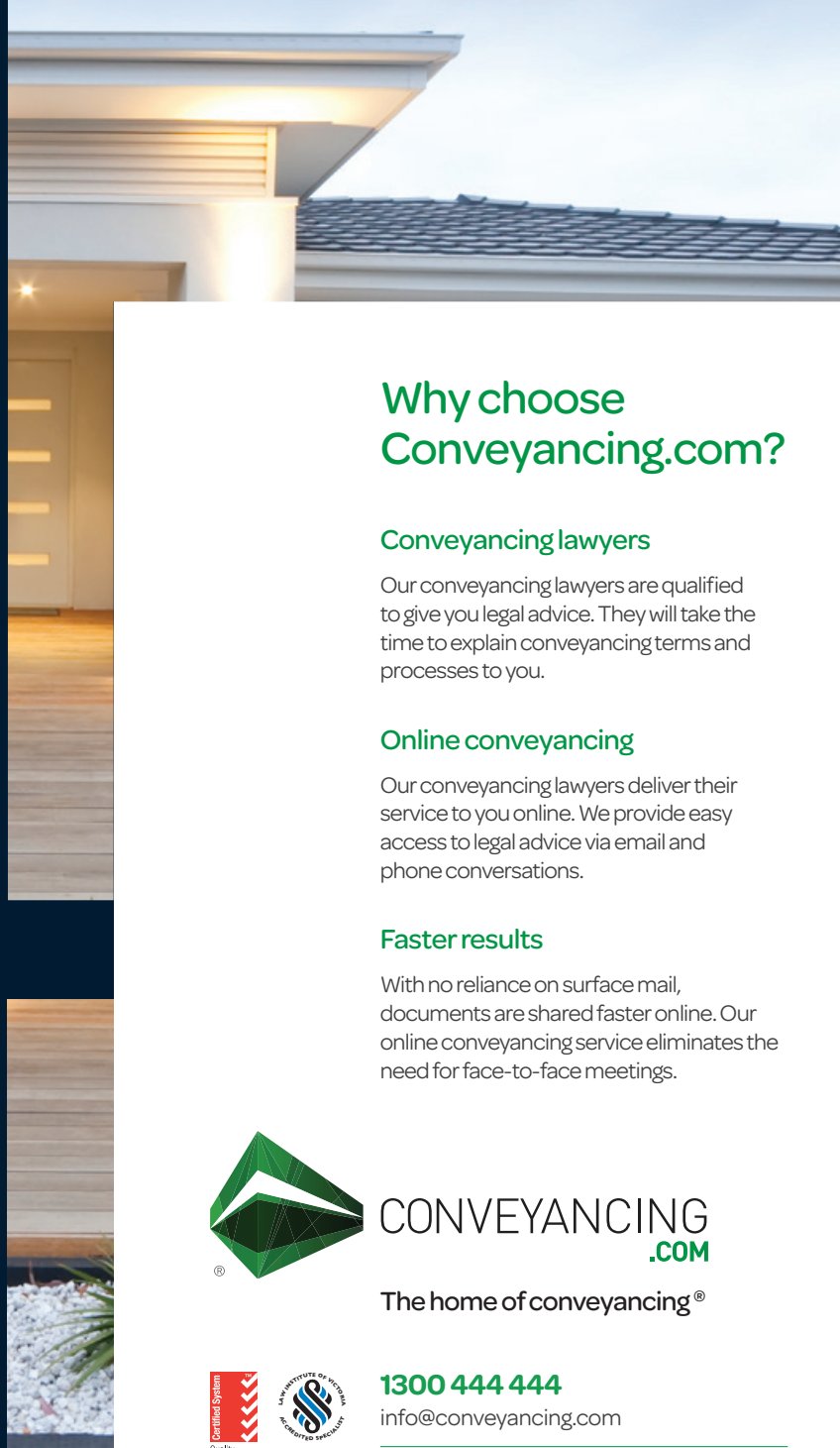
Caveats, easements or anything else that may affect the property transaction are identified and legal advice is provided during the online conveyancing process.
