Dear OPRA Market Data Subscribers:

What You Need To Know

For optimal symbol balancing and line capacity utilization, the symbol distribution for the Options Price Reporting Authority (OPRA) will be modified.

Changes Being Made

The security symbol range over the OPRA multicast lines will be redistributed. Reference the attached charts for current and new OPRA symbol routing.

When is it Changing

OPRA will employ a new symbol distribution at the start of day **Monday, July 15, 2019**. A Confidence test will be conducted on **Saturday, July 13, 2019, from 9:00 am ET to 11:00 am ET**, prior to implementation.

Evening Test Schedule

An OPRA replay file with test data including the new symbol distribution will be available beginning Thursday, June 13th, and will be disseminated business weekdays from **9:15 – 9:30 p.m. ET** from the multicast Playback Test channels (not over Production channels).
