1 This matter came on for hearing on July 22, 2019, at 10:00 a.m. in Courtroom
2 5A of the above-entitled court regarding Plaintiffs' Motion for Attorneys' Fees,
3 Litigation Costs, Administrative Costs and Class Representative Enhancement
4 Payments. After duly considering all papers filed and proceedings had herein, and,
5 otherwise being fully informed, and good cause appearing therefore,

6 **IT IS HEREBY ORDERED, ADJUDGED AND DECLARED THAT:**

7 Plaintiffs' Motion for Attorneys' Fees, Litigation Costs, Administrations Costs
8 and Class Representative Enhancement Payments is GRANTED.

9 The Court finds that good cause exists for the granting of the Motion in that the
10 settlement is fair, reasonable and adequate.

11 The Court awards Attorneys' Fees to Plaintiffs' counsel in the amount of
12 \$1,213,500 (totaling 25% of the \$4,854,000 Class Settlement Amount); Litigation
13 Costs to Plaintiffs' counsel in the amount of \$19,750.00; Administrative Costs and
14 Costs of Notice in the amount of \$630,25.00 to be paid to CPT Group; and,
15 Representative Enhancement Payments of \$5,000 each to Jose Jacobo and Theresa
16 Metoyer, totaling \$10,000.

17 This Court shall maintain continuing jurisdiction over these settlement
18 proceedings to assure the effectuation thereof for the benefit of the Settlement Class.
