# **Policies and Procedures**

Please read the enclosed policies regarding Emergency Procedures, Activities, Animals, Firearms, Drugs, and Health Information.

- 1. Rental Party must provide their own adults currently certified, age appropriate in First Aid and CPR/AED, who are responsible for Health needs of the group. Groups are responsible for providing their own First-Aid supplies and equipment.
- 2. Rental Party is responsible for gathering and maintaining information on all members of the group that includes Names, Address, Emergency Contact Names and Numbers, and any Allergies, Health Conditions/Restrictions, or Medications.
- 3. Group leaders are responsible to inform camp of any allergies or restrictions of their group that may affect camp services provided (e.g., food service, program activities, etc.).
- 4. Wasewagan advises user groups to Background Check their participants before allowing them to work with children.
- 5. Camp Wasewagan requires Liability and Medical Insurance for all user groups.
- 6. Rental Party is responsible for the storage and administration of the medications of their group both over the counter and prescribed. These medications should be stored under lock except when in the controlled possession of the person responsible for administering the medications.
- 7. Rental Party is responsible for their own Emergency Transportation, Phone Numbers and Locations of local EMS providers, Clinics, and Hospitals.
- 8. Orientation for groups will include updated Emergency Procedures for the camp including information on how to contact camp personnel in an emergency.
- 9. There will be no use of Camp Activities unless arranged or supervised by a Wasewagan staff member. No Exceptions. Wasewagan will provide Certified Lifeguards when arranged.
- 10. Wasewagan does not allow Dogs or Pets on the premises. The exception to this rule is a working Guide Dog and Camp Dogs.
- 11. No Firearms or Drugs may be brought onto Wasewagan property.
- 12. Rental Party is Responsible for Guests Consuming Drugs and Alcohol.
- 13. I agree to release Camp Wasewagan and Staff from Liability for Any possible Sickness/Illnesses, Injuries, or Incidents on Site or After Departure from our Venue.
- 14. I agree to release Camp Wasewagan and its people from Any and All Medical and Financial Responsibility Including Lost, Stolen, or Damaged Items.
- 15. I understand that rates for the following year may increase due to Annual Evaluation of Costs.
- 16. I understand that all payments made to Camp Wasewagan are considered Deposits and are non-refundable.
