DONATING TO FUNDACION SOMOS

Donations may be made to Fundación SOMOS and the many projects that we support via credit card, Paypal, check, wire transfer, or donation of stock or land. Donations made by credit card will receive an automatically generated receipt and are eligible for tax deductions in the United States. Receipts for donations by check, wire, stock, and land will be sent via email. Donations made via bank transfer or direct deposit to our Costa Rican bank account are eligible for a tax deduction in Costa Rica.
