CIVIL PETITION

Purpose: This form is used to start a court case by the petitioner because he/she believes

a claim is necessary.

How: The petitioner completes the Civil Petition from which contains:

a. A short and factual statement of who is involved, how to contact each party, the enrollment status of all involved and the law(s) that applies to the claim;

- b. A short statement describing the facts that resulted in the Petitioner filing the claim;
- c. A short and plain statement describing what the Petitioner is asking the Court to order, which can include ordering the Respondent to do or stop doing something; and
- d. A short explanation (with amounts or if unknown may ask to give this information later) used to ask the Court to order damages, reimbursement of fees or other types of relief (costs, attorney's fees).

The Civil Petition must be signed and notarized by a Notary Public. After your signature has been notarized, the Civil Petition must be filed with the Court Clerk. A case file will then be created.

A 'Filed' copy of the Civil Petition, with the Court stamp showing the date filed, is returned to the Petitioner for the Petitioner's records.

The Petitioner must then serve a copy of the 'Filed' Civil Petition to the Respondent (if the Respondent is the San Juan Southern Paiute Tribe, see *Instruction Sheet for Service*).






