APPEAL OF TRIBAL COURT DECISION

If you believe the decision of the Tribal Court was clearly contrary to the San Juan Southern Paiute Tribe's Constitution you have a right to appeal to the Tribal Appellate Court. An appeal to the Appellate Court of the San Juan Southern Paiute Tribe may be submitted to the Court Clerk electronically to e-mail address: appellatecourt@sanjuanpaiute-nsn.gov

You may use the original Notice of Enrollment Appeal form or Civil Petition to file your appeal or you may hand write what you would like the Appellate Court to consider as long as you write legibly and clearly state why you believe the Tribal Court mistakenly denied your petition.

This form is only should in cases that have already been decided in the Tribal Court. Do not use this form for enrollment appeals or the appeal of a decision in a general assistance action. After your appeal is received, the Court Clerk will put together all of the records that the Tribal Court reviewed in your case. The record will be forwarded to the Tribal Appellate Court to be considered with your appeal.
