Do not send emails to us through any other email address. If you have already done so, please promptly forward those emails to me at <a href="mailto:moshe@autec.com">moshe@autec.com</a>
- 2. The impersonator has used the email address of @autecpowerinc.com. If you have sent or received an email from us using an @autecpowerinc.com or any other address other than @autec.com, please promptly forward it to me at moshe@Autec.com
- 3. Please double check any recent changes to our email address due to server changes or facility closure to ensure that you are not inadvertently sending us e-mails via an address other than @autec.com.
- 4. Verify any unexpected or unusual requests through our official channels before proceeding. Such as changes to bank accounts and business or facility closer.
- 5.
