#### **Position Purpose**

To assist the Project Owners to deliver commercially successful and fit for purpose projects and to assume the responsibility for the overall direction, coordination, implementation, execution, control and completion of major capital works projects ensuring consistency with the Corporate Vision, Mission and Strategic Direction.

The Project Manager will assist in identifying future major capital works projects to ensure the provision of infrastructure meets the requirements for the future airport growth as presented within the Master Plan.

# **Job Role Requirements**

#### **Objective 1: Planning**

- Provide technical assistance for input into project business cases with the Project Owner for the outline of the project functional needs and deliverables.
- Guide the projects through the project planning phase on aspects of definition, feasibility, options assessment, programming and risk assessment.
- Ensure that concepts are consistent with relevant planning legislation and airport master plans.
- Liaise with external stakeholders to ensure compliance with regulatory requirements.
- Assist in identifying and planning of new major capital works projects for airport precinct growth.

#### Objective 2: Concept Design, Approvals and Detailed Design

- Developing technical design briefs and concepts to ensure that projects are appropriately scoped.
- Develop preliminary concept, detail design work and obtaining cost estimates.
- Establish delivery method and programme.
- Review designs, at stages, for adequacy to meet design/client brief.
- Assist Project Owners with the drafting of Board Papers, including formatting, justification, and business case needs.
- Guide the project through all regulatory applications and certification requirements.
- Monitor designs for compliance with regulations, policies and standards.
- Brief Consultants and Contractors on responsibilities in the Airport's Master Plan and drafting of Construction Environment Management Plans.
- Procure and manage Consultants to ensure value for money solutions are obtained.

## **Objective 3: Project Management/Construction Management**

- As the Project Manager for projects, implement and manage project resources for tendering and contract administration in accordance with QAL procurement policies and procedures.
- Manage and oversee the management and delivery of capital works projects.
- Appointment and management of external project resources as required and oversee the management during the construction phase.
- Manage the transfer (handover) of projects upon completion to the Project Owner.

- Complete projects for the function designated in the business case to the specified quality, time, cost and scope parameters.
- Guide projects to ensure that Consultant and Contractors consider risk mitigation and WH&S impacts in designs and construction techniques.

## **Objective 4: Communication and Reporting**

- Establish and organise relevant Steering Committee and Projects Control Groups, as required, or as directed by the GM Infrastructure.
- Establish effective communication with the Airport management team.
- Ensure reports for projects are presented covering key parameters of scope, time, quality and cost.
- Ensure documentation presented in a concise, clear and professional manner.
- Ensure that contractors risk, quality, safety and environmental plans are followed and relevant reviews/audits are undertaken.
- Provide quality internal and external customer service.

#### **Objective 5: Environment**

- Ensure that consultants and contractors are adequately briefed on responsibilities under the Airport's Environment Strategy and Construction Environment Management Plans
- Develop action plans for activities with the potential for adverse environmental impacts
- Ensure that environmental audits and reviews are undertaken

## Objective 6: Project Participation / Innovation / Continuous Improvement

- Continuously strive for improvement of departmental processes.
- Participate in team workshops and activities.
- Encourage consultants and contractors to recommend innovative solutions to project design and construction issues, which will provide a better product for the Project Owners

#### Objective 7: Workplace Health & Safety, Environmental and Aviation Safety & Security

- Take reasonable care for your health and safety.
- Take reasonable care for the health and safety of others including the implementation of risk control measures within your control to prevent injuries or illnesses.
