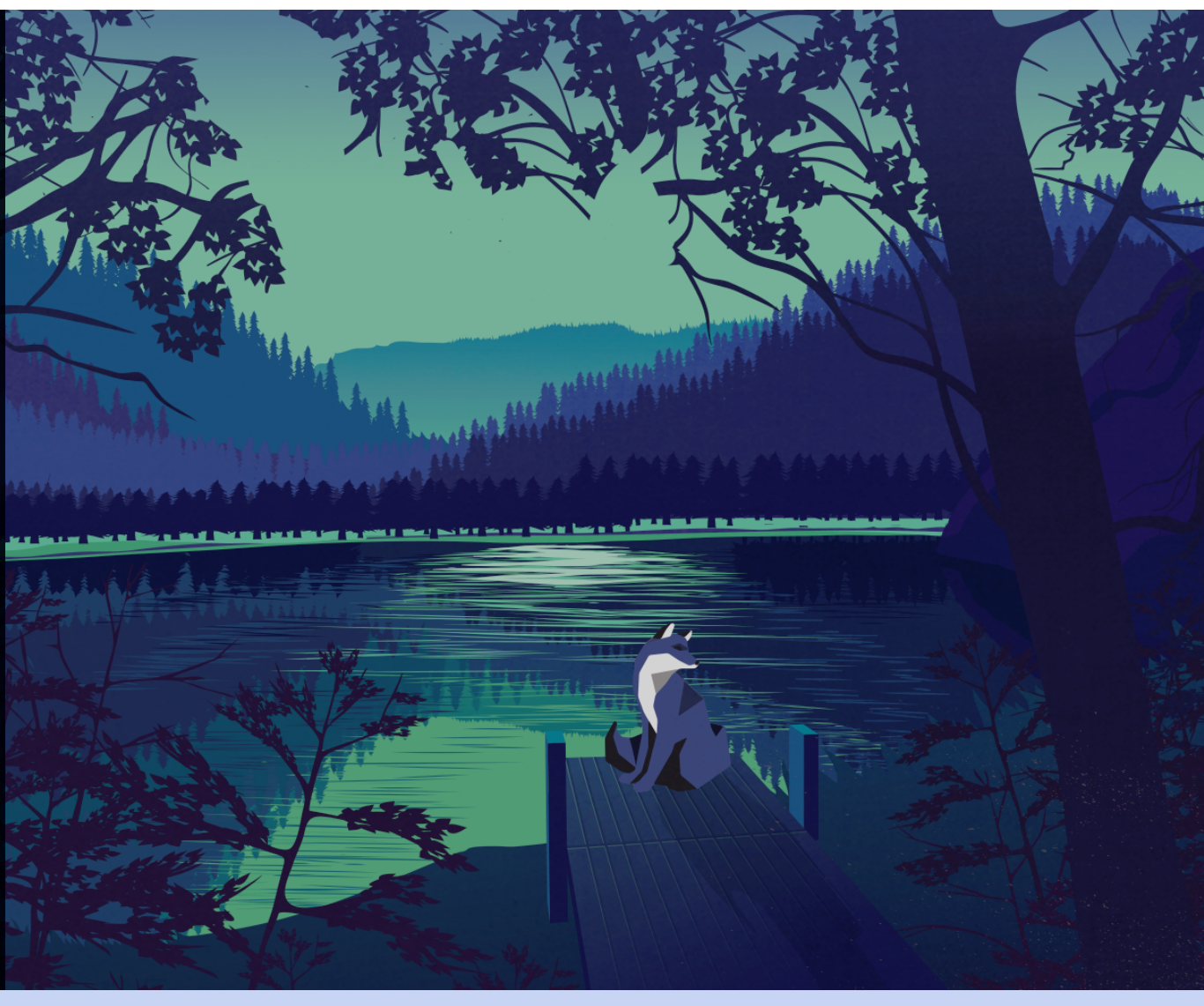




# Your Weekly Governance Newsletter #44

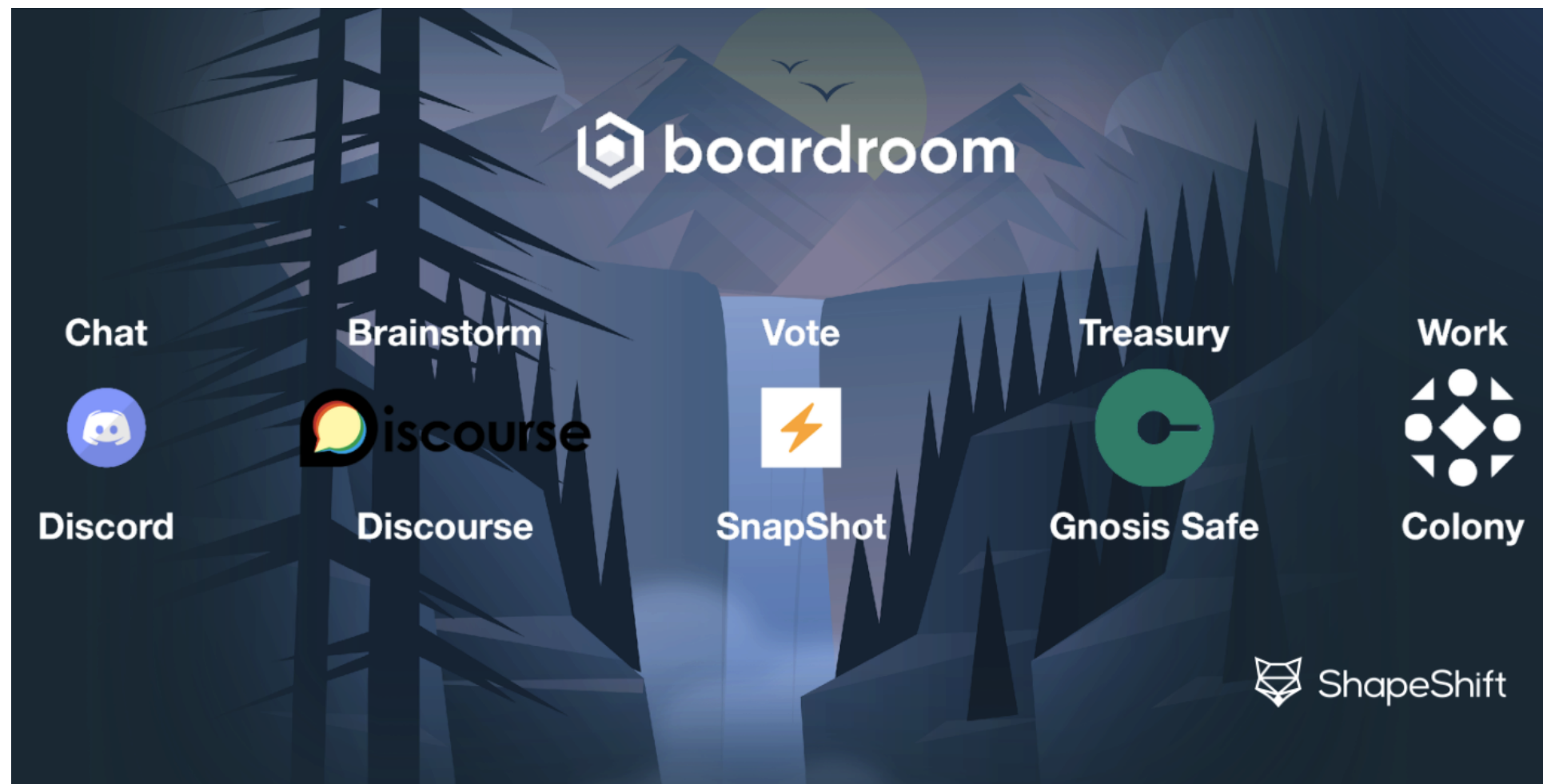

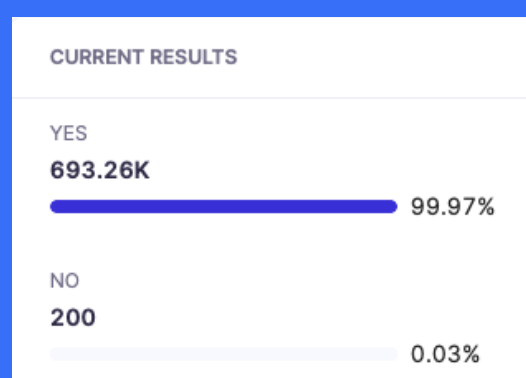
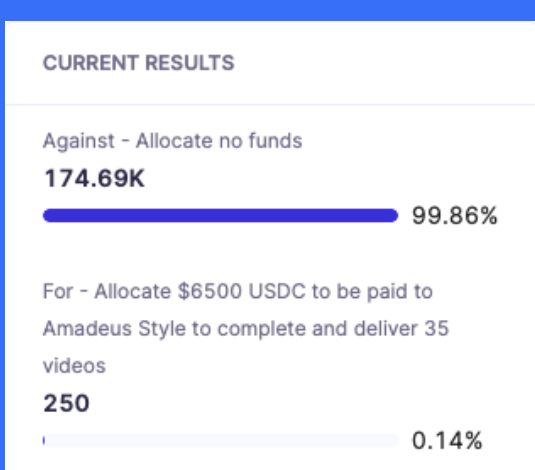

Total Proposed Budget: \$6,500 USDC

Total Proposed Budget: \$0

- This proposal is to finish editing additional footage shot by Amadeus Style from ETHDenver into usable stories, and to deliver these assets to ShapeShift.
- Content is very usable through the next 3-6 months.
- View the original [ETHDenver 2022 ShapeShift videos](#) shot and edited by Amadeus Style.
- 15 YouTube videos and 20 social media videos to the Creative Services squad, to be used in conjunction with Marketing and Growth to promote the DAO with video content.
- Some videos will be delivered immediately, with the remaining videos delivered within about 4 weeks.

- Extends and modifies the current phase of liquidity mining incentives, which end mid-July.
- Continues the LM program on Uniswap v2 for another 4.5 months with 6.75M FOX.
- Creates and funds liquidity mining incentives on Bancor v3 (Up to 10M FOX for LP, up to 6.75M FOX for rewards, up to TDMC).
- Bancor will match up to 50k BNT to any whitelisted v2 token.
- Shapeshift will augment the Bancor IL protection with an escrow account holding \$1M FOX, to be paid out to FOX holders in cases of IL.
