

# Warranty

We guarantee the work performed at Brazoria Collision Specialist-Auto & RV for as long as the vehicle remains under the present ownership. This warranty shall only apply if the defects occur under normal driving conditions and not if any vehicle has been subjected to accidents, negligence, abuse or misuse. Specifically excluded from this limited warranty is rust coming through metal, scratches, and gravel marks acquired from driving conditions. This is a fragmented four part Limited Warranty, and specific additional stipulations pertaining to each part are stated hereafter:

1. **Metalwork:** Brazoria Collision Specialist-Auto & RV provides a Lifetime Limited Warranty, from effective date stated herein, on all metalwork, to include welding and the application of materials utilized in making collision repairs against cracking, flaking, pitting or deterioration, excluding rust repairs. The Shop will repair and repaint, excluding rust repairs, any metalwork warranted hereby, when claim is made within the warranted period, unless caused by or damage resulting from unreasonable use, maintenance, or care of vehicle.
2. **Painting, Stripes, and Decals:** Brazoria Collision Specialist-Auto & RV provides a Lifetime Limited Warranty, on painting-related, priming and painting work. This warranty covers problems caused by solvent blistering, peeling, hazing, or excessive loss of pigmentation; and a Lifetime Limited Warranty on the application and adhesion of decorative stripes and decals, excluding those effects that are caused by extreme environmental conditions to which the vehicle may be exposed. The Shop will re-prime, re-paint, re-stripe or re-decal the specific section or sections of the warranted vehicle, if a claim is made within the warranty period, unless caused by or damage resulting from unreasonable use, rust, negligence, or improper care of the vehicle. Our paint warranty is valid only over factory quality finishes that are free from defects.
3. **Mechanical Repairs:** Brazoria Collision Specialist-Auto & RV provides a One (1) year Limited Warranty on all mechanical repairs pertaining directly to original collision damage. The Shop will repair any mechanical assembly or component found defective due to improper workmanship relating to our repair of the original collision damage.
4. **Parts:** Brazoria Collision Specialist-Auto & RV guarantees that parts of materials used, are of the first quality. Those parts or materials are subject to the guarantee of the supplier. We will assist you in handling any claim under the supplier's guarantee. We guarantee that used part or other than original equipment manufactured parts were not used without authorization as noted on the Repair Order. The Shop will repair or replace any defective part warranted hereby, when repairs are made within the warranted period, unless damage caused by or damage resulting from unreasonable use, neglect, or improper care of the vehicle.

Limited Warranty: Stipulations listed above hereof are made in part hereof as though fully incorporated herein, and that this shop agrees to be bound by each and everyone thereof. This Limited Warranty: Shall be null and void if the repair is altered, adjusted, or tampered with by any persons not authorized by Warranty Grantor. This Warranty is non-transferable.

Specifically Excluded:

A: Incidental cost, such as towing fees, car rental charges, travel expenses, or assemblies and components, which are not specifically covered by this Limited Warranty.

B: Rust through, and/or damage caused by rusting of interior or exterior non-replaced panels is not covered.

This States All: the Limited Warranties made by The Shop and contain only promises for which it will be responsible.

All Warranties implied by law, including the warranties of merchantability and fitness for a particular purpose, are hereby limited to the warranty period herein and shall expire at the end of each such period.
