### **PURPOSE**

➤ **Temporary Clerical Assistance Wages**

**MOTION**

**Motion** by Young; supported by Jarvis to approve Clerical Assistance Wages at \$15.00 per hour. **PASSED.**

➤ **Hobby Farming in area zoned High Density Residential District**

This was brought before the PC at the residents' request that animals be allowed in high residential zones. They denied the request. The supervisor received a letter asking the board to look into it and reconsider. After considerable consideration, the Board agreed with the PC that a Hobby Farm in a High Residential area within Cedar Creek would not fit within our Master Plan.

➤ **RECYCLING FEES**

After discussing different ideas and amounts the Board agreed to:

\$ 2.00 for a 20 Gallon Container

\$ 4.00 for a 40 Gallon Container

\$20.00 for a pickup truck load

Non-residents would pay double the fee.

➤ **Special Assessment for Snow Plowing in Don Snow Camp Sub-Division**

Bill Homrich, the gentleman spearheading the program, was here for the meeting. His concern was learning that in 5 years they would have to start all over again; with a new petition and meeting and have to repay set up fees of \$5500.00 or more again. Linda and Stephanie both agreed with him and let him know we support the residents.

Stephanie told Mr. Homrich she would talk to the attorney in the morning and go over all his concerns. Stephanie also informed the board that we have to decide on Resolution #1, this is only an intent resolution, if things change, we can stop it at the next meeting (public hearing) on October 13, 2020.

**Motion** by Kuziak, supported by Young to move forward with Special Assessment Resolution #1 for Don Snow Camp sub-division. **PASSED**




**Motion** by Kuziak; supported by Jarvis to adjourn at 7.55 PM. **PASSED.**
