A RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF WILLIAMSBURG, SIERRA COUNTY, NEW MEXICO, AUTHORIZING THE SUBMISSION OF A NEW MEXICO COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM APPLICATION TO THE DEPARTMENT OF FINANCE AND ADMINISTRATION/LOCAL GOVERNMENT DIVISION; AND AUTHORIZING THE MAYOR TO ACT AS THE MUNICIPALITY'S CHIEF EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE IN ALL MATTERS PERTAINING TO THE MUNICIPALITY'S PARTICIPATION IN THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM.

WHEREAS, the need exists within Municipality for neighborhood improvement projects in several low and moderate income neighborhoods, and the Municipality desires to apply to the Housing and Urban Development's Community Development Block Grant Program to obtain funding for neighborhood improvement projects; and

WHEREAS, the Board of Trustees has held 3 public hearings for public input and comment 07/29/19 meeting, 08/08/2019 and 08/26/19 during the 2020 application process; and

WHEREAS, the Board of Trustees finds that there is a significant need to undertake the Joint Application with the City of Truth or Consequences; Mona Street and Doris Street Water/Sewer/Street Project to provide adequate services to the community; and

WHEREAS, the Board of Trustees determines that the Joint Application with the City of Truth or Consequences; Mona Street and Doris Street Water/Sewer/Street Project meets the requirements of the Community Development Block Grant Program.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE VILLAGE OF WILLIAMSBURG, NEW MEXICO, that

1. The Village is hereby authorized to prepare and submit a Community Development Block Grant application to the New Mexico Department of Finance and Administration/Local Government Division for the Joint Application with the City of Truth or Consequences; Mona Street and Doris Street Water/Sewer/Street Project;
2. That the Board of Trustees directs and designates the Mayor as the Village's Chief Executive Officer and Authorized Representative to act in all matters in connection with this application and the Village's participation in the New Mexico Community Development Block Grant Program;



3. The Village officials and staff are directed to do any and all acts necessary to carry out the intent of this Resolution;

4. That the full application amount be for \$ 1,500,000.00 and phased application amount be for \$1.269,000.00 of grant funds to carry out Joint Application with the City of Truth or Consequences; Mona Street and Doris Street Water/Sewer/Street Project;

5. That it further be stated that, by virtue of the Joint Application, the City of Truth or Consequences is committing 7.5% of the total project funds awarded from its General Fund as a cash contribution toward the project of this Joint Application with the Village of Williamsburg Mona Street and Doris Street Water/Sewer/Street Project.
