This tariff outlines the basic charges associated with the preparation of patent, design and trademark applications and for a variety of consultation services.

This tariff does not itemize the many steps typically carried out in preparing a patent, design, or trademark application. Please feel free to contact our staff regarding any action which is not included in the tariff.

The activities of our office are billed according to the hourly rate of the specific professional, as engaged, as listed in Part A below. Some of these activities have a basic minimum charge as itemized in Parts B and C. In some cases, an hourly work rate will be added to the basic charge specified in Parts B and C. Specific office expenses are billed as listed in Part D.

We would like to emphasize the following points:

- All of our rates are in U.S. Dollars (US\$) and are paid according to the currency exchange rate on the actual day of payment.
- All charges listed are exclusive of V.A.T., which is currently 17%.
- Every year on January 1, our office tariff and rates are reviewed.
- In dealing with patents, trademarks and designs, meticulous monitoring and strict schedule adherence are required. In the event of a client-caused delay beyond the strict schedule, additional charges are incurred.
- Please note that there is a charge for an initial meeting with our professional staff according to the hourly rate listed in Part A.

## **Part C – Basic Minimum Rates for certain actions taken abroad**

### General

25% of the foreign associates' charges:

Our office charges a 25% surcharge on all charges and fees of our foreign associates, including associate's fees, official fees and expenses in respect of filing patent, design and trademark applications, the continued prosecution of the applications through to registration and renewals.

#### 9. Foreign Applications:

##### i. Patents:

1. Our charges for the filing of a patent application in any country other than Europe are no less than \$ 400 per application in addition to charges and fees of our foreign associates as described above.

Our charges for the filing of a patent application in Europe are no less than \$ 850 per application in addition to charges and fees of our foreign associates as described above.

However, if our associate's charge for the filing of a patent application in a single country (other than Europe and Japan, to which this section does not apply), exceeds the amount of \$ 8,000, our office will charge only \$ 2,000. This restriction refers to the filing of the application only, and not to the actual writing of the patent application or prosecution thereof, which is detailed in Section 6, above.

2. Our charges for the filing of a PCT application are \$ 1,700 not including official fees which are charged according to the actual cost.

##### ii. Designs and Trademarks:

Our charges for the filing of a design or trademark application abroad will be no less than \$300 per application in addition to charges and fees of our foreign associates as described above.

#### 10. Renewals abroad (patents, designs and trademarks):

Our charges for the renewal of a foreign application will be no less than \$ 50 in addition to charges and fees of our foreign associates as described above.
