OVER ONE-THIRD OF ALL WELLS DRILLED IN THE LAST TWENTY YEARS ARE NOW BROKEN -50,000 ARE CURRENTLY BROKEN IN AFRICA ALONE. WE ARE WORKING WITH WATER FOR PEOPLE TO TRAIN LOCAL WELL MECHANICS TO FIX AND MAINTAIN WELLS IN UGANDA, AS WELL AS BUILD PIPELINES TO FAMILIES' HOMES. STOVES ARE MADE LOCALLY AND SOLD BY MEN AND WOMEN IN KENYA. BOTH MASONS AND VENDORS EARN COMMISSION FOR EVERY SALE. EACH STOVE SAVES A FAMILY 20% OF THEIR DAILY EXPENSES, BECAUSE THEY USE 50% LESS CHARCOAL PER DAY. 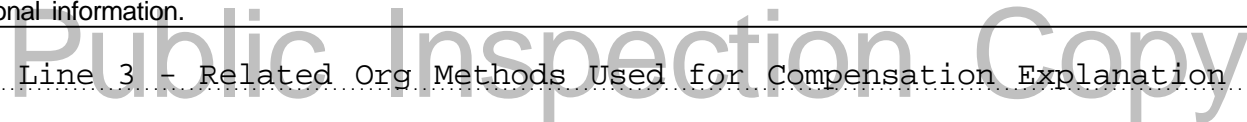
