Open Gym Information, Rules and Code of Conduct

An Open Gym Membership allows you use of the gym when it is unoccupied as well as admission to any, age appropriate open gym session. If you are under the age of 18 and do not have an Open Gym Membership or a Fitness Center Membership, you will not be allowed to use the gym or participate in any open gym session.

Open Gym Rules and Code of Conduct

1. Members must present their ID card when using the gym or for checking out a basketball. If you excessively forget or lose your ID, you will be charged \$5 for a replacement.
2. Clean, dry gym shoes and shirts must be worn at all times.
3. No hanging on the rim or dunking.
4. No gum or candy in the gym.
5. Show good sportsmanship and no use of foul language.
