The Roselle Park District team has and will continue to increase efforts to clean and sanitize our facilities and program areas in accordance with the CDC guidelines. <u>Dance classes:</u> will be held virtually for the final two weeks, starting November 30, 2020. Specific details will be communicated to dance families soon.

Hot Shots Sports Classes:

- Basketball: Remainder of classes will run virtually. Details will be sent to you.
- **Flag Football**: Will continue to run outside for the remainder of the program. Please dress warm.

Fitness Center:

- Face coverings are always required in the fitness center
- Fitness Center hours will change to Monday-Friday 5:30am-6pm Saturday and Sunday 8am-12pm

Walking Track:

- The walking track will be closed from Sunday, November 22-November 29.
- More information on the walking track will be sent out later.

Personal Training

- Personal Training will continue to run
- Do not forget to check out this great program

Preschool:

• Preschool will continue to run with no changes

School Based Programs:

- All school-based programs will continue to run. (Club Kids, Teacher Childcare, Wildcat Care, & Ribbit Remote Care).
- All school-based programs will be limited to 10 or fewer in each group.

Tot and Parent:

• The remainder of this program will be cancelled and refunded

Music Lessons:

• Will continue to run with no changes

Distinguished Citizens Club

• The Distinguished Citizens Club is paused for the time being

Room Rentals:

• No room rentals will be allowed during this pause

Special Events:

- All special events are limited to 10 people or fewer at any given time.
- All special events scheduled during this time will be following the current guidelines. These
 guidelines may change prior to each event and we will make the appropriate changes before
 those events start.

Spectators:

• During this mitigation, no spectators will be allowed inside the Roselle Park District. Due to the nature of our youth programs, we know many of our participants may require support and/or assistance. Therefore, one parent/guardian will be permitted to escort the participant into the facility to provide support. Once your child is in their program, then you will have to return to your car until then of their program. If your child does not require any support as outlined above, we kindly ask you drop off your child and wait in your car for the duration of the scheduled program time.

Playgrounds:

- Our playgrounds are open
- Please follow the 3 W's, Wear a mask, Watch your distance and Wash your hands

COVID-19 Guidelines:

- All programs and events will follow current guidelines.
- Masks are required unless otherwise noted.
