

This postcard relates to a proposed settlement ("Settlement") of three class action and representative lawsuits ("Civil Actions") against Contemporary Services Corporation ("CSC") alleging violations of certain California wage and hour laws from February 18, 2006 to August 15, 2019. The Civil Actions are known as *West, et al. v. Contemporary Services Corporation, San Francisco Superior Court Case No. CGC-10-502191*, *Johnson, et al. v. Contemporary Services Corporation, San Francisco County Superior Court Case No. CGC-16-552354*, and *Collins v. Contemporary Services Corporation, American Arbitration Association Case No. 72-20-1200-0345-12*. Plaintiffs in the Civil Actions seek, *inter alia*, recovery of unpaid wages, premiums for improper meal and rest breaks, reimbursement of business expenses, restitution, damages, liquidated damages, statutory penalties, civil penalties, injunctive and other equitable relief, prejudgment interest, and attorneys' fees and costs. CSC denies all allegations of wrongdoing or liability, and denies that plaintiffs or the Class have been harmed in any way. You are receiving this postcard pursuant to an order of the Court because CSC's records show you may be a Class Member.

Who is in Class? Class Members include all persons who worked in California for CSC as non-exempt security guards and event staff at any time from February 18, 2006 to August 15, 2019 (the "Class Period").

What relief does the Settlement provide? CSC has agreed to pay \$3,600,000 into a fund (the "Total Maximum Settlement Payment") to be used, in part, to make payments to Class Members who submit approved Claim Forms. This amount also includes payments for court-approved attorneys' fees and costs, the class representative service awards, payments to the State of California Labor and Workforce Development Agency for penalties under the Labor Code Private Attorneys General Act of 2004, and notice and settlement administration costs. The amount of your payment will be determined based on the total number of Compensable Pay Periods you worked during the Class Period in relation to the total number of Compensable Pay Periods worked by all Class Members during the Class Period who submit approved Claim Forms.

How do I receive a settlement payment? To receive a payment, you need to submit a Claim Form on the Settlement Website (www.CSCClassActionSettlement.com) no later than November 23, 2019. YOU HAVE BEEN ASSIGNED A PASSCODE AND CPT ID NUMBER (LOCATED ON THE FRONT OF THIS POSTCARD) WHICH ARE REQUIRED TO ACCESS AND SUBMIT YOUR CLAIM FORM.

What if I don't agree with the Settlement? You can exclude yourself (and keep any rights you may have against CSC over the legal issues involved in the Civil Actions) or you may object to the Settlement. The deadline to exclude yourself or object is November 23, 2019. Please visit the Settlement Website for instructions.

When is the Final Approval Hearing? The Court will hold the Final Approval Hearing to consider, among other things, the Settlement, the request for attorneys' fees and expenses of the attorneys who brought the Civil Actions, and the request for service awards to the plaintiffs who brought the Civil Actions. You may attend the hearing, but you are not required to do so. The hearing is currently scheduled on January 8, 2020.
