THE MUSEUM SERVES APPROXIMATELY 800,000 VISITORS PER YEAR. ALMOST 30% OF VISITS AT THE MUSEUM ARE NON-PAID - ADMISSION IS DISTRIBUTED THROUGH 948 SOCIAL SERVICE AGENCIES. THE OVERALL AUDIENCE REFLECTS HOUSTON DEMOGRAPHICS - 48% LATIN AMERICAN, 23% AFRICAN AMERICAN, 21% ANGLO AMERICAN AND 7% ASIAN AMERICAN.
