A past-president of the NTSA, Susan also served as a board member of the American Retirement Association and on the 403(b) Advisor Editorial Committee for the magazine 403(b) Advisor published by the National Tax Sheltered Accounts Association.

The NTSA has honored Sue with the 2023 Richard Ford Volunteer Service Award and the 2012 Bob Schiller Meritorious Service Award. As a leader among women, she was bestowed the Athena Award for promoting women in business and was inducted to the Athena Hall of Fame in Michigan. In 2013, the Upper Dublin Education Foundation recognized Susan with the Outstanding Citizen Award for her exemplary charitable service, volunteer work, and long-term community involvement. In 2016, the NTSA presented her with the Kelli Award and recognized her service on the NTSA Leadership Council.

While her expertise and acumen keep her in high demand within the industry, Susan's commitment to her PenServ clients is paramount every day. In her spare time, she volunteers as a host coordinator with Family Promise (formerly Interfaith Housing Alliance) sheltering and helping homeless and displaced families find permanent housing.
