EC LOGISTICS

These terms and conditions supersede all others issued.

1: The “Company” _refers to Kache Ltd T/A EC Logistics

2: The “Customer” _refers to the organisation or person who requests services from the Company.

3: The “End Customer” _refers to the driver taking receipt of the vehicle being delivered.

4: It is the Customer’s duty to ensure that all vehicles are roadworthy and are covered by a current MOT. The Company reserves the right to refuse to move any vehicle considered not suitable for transit. Any vehicle that breaks down will incur a £100 charge to cover the use of the Company’s breakdown facility. The Company will not be held responsible for any damage from road debris i.e. stone chips. The Company will not move a vehicle which contain goods.

5: Payment is to be made within 30 days of the date of the invoice. Queries raised after this period will not affect the invoice which must be paid within 30 days.

6: Any queries must be raised within 7 days of the invoice being raised by the Company. Queries raised after the 7 day period has expired will not affect point 5.

7: Once a vehicle has been signed for by the End Customer then it is no longer the responsibility of the Company and any claims for damage will not be granted.

8: All prices quoted are exclusive of VAT and other taxes prevailing at the time of invoice, including tolls, dock fees, congestion charges, fuel and other ad hoc expenses.

9: We reserve the right to charge legal or collection charges where it is necessary to obtain payment from a Customer. We also understand and may exercise our statutory right of interest and compensation under the late payment of Commercial Debts (Interest) Act 1998 if we are not paid within our credit terms. In the event of a cessation of business from the Customer we, or our agents

In such circumstances we shall be entitled by notice to terminate the contract in whole or in part without incurring any liability whatsoever to the Customer.

11. These terms and conditions shall be governed by the laws of England and shall be subject to the exclusive jurisdiction of the courts of England or Wales.

These terms and conditions are applicable with immediate effect, superseding all previous terms and conditions, and it is the Customer's duty to ensure that they are aware of any changes relating to these terms and conditions at the time of placing an order.
