THE OBJECTIVE OF THE LATITUDE HORIZON FUND IS TO DELIVER CAPITAL APPRECIATION OVER THE LONG TERM BY HOLDING A CONCENTRATED PORTFOLIO OF STOCKS, WHILST LOWERING THE EQUITY RISK AND ENHANCING RETURN THROUGH A SELECTION OF NON-EQUITY INVESTMENTS.

April Commentary

In simple terms what we look for when investing in businesses can be summarised as follows: businesses with strong individual characteristics, operating in an industry with strong characteristics, with attractive long term value creation opportunities, at an attractive valuation.

The most recent addition to the portfolio was **Starbucks**, one of the most successful individual businesses of the past thirty years, generating a sustained 25% annual return for shareholders since 1992. One of the key attributes which attracted our attention a few years ago was its commitment to its staff, and the many programs it runs, including offering college education in the US, to make Starbucks an aspirational place to work. This benefits the business through lower staff turnover, higher staff quality and, critically, extremely strong customer service. While peers like McDonald's are moving towards screen based ordering systems, Starbucks' focus on customer interaction will continue to set it apart. The balance sheet is very strong, with current debt covered by cash and around two years of free cash flow. Most importantly, at an individual level we believe growth is likely to be sustainable, and does not rely on any of the usual red flags such as capex, acquisition, or financial engineering. It's true that short term weakness in same store sales in the US has concerned investors, although with a longer term outlook the commensurate 50% derating of the stock was our opportunity to initiate a position.

This leads us onto the industry itself. While the US and UK markets feel very penetrated, there is still potential for growth in those markets as Starbucks introduce online ordering, kiosks and more upmarket Roastery

stores. There is considerably more growth elsewhere in the developed markets (Starbucks only opened its first store in Italy this year for example, a Roastery, and I urge you to Google it) and most excitingly the Chinese market. Starbucks is the market leader in China and it has significant growth ahead. In recent years Chinese exposure has been re-priced by investors as a risk not an opportunity, which we believe will prove an error of judgement over the next five to ten years. Recent inroads have been made by the dramatic entrance of Luckin coffee, a heavily funded start-up offering kiosks and coffee on demand through delivery. This is surely causing consternation for local Starbucks management, however, we believe the opportunity is more than large enough for two players in time.

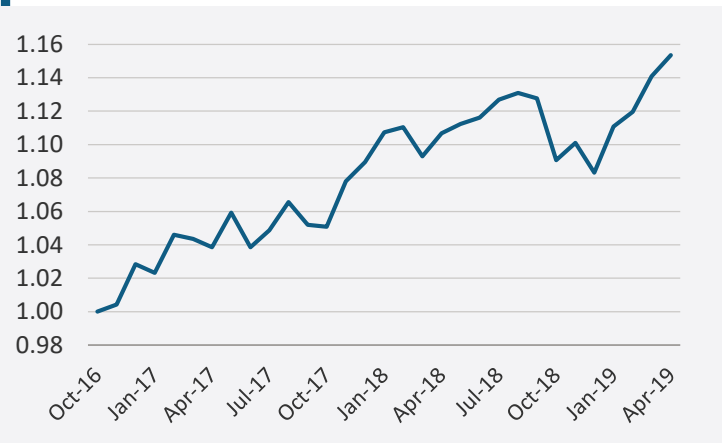
One of the most exciting aspects of the investment is the *incremental* returns on capital. Between the US and China Starbucks has an average 75% pre-tax return. If we assume a fair value multiple for these incremental returns of 15x then each \$1 invested is worth \$11 in business value within a year. We struggle to find opportunities like this in any other sector, especially one so defensive and resilient. When we invested the stock was trading on 17.5x 2020 earnings estimates, very close to a decade low. The shorter term issues around US saturation and China competition should abate, and the business and the industry have many tailwinds which will benefit long-term investors through time. It's a great example of our process in action and, hopefully, more opportunities like the Nestle licensing deal will present further upside opportunities over the years to come.

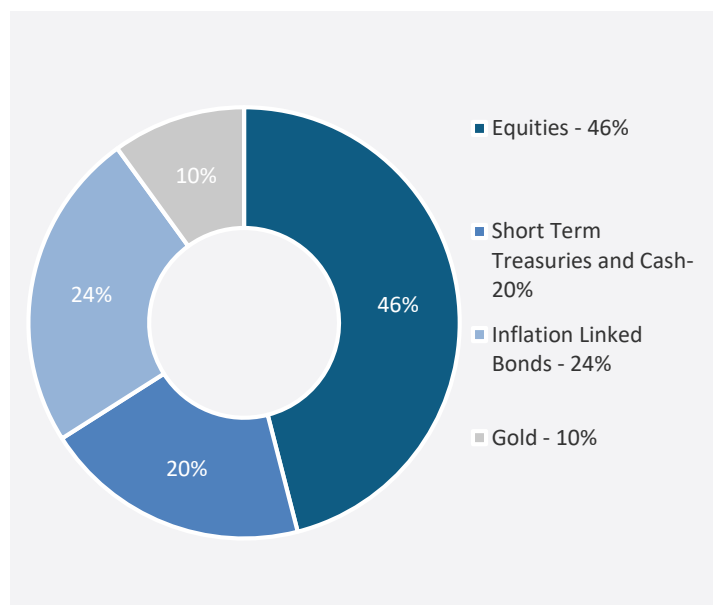
