

“GET50” Promotion of BOTS Terms and Conditions

BOTS Hungary Kft. (“BOTS” or “we”/“our”) offers new customers (“you”/“your”) the opportunity to receive the equivalent of 50 euro in TUSD for opening a BOTS Account during the promotional period (15th September 2021 - 30th November 2021).

Please read below to see how this works and what are the underlying terms and conditions.

1. These Terms and Conditions (hereinafter the “T&C”) regulate the promotional program of BOTS called “GET50”. By participating in the promotion program, you agree to be bound by these T&C and the general Terms & Conditions of BOTS.
2. Please note that the use and access to the BOTS mobile application (hereinafter the “BOTS Platform”), including, but not limited to, all investment strategies accessible through the BOTS Platform (hereinafter the “bots”) and all associated information or content accessible through, or in conjunction with, the BOTS Platform (hereinafter the “BOTS Content”) are regulated by the general Terms & Conditions of BOTS which can be found here: <https://www.bots.io/legal/terms-conditions>
3. In order to be eligible to receive the equivalent of 50 euro in TUSD, in accordance with art. 6, you will need to comply with the following conditions:
 - a. You will need to be a new user (as defined in art. 4)
 - b. You will need to start one or more bots on the BOTS Platform with a total deposit value of at least EUR 150 as per the conditions in art. 5. The deposit value may be used to start one or multiple bots.
 - c. You shall not withdraw the deposited EUR 150 in bot(s) on the BOTS Platform for a period of 6 months as per the conditions in art. 5.
 - d. You have completed the Client Due Diligence measures of BOTS, and have read and accepted the general Terms & Conditions of BOTS.
 - e. You have entered the ‘GET50’ promo code in the BOTS Platform within 7 days of depositing EUR 150 in bot(s) on the BOTS Platform.
 - f. You have not used the ‘GET50’ promo code before.
4. The goal of this promotion is to allow new users to get to know the BOTS App better. ‘New users’ shall be defined as natural persons that created a BOTS Account during the promotional period, or natural persons that created a BOTS Account before, but were not yet active in the BOTS Platform until the promotional period.
 - a. ‘opening a BOTS Account during the promotional period’ shall be understood to mean creating an Account in the BOTS Platform during the period 15th September 2021 - 30th November 2021.
 - b. ‘not yet active in the BOTS Platform until the promotional period’ shall be understood to mean not having started a bot before 15th September 2021.
5. The bot(s) on the BOTS Platform in which you have deposited EUR 150 can be stopped, and the deposit, whose value may have changed, can be reinvested into other bot(s). In any case, the deposit needs to be in bot(s) for a minimum of 175 days during a period of 6 months. This 6-month period starts once a user has entered the promo code and deposited EUR 150 or more in bot(s) on the BOTS Platform. ‘Early withdrawal’ shall be understood to mean a withdrawal of the own invested funds as per art. 3 initiated prior to the lapse of above mentioned 175 days. Early withdrawal

is meant to be a breach of these T&C and cause the loss of your right to the granted funds (equivalent of 50 euro in TUSD). In such a case, the value equal to the equivalent of 50 euro in TUSD will be automatically blocked for withdrawal by you and returned to BOTS. The rest of the balance on your BOTS Account can be withdrawn without restrictions. Loss of own funds invested in bot(s), including the case in which the value of own invested funds drops below the minimum initial investment as per art. 3 (c), is not meant to be Early withdrawal.

6. Once you receive the equivalent of 50 euro in TUSD, you will be able to use the amount to start a bot or keep it in available funds until the above mentioned 175 days period ends. The actual value of 'the equivalent of 50 euro in TUSD' might differ slightly depending on the actual exchange rate. During the 6-month period, defined in art.5, you will not be able to withdraw the equivalent of 50 euro in TUSD. After the 6-month period ends, you will be able to withdraw the balance of funds, or any part of it, from your BOTS Account without any restrictions, including the granted funds.
7. The 'GET50' promo code can only be used once, and users are eligible to receive the equivalent of 50 euro in TUSD only once. BOTS reserves the right to withdraw any additional funds received already by you from your BOTS Account as a result of technical and/or telecommunication problems, including misuse of the 'GET50' promo code.
8. The initial term during which this promotion program will be valid is 15th September 2021 - 30th November 2021.
9. In case of any abuse and/or fraud, or in case of violation of the general Terms & Conditions of BOTS, or these T&C, BOTS reserves the right to disqualify you from the promotion program and withdraw the equivalent of 50 euro in TUSD already received by you from your BOTS Account.
10. Please keep in mind that this promotion does not apply to the Netherlands. Dutch consumers are not eligible to participate.
11. Matters not regulated by the present T&C shall be governed by the general Terms and Conditions of BOTS.
12. Complaints about this referral program can be sent by e-mail to support@revenyou.io stating "complaint about referral program". The rules stipulated in the general Terms and Conditions of BOTS for filing a complaint shall be applied accordingly.
13. BOTS is not liable for the actions or omissions of third parties, except for third parties participating in the performance of BOTS' obligation under this T&C.
