Connected HD Box Trial Terms & Conditions

- 10. As a participant of the Connected HD Box Trial under the Astro Trial Programme, you agree to the following terms and conditions.
- 11. To be eligible for participation in the Astro Trial Programme as a Connected HD Box tester, you are required to:
 - a. be an active regular customer (IPTV, NJOI and Astro Broadband customers are not eligible);
 - b. have an existing byond HD box or Personal Video Recorder (PVR). A new decoder yet to be introduced to the market ("New Box') will be provided during the Connected HD Box Trial.

 Please note that customers with non-HD or Ultra box are not eligible for this Connected HD Box Trial;
 - c. have an existing Astro primary subscription worth less than RM100 per month;
 - d. have an existing subscription to the HD+ Recording (PVR) service or have an existing subscription to Family Pack and above;
 - e. reside in and to install the New Box in Klang Valley areas; and
 - f. have a minimum broadband speed of 10Mbps/decoder.

- 18. The New Box used for Connected HD Box Trial comes with a 6-month installation workmanship warranty upon activation.
- 19. In the event you choose to terminate your Astro subscription during or after the Connected HD Box Trial period, you agree to allow Astro to collect all equipment provided by Astro.
