Streamtime is committed to protecting your privacy and your security. Wewant to be as transparent as possible and never want to hide anything from our customers who trust us with their import information.

Streamtime does not own your data, nor do we sell it to others or use it foradvertising. It is 100% your data.

Here are our policies regarding the collection, use and disclosure of personal information we receive.

By using <u>streamtime.net</u>, <u>app.streamtime.net</u> or Streamtime Classic you agree to the collection and use of information set in this Privacy Policy andour <u>Terms</u>. You also agree to subscribe to product information, newslettersor marketing materials we may send. However, you may opt out of receiving these by selecting the unsubscribe option on any communication from us.

#### What we collect:

When collecting information we do so to ensure we're providing you withthe best service possible.

<u>Account Info</u> - we may ask you to provide us with certain information that can be used to contact or identify you. This information may include, but is not limited to your name, company name and email address.

<u>Billing Info</u> - when you purchase Streamtime we will ask you to provideyour billing address and credit card information.

<u>Log Data</u> - we collect information that your browser sends whenever you visit our website. This may include information such as your computer's Internet Protocol address, browser type, browser version,

the pages of our website that you visit, the time and date of your visit, the time spent on those pages and other similar statistics.

<u>Streamtime Usage</u> - we use third parties like <u>Intercom</u> for in-app customersupport & email marketing analytics and <u>Fullstory</u> for user analytics. If you wish to opt out of any data collection, you can install browser analytics blocker plug-ins (eg. Ghostery). You can also opt out of Fullstory by going <u>here</u>.

### Do we use Cookies?

Like many websites, we use cookies to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able touse some portions of our website.

Cookies are files with a small amount of data, which may include anonymous unique identifier. Cookies are sent to your browser from aweb site and stored on your computer's hard drive.

In addition, we use third parties like <u>Google Analytics</u> and <u>Mixpanel</u> for website analytics. You may opt-out of third party cookies from Google Analytics and Mixpanel on their respective websites.

# Google Ad Network

Our website uses the Google AdWords remarketing service to advertiseon third party websites (including Google) to previous visitors to streamtime.net. This could be in the form of an advertisement on the Google search results page, or a site in the Google Display Network.

Google use cookies to serve ads based on someone's past visits to our website. Of course, any data collected will be used in accordance with ourown privacy policy and <u>Google's privacy policy</u>. You can opt out of Google's use of cookies by visiting <u>Google's Ad Settings</u>.

<u>Pay the bills</u> - we do need to bill you for our services. In the very unlikely case of a sale, merger, consolidation, or acquisition, we may also have to transfer your information. Your email address may also be used to send youinformation, respond to inquiries, and/or other requests or questions.

## **Security**

We implement a variety of security measures to maintain the safety of your personal information.

All supplied sensitive/credit information is transmitted via Secure SocketLayer (SSL) technology.

Credit card details stored on site are encrypted using 256bit AES encryption.

We use BNZ to process all credit card transactions and their privacy policycan be found <a href="here">here</a>.

Your Streamtime database is hosted on Amazon's AWS servers and youcan view their privacy & security policies on their <u>website</u>.

If you are a Streamtime Classic customer your system is FileMaker based (the FileMaker privacy policy can be found <a href="here">here</a>) and you are responsible for managing your own FileMaker Server.

If Streamtime agrees to provide hosting services to you in connection withthe use of our Streamtime Classic then that service is as per section 9 of our terms. These server providers have their own privacy policies: Blue Pineapple (Amsterdam), Servers Australia (Melbourne), Amazon Web Services & Servers Australia (Sydney), Nimbus Hosting (London), Productive Computing (New York).

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage, is 100% secure. While we strive to use commercially acceptable means to protect your personal information, we cannot guarantee its absolute security.

#### **Data Breaches**

Streamtime has an internal data breach procedure and response plan in place. If a notifiable personal data breach is discovered, we will notify youwithin 72hrs of discovery.
