Application

The Environmental Policy, the Code of Ethics and the Code of Conduct of the company AUFEER TOOLS apply to the company AUFEER TOOLS and its subsidiaries, including minority shares in companies it co-owns (hereinafter referred to as "AUFEER TOOLS"). It shall also apply to all employees of such companies, without exception, regardless of their status, function or level of employment, and to any member of any of the company bodies of these entities.

Water

The company AUFEER TOOLS s.r.o. uses water from the municipal water pipeline, the water is consumed in sanitary facilities for employees and minor maintenance, due to the field of business activity and especially design activities it is clear that the water is not used for technological purposes.

The company AUFEER TOOLS s.r.o. does not discharge waste water into surface waters, only into the municipal sewer system.

Most of the rainwater is collected in the retention tank for watering, if it is filled the excess flows into the infiltration objects an the AFD premises.

The building of the company management uses solar panels for water heating which saves energy and consequently does not burden the environment.

Air

The company AUFEER TOOLS s.r.o. does not produce any emissions which would be the by-product directly related to our business activity.

The company AUFEER TOOLS operates passenger cars producing emissions but all cars of the company AUFEER TOOLS s.r.o. meet the emission limits set by law and undergo service inspections at regular intervals which also include emission measurements. Emission production is the main criterion in choosing a new vehicle, which is why the company management is considering buying electric cars and installing charging stations in the future. The infrastructure and cable preparation for 3 pieces of charging stations has already been prepared at the company premises, which will be subsequently used for own vehicles as well as for employees and visitors.

The company motivates the use of emission-free means of transport, therefore it establishes indoor parking places for bicycles, electric bicycles and scooters and it supports the expansion of the public transport network in the region.

Waste management

The philosophy of the company AUFEER TOOLS s.r.o. is not to generate unnecessary waste and to sort and recycle the generated waste as much as possible.

The company strictly requires complex sorting of waste at all its workplaces.

All sorted waste at the company AUFEER TOOLS s.r.o. is recycled in cooperation with specialized companies. The company strictly requires proof of waste management.
