#### What is the purpose of this update?

This document tells you how the i-Select PIE Superannuation Scheme NZD Growth Fund (Fund) has performed and what fees were charged. The document will help you to compare the Fund with other funds.

i-Select Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this Fund**

The Fund is a New Zealand-domiciled diversified portfolio that invests primarily in Growth assets, such as Equities. The portfolio has allocations to Equities, Fixed Interest, Real Assets and Cash. The portfolio employs an active approach to asset allocation and a predominantly active multi-manager approach to security selection.

#### What are the risks of investing?

#### Risk indicator for the NZD Growth Fund<sup>1</sup>


## How has the Fund performed?

## Example of how this applies to an investor


Jane had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted of \$1,737 (that is 17.37% of her initial \$10,000). Jane paid \$0 in other charges. This gives Jane a total return after tax of \$1,559 for the year.


#### **Actual investment mix**
