i-Select Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

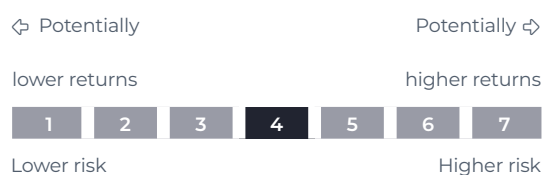
Description of this Fund

The Fund is an Australian-domiciled diversified portfolio that invests in Defensive assets, such as Fixed Interest and Cash, and Growth assets, such as Equities. The portfolio has allocations to Equities, Fixed Interest, Real Assets, Cash and Alternatives. The portfolio employs an active approach to asset allocation and a predominantly active multi-manager approach to security selection. The Fund currency is Australian Dollars (AUD).

What are the risks of investing?

Risk indicator for the AUD Balanced Fund¹

While risk indicators are usually relatively stable, they do shift from time to time. The risk indicator will continue to be updated in future fund updates.

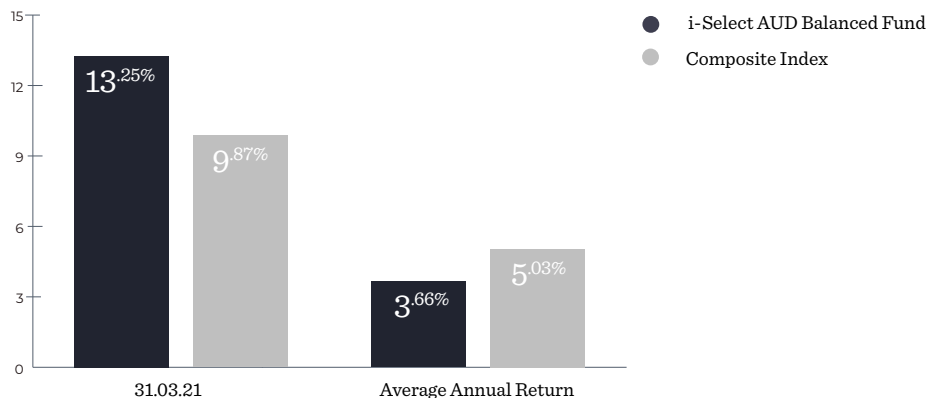

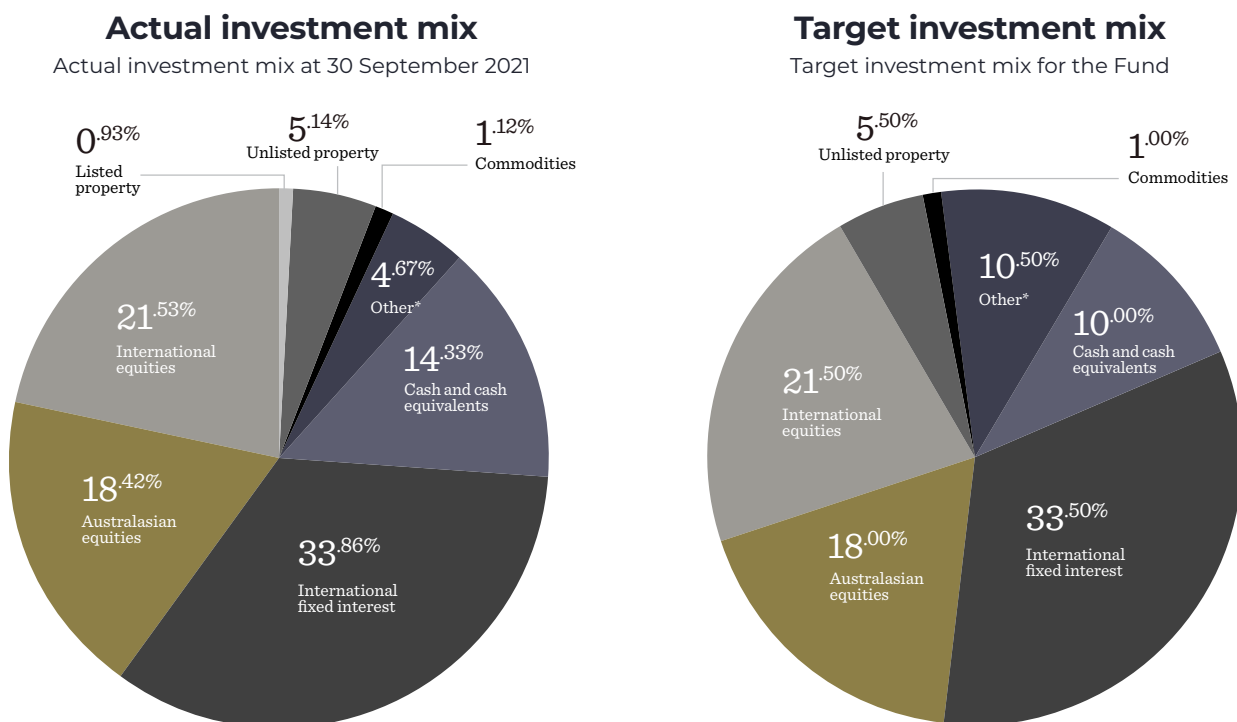
Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Jane had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Jane received a return after fund charges were deducted of \$1,210 (that is 12.10% of her initial \$10,000). Jane paid \$0 in other charges. This gives Jane a total return after tax of \$1,078 for the year.
