a woman of character

Carol Willman made a difference in the lives of many children during her career as a special educator. She carried a Ph.D, which allowed her to travel as far as London to share her gifts and research.



Later in life, Carol's passion included older adults. She made her first gift to Farmington Presbyterian Manor in 2002. Over the course of her 18 years of giving, she funded the Rev. Clyde West Chapel (*above right*) with her aunt Marjarie Blight. Carol also honored a fellow resident and dear friend, Leroy Dalton, with funds to purchase and build a wheelchair accessible gazebo for all to enjoy. She supported the annual Angel tree, the Chicken N Dumplings fundraiser, and then in 2019 she served on the campaign committee for the Hull Family Fellowship Center and made a personal gift to the campaign. She believed in the project deeply and looked forward to many events and gatherings in the center with residents and staff.

To know Carol was to know that she lived out her faith in her daily life and in her planning. She made the ultimate decision to make a bequest for the Good Samaritan Program so that residents who did not have the financial means to afford care were ensured a safe and caring home. The gift allowed Farmington Presbyterian Manor to recognize Carol as a member of the Alice Kalb Society. She shared a message once about why she gives.
