

TING "BIG GAME GIVEAWAY" SWEEPSTAKES

OFFICIAL RULES

2. **How To Enter:** Visit mobile.ting.com/yeti-big-game and complete one or more entry options offered on the Glean widget (number of entries per action to be determined on landing page). Entrants will also automatically receive additional entries if they activate on a Ting Mobile plan during the contest window (each active account will receive the following entries: Flex - 2 entry, Set 5 - 4 entries, Set 12 - 6 entries, Unlimited - 8 entries, Unlimited Pro - 10 entries).
3. Entrants may only complete every task once.

This Sweepstakes is in no way sponsored, endorsed, administered by, or associated with Instagram, Facebook, Twitter, or YETI and entrants hereby release Instagram from any liability in connection with this Sweepstakes.
