

## PMMA's COVID-19 Response Timeline

**March 11, 2021** – PMMA releases new guidance for all campuses for visitation based on the Centers for Medicare and Medicaid Services (CMS) guidance released on March 10, 2021. Guidance opened up visitation to residents in every level of living no matter what the county positivity rate is for COVID-19 testing. Outdoor visitation remains preferred for all residents.

**March 10, 2021** – Emporia Presbyterian Manor reports an essential health care worker has tested positive for the virus. The employee last worked on March 7. The health department has been notified and surveillance testing will continue.

**March 10, 2021** – Parsons Presbyterian Manor reports one non-direct resident care employee tested positive March 10. The health department was notified and surveillance testing will continue.

**March 5, 2021** – PMMA releases new guidance for independent living resident visitation when residences are under the same roof as licensed care areas including skilled nursing, assisted living and memory care. Guidance allows independent living residents to have two guests at a time in their residences. Communities may determine whether visitors need to schedule in advance based on the ability to track campus visitors and provide screening services.

**March 4, 2021** – Emporia Presbyterian Manor reports a health care resident of Emporia Presbyterian Manor who previously tested positive for COVID-19 has passed away.

**February 23, 2021** – Wichita Presbyterian Manor reports one essential health care worker in memory care tested positive for the virus during our weekly employee surveillance testing on Monday, February 22. The health department was notified and surveillance testing will continue.

**February 19, 2021** – Emporia Presbyterian Manor reports a health care resident who previously tested positive for COVID-19 has died.

**February 18, 2021** – Emporia Presbyterian Manor reports a non-direct care employee has tested positive for the virus. The employee last worked on February 18. The health department was notified and surveillance testing will continue.

**February 16, 2021** – Emporia Presbyterian Manor reports two health care residents tested positive for COVID-19 via rapid point-of-care (POC) testing. The resident will recuperate in the COVID-19 isolation area, cared for by designated employees. A health care resident who previously tested positive for COVID-19 passed away.

## PMMA (Presbyterian Manors of Mid-America) Response Timeline

**February 13, 2021** – Wichita Presbyterian Manor reports one essential health care worker tested positive for COVID-19. The employee last worked February 7. The health department was notified and surveillance testing will continue.

**February 13, 2021** – Aberdeen Heights reports one essential health care worker tested positive for COVID-19 during surveillance testing February 8. Results were received February 11. The employee last worked February 10. The health department was notified and surveillance testing will continue.

**February 12, 2021** – Emporia Presbyterian Manor reports two essential health care workers tested positive for the COVID-19 virus. The employees last worked on February 8, screening in prior to their shifts and wearing personal protective equipment (PPE) while at work. The health department has been notified and surveillance testing will continue.

**February 12, 2021** – Fort Scott Presbyterian Village reports a resident who previously tested positive for COVID-19 has passed away.

**February 8, 2021** – Arkansas City Presbyterian Manor hosted its second COVID-19 vaccine clinic for residents and staff. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**February 8, 2021** – Emporia Presbyterian Manor reported a resident who previously tested positive for COVID-19 has died, and an independent living resident has tested positive for the virus. The resident will recuperate in the COVID-19 isolation area, cared for by designated employees. Also, four health care residents have tested positive via rapid point-of-care testing. Mass testing will continue as the community fights an outbreak at the campus.

**February 8, 2021** – Manor of the Plains hosted its third COVID-19 vaccine clinic for residents and staff. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**February 7, 2021** – Farmington Presbyterian Manor reported one essential health care employee tested positive for COVID-19. The employee last worked January 31. The health department was notified and surveillance testing will continue.

**February 6, 2021** – Clay Center Presbyterian Manor hosted its second COVID-19 vaccine clinic for residents and staff. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**February 6, 2021** – Farmington Presbyterian Manor hosted its second COVID-19 vaccine clinic for residents and staff. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**February 6, 2021** – Fort Scott Presbyterian Village announced a resident who previously tested positive for COVID-19 died at the community. Testing will continue as the community continues to fight an outbreak.

**February 5, 2021** – Emporia Presbyterian Manor reported the death of a health care resident who previously tested positive for COVID-19. In addition, three health care residents and one essential health care worker tested positive for the virus.

**February 4, 2021** – Emporia Presbyterian Manor hosted its second COVID-19 vaccine clinic for residents and staff. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**February 4, 2021** – Fort Scott Presbyterian Village reported one essential health care worker tested positive for COVID-19. The health department was notified and testing will continue as directed for residents and staff.

**February 3, 2021** – Emporia Presbyterian Manor reports four health care residents and an essential health care worker tested positive for COVID-19. The Flint Hills Community Health Department has been notified. Testing for residents and employees will continue as the community continues to fight the outbreak.

**February 2, 2021** – The Glen at Aberdeen Heights had its second COVID-19 vaccine clinic for staff and residents. The campus is participating in the Pharmacy Partnership for Long-Term Care Program with CVS.

**February 2, 2021** – Emporia Presbyterian Manor reports three health care residents tested positive for COVID-19. The Flint Hills Community Health Department has been notified. Testing for residents and employees will continue as the community continues to fight the outbreak.

**February 1, 2021** – Wichita Presbyterian Manor reported two of three employees placed in quarantine after exposure to another employee who tested positive for COVID-19 last week have tested positive for the virus. The health department was notified and testing continues at the campus.

**January 31, 2021** – Salina Presbyterian Manor reported one essential health care worker tested positive for COVID-19 after reporting signs and symptoms to a supervisor while working. The employee was sent home and the health department was notified. Testing continues for residents and staff.

**January 30, 2021** – Fort Scott Presbyterian Village reported one essential health care employee tested positive for COVID-19 with a rapid point-of-care (POC) test during pre-shift screening. The health department was notified and testing will continue as directed.

**January 30, 2021** – Salina Presbyterian Manor reported one health care resident tested positive for COVID-19 with a rapid point-of-care (POC) test. The resident was tested due to a previously reported exposure risk. Testing will continue for residents and staff.

**January 29, 2021** – Fort Scott Presbyterian Village reported two residents and two essential health care employees tested positive for COVID-19. The health department was notified and testing will continue for residents and staff as directed.

**January 28, 2021** – Clay Center Presbyterian Manor reports one recently admitted resident has tested positive for COVID-19. The resident, who was in isolation in accordance with new admission protocols, tested negative on January 21, January 22 and January 25. The resident was transferred to the emergency room January 28 for a medical evaluation and was administered another COVID-19 test, which was positive. The resident remained hospitalized.

**January 28, 2021** – Emporia Presbyterian Manor reported two health care residents tested positive for COVID-19 via rapid point-of-care (POC) tests. The Flint Hills Community Health Department has been notified. Testing for residents and employees will continue as the community continues to fight the outbreak.

**January 28, 2021** – Salina Presbyterian Manor had its second COVID-19 vaccine clinic for staff and residents. The campus is participating in the Pharmacy Partnership for Long-Term Care Program with CVS.

**January 27, 2021** – Emporia Presbyterian Manor reported four essential health care workers and four health care residents tested positive for COVID-19. The Flint Hills Community Health Department has been notified. Testing for residents and employees will continue as the community fights the outbreak.

**January 27, 2021** – Fort Scott Presbyterian Village reported another resident tested positive for COVID-19 with a rapid point-of-care (POC) test. The health department was notified and recommended administering standard tests to all residents to confirm diagnoses. Staff testing will continue.

**January 27, 2021** – Newton Presbyterian Manor reported three independent living residents living outside the main building tested positive for COVID-19. Two of the residents reported positive test results after exposure to a close contact who tested positive. The third resident tested positive after residents in that area of campus were offered the opportunity to be tested. The residents will recover in their residences until they meet health department guidelines for ending isolation.

**January 27, 2021** – Parsons Presbyterian Manor hosted its second COVID-19 vaccine clinic for residents and staff. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**January 27, 2021** – Salina Presbyterian Manor reported one resident who previously tested positive for COVID-19 has died. In addition, two residents who had suspected contact with previously reported positive cases tested positive for COVID-19. The health department was notified and testing continues for residents and staff.

**January 27, 2021** – Wichita Presbyterian Manor reported one essential health care employee and one non-direct resident care employee tested positive for the virus January 25. Contact tracing identified three employees with possible exposure risk, who will quarantine as directed by the Sedgwick County Health Department as a precaution. Testing continues for employees and health care and PATH residents.

## PMMA (Presbyterian Manors of Mid-America) Response Timeline

**January 26, 2021** – Aberdeen Heights hosted its first vaccine clinic for independent living residents and employees, with 225 people participating. The campus is participating in the Pharmacy Partnership for Long-Term Care Program with CVS.

**January 26, 2021** – Arkansas City Presbyterian Manor reports one memory care resident tested positive for COVID-19 January 25 after an employee tested positive the week prior. Memory care residents will be tested again February 1, and employee surveillance testing will continue as required.

**January 26, 2021** – Fort Scott Presbyterian Village reported five residents tested positive for COVID-19 after mass testing at the community. All residents were tested after two residents tested positive with rapid point-of-care tests. The health department was notified and recommended administering standard tests to all residents to confirm diagnoses. Staff testing will continue.

**January 25, 2021** – Aberdeen Village reports an essential health care worker has tested positive for the virus via rapid point-of-care (POC) testing. The Johnson County Health Department was notified. Mass testing will continue as required.

**January 25, 2021** – Fort Scott Presbyterian Village reported an essential health care worker tested positive for COVID-19. The Bourbon County Health department was notified and three residents with possible contact were quarantined per health department recommendations. Staff testing continues.

**January 25, 2021** – Salina Presbyterian Manor reported one health care resident and one essential health care worker have tested positive for COVID-19. The health department was notified and testing continues for staff and residents.

**January 23, 2021** – Newton Presbyterian Manor reported one non-direct resident care employee tested positive for COVID-19 via rapid point-of-care (POC) testing. The health department was notified. Employee surveillance testing will continue as required.

**January 22, 2021** – Rolla Presbyterian Manor reported an independent living resident at the campus tested positive for COVID-19 after exhibiting signs and symptoms of the illness. The resident will self-quarantine in their residence. The Phelps County Health Department was notified and employee surveillance testing continues at the community.

**January 22, 2021** – Salina Presbyterian Manor reported one essential health care employee tested positive for COVID-19. In addition, two health care residents, who were tested due to exhibiting signs and symptoms of the virus, have tested positive. The health department was notified and testing will continue for residents and staff.

**January 22, 2021** – Wichita Presbyterian Manor had its first COVID-19 vaccine clinic for staff and residents with 262 people participating. The campus is participating in the Pharmacy Partnership for Long-Term Care Program with CVS.

**January 21, 2021** – Emporia Presbyterian Manor reported an essential health care worker and a non-direct resident care employee tested positive for COVID-19. The Flint Hills Community Health Department has been notified. Testing for residents and employees will continue.

**January 21, 2021** – Topeka Presbyterian Manor had its second COVID-19 vaccine clinic for staff and residents. In addition to those receiving their second dose of the vaccine, an additional 19 people received a first dose of the vaccine. The campus is participating in the Pharmacy Partnership for Long-Term Care Program with CVS.

**January 20, 2021** – Aberdeen Village had its second COVID-19 vaccine clinic for staff and residents. In addition to those receiving their second dose of the vaccine, an additional 42 people received a first dose of the vaccine. The campus is participating in the Pharmacy Partnership for Long-Term Care Program with CVS.

**January 20, 2021** - Arkansas City Presbyterian Manor reported an essential health care worker tested positive for COVID-19 January 18. Memory care residents will be tested in 7 days due to the potential for exposure, and employee surveillance testing will continue.

**January 20, 2021** – Clay Center Presbyterian Manor reported one non-direct resident care employee tested positive for COVID-19 in surveillance testing. Resident and employee testing will continue at the community.

**January 20, 2021** – Lawrence Presbyterian Manor reported one essential health care worker tested positive for COVID-19. The Douglas County Health Department was notified. The campus continues with employee surveillance testing.

**January 20, 2021** – Newton Presbyterian Manor reported an essential health care worker tested positive for COVID-19 at the campus. The employee was tested as part of ongoing surveillance testing but had been in quarantine due to a close contact testing positive for COVID-19. Employee surveillance testing will continue.

**January 20, 2021** – Salina Presbyterian Manor reported one health care resident has tested positive for COVID-19 with a rapid point-of-care (POC) test. The health department was notified and testing will continue for residents and staff.

**January 20, 2021** – Wichita Presbyterian Manor reported results for residents in assisted living, memory care, health care and PATH® (Post-Acute to Home) short-term rehabilitation were negative. However, one essential health care employee tested positive for the virus January 18. The health department has been notified. This round of tests marks two weeks with no new cases in assisted living or memory care. Residents in those areas will not be tested next week. Employee surveillance testing and testing for health care and PATH residents continues.

**January 18, 2021** – Arkansas City Presbyterian Manor hosted its first COVID-19 vaccine clinic for residents and staff, with 121 people receiving the vaccine. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**January 18, 2021** – Manor of the Plains hosted its second COVID-19 vaccine clinic for residents and staff. In addition to those receiving their second dose of the vaccine, an additional 100 people received their first dose. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**January 18, 2021** – Newton Presbyterian Manor reported one essential health care worker tested positive for COVID-19 after exhibiting signs and symptoms of the virus. The campus had not had a new case for two weeks. The health department was notified and employee surveillance testing will continue.

**January 17, 2021** – Aberdeen Village reports an assisted living resident tested positive for COVID-19 with a rapid point-of-care (POC) test after exhibiting signs and symptoms of the virus. The Johnson County Health Department was notified. Mass testing will continue as required.

**January 16, 2021** – Clay Center Presbyterian Manor hosted its first COVID-19 vaccine clinic for residents and staff with 74 people receiving the vaccine. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**January 16, 2021** – Rolla Presbyterian Manor had its first COVID-19 vaccine clinic for staff and residents with 65 people participating. The campus is participating in the Pharmacy Partnership for Long-Term Care Program with CVS.

**January 16, 2021** – Parsons Presbyterian Manor reported one health care resident tested positive for COVID-19. The resident, who is asymptomatic, was a recent admission and was still in the initial quarantine period. The health department was notified and testing will continue.

**January 15, 2021** – Arkansas City Presbyterian Manor reported one non-direct resident care employee tested positive for COVID-19. The Cowley County Health Department was notified. Employee surveillance testing will continue.

**January 15, 2021** – Salina Presbyterian Manor reported one non-direct resident care employee, one PATH® (Post-Acute to Home) resident and one independent living resident tested positive for COVID-19 at the campus. The health department was notified and testing will continue for staff and residents.

**January 15, 2021** – Topeka Presbyterian Manor reported a health care resident who previously tested positive for COVID-19 died. Residents continue to be monitored for signs and symptoms of COVID-19 and employee surveillance testing continues.

**January 15, 2021** – Wichita Presbyterian Manor reported one PATH® (Post-Acute to Home) resident has tested positive for COVID-19. The positive test was conducted during admission and the resident will remain isolated until cleared by the health department. The health department has been notified and testing will continue for staff and residents.

**January 14, 2021** – Aberdeen Village reports one health care residents who previously tested positive for COVID-19 has passed away. In addition, one health care resident has tested positive

for the virus as part of our ongoing surveillance testing. The Johnson County Health Department was notified. Mass testing will continue as required.

**January 14, 2021** – Emporia Presbyterian Manor hosted its first COVID-19 vaccine clinic for residents and staff with 136 people receiving the vaccine. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**January 14, 2021** – Fort Scott Presbyterian Village residents had the opportunity to receive a first dose of the COVID-19 vaccine through a partnership with Community Health Center of Southeast Kansas. A second clinic was scheduled for January 28.

**January 13, 2021**- Arkansas City Presbyterian Manor reports one non-direct resident care employee tested positive for COVID-19. No residents were exposed. Employee surveillance testing will continue.

**January 13, 2021** – Clay Center Presbyterian Manor reported one resident who previously tested positive for COVID-19 died. One essential health care employee tested positive for COVID-19. All other tests were negative. Testing will continue at the campus.

**January 13, 2021** – Emporia Presbyterian Manor reported an essential health care worker tested positive for COVID-19. The Flint Hills Community Health Department has been notified. Testing for residents and employees will continue.

**January 13, 2021** – Salina Presbyterian Manor reported an essential health care worker tested positive for COVID-19 during pre-shift screening and one health care resident tested positive in mass testing at the community. The health department was notified and testing will continue for residents and staff.

**January 13, 2021** – Wichita Presbyterian Manor reported two non-direct resident care employees tested positive for COVID-19. The health department has been notified and testing continues for residents and staff.

**January 12, 2021** – Aberdeen Village (Olathe, Kan.) received its second consecutive zero deficiency survey for infection control practices at the community. The survey, conducted earlier this month, was done on behalf of the Centers for Medicare and Medicaid Services. The community was surveyed due to an ongoing outbreak.

**January 12, 2021** – Newton Presbyterian Manor hosted its first COVID-19 vaccine clinic for residents and staff with 180 people receiving the vaccine. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**January 11, 2021** – Lawrence Presbyterian Manor hosted its first COVID-19 vaccine clinic for residents and staff with 147 people receiving the vaccine. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**January 11, 2021** – Topeka Presbyterian Manor reported one contract non-direct resident care employee tested positive for COVID-19. The community notified the health department and will continue with employee surveillance testing as required.

**January 11, 2021** – Salina Presbyterian Manor reported that a resident who previously tested positive for COVID-19 has died. In addition, two essential health care workers tested positive with rapid point-of-care tests. The health department was notified and resident and staff testing continues.

**January 9, 2021** – Farmington Presbyterian Manor hosted its first COVID-19 vaccine clinic for residents and staff with 133 people receiving the vaccine. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**January 8, 2021** – Aberdeen Heights reported one non-direct resident care employee tested positive for COVID-19 on January 6. Employee surveillance testing will continue as required based on the St. Louis County positivity rate for COVID-19 testing.

**January 8, 2021** – Clay Center Presbyterian Manor reported one resident who previously tested positive for COVID-19 died. Testing for residents and staff will continue.

**January 8, 2021** – Parsons Presbyterian Manor reported one non-direct resident care employee tested positive for COVID-19. The employee had not worked since before Christmas. The health department was notified, but there was no exposure risk for staff or residents. Community testing will continue.

**January 7, 2021** – Parsons Presbyterian Manor hosted its first COVID-19 vaccine clinic. There were 48 individuals who received the vaccine, including 13 staff members. The second clinic date set for January 27.

**January 7, 2021** – Salina Presbyterian Manor had its first COVID-19 vaccine clinic for staff and residents with 253 people participating. The campus is participating in the Pharmacy Partnership for Long-Term Care Program with CVS.

**January 6, 2021** – Aberdeen Village reported two health care residents, an essential health care worker, a non-direct care employee and a contract health care employee tested positive for the virus in the latest round of testing.

**January 6, 2021** – Clay Center Presbyterian Manor reports a resident who previously tested positive for COVID-19 died, and two non-direct resident care employees tested positive for COVID-19. Testing for residents and employees will continue.

**January 6, 2021** – Newton Presbyterian Manor reported one non-direct resident care employee tested positive for COVID-19. All assisted living residents tested were negative for the virus. With two rounds of resident testing complete with no new cases identified, so residents will not

be tested next week. The health department was notified of the positive case and employee surveillance testing will continue.

**January 6, 2021** – Salina Presbyterian Manor reported that three essential health care workers tested positive for COVID in surveillance testing January 4. The health department was notified and resident and staff testing will continue at the campus.

**January 6, 2021** – Wichita Presbyterian Manor reported two non-direct resident care employees tested positive for COVID-19 in surveillance testing January 4. The health department has been notified and testing will continue for residents and staff.

**January 5, 2021** – The Glen at Aberdeen Heights hosted its first COVID-19 vaccine clinic for staff and residents with 153 people receiving their first doses. The campus is participating in the Pharmacy Partnership for Long-Term Care Program with CVS.

**January 5, 2021** – Emporia Presbyterian Manor reported an independent living resident who previously tested positive for COVID-19 has died. In addition, one essential health care worker tested positive for the virus. The Flint Hills Community Health Department has been notified. Testing for residents and employees will continue.

**January 5, 2021** – Farmington Presbyterian Manor reported one essential health care employee tested positive with a rapid point-of-care test. The employee had not worked since December 29. The health department was notified and surveillance testing will continue.

**January 5, 2021** – Parsons Presbyterian Manor reported three non-direct resident care employees and two essential health care workers tested positive for COVID-19. The Labette County Health Department was notified and campus testing will continue as directed.

**January 5, 2021** – Topeka Presbyterian Manor reported that two independent living residents who previously tested positive for COVID-19 have died. In addition, one non-direct resident care employee tested positive for COVID-19 with a rapid point-of-care (POC) test. The health department has been notified and employee surveillance testing will continue.

**January 5, 2021** – Wichita Presbyterian Manor reported two essential health care employees tested positive for COVID-19 and one resident who previously tested for the virus died. The health department was notified and resident and staff testing continues.

**January 4, 2021** – Aberdeen Village reports one health care resident has tested positive for the virus via rapid point-of-care (POC) testing. The Johnson County Health Department was notified. Mass testing will continue as required.

**January 4, 2021** – Aberdeen Heights reported one independent living resident notified the campus that they had been tested for COVID-19 and received a positive result last week. The resident had been in quarantine since December 23.

**January 4, 2021** – Salina Presbyterian Manor reported one health care resident tested positive for COVID-19 with a rapid point-of-care (POC) test. The health department was notified and testing will continue for resident and staff.

**January 2, 2021** – Topeka Presbyterian Manor had its first COVID-19 vaccine clinic for staff and residents with 130 people participating. The campus is participating in the Pharmacy Partnership for Long-Term Care Program with CVS.

**December 31, 2020** – Aberdeen Village reports a non-direct resident care employee who reported signs and symptoms of COVID-19 has tested positive for the virus via a rapid point-of-care test at the campus. The Johnson County Health Department was notified. Mass testing will continue as required.

**December 31, 2020** – Lawrence Presbyterian Manor reported a contract health care provider who last worked December 31 tested positive for COVID-19. Because the individual is asymptomatic, the Douglas County Health Department has requested a confirmatory standard COVID-19 test within 48 hours to confirm the diagnosis. The community will continue employee surveillance testing.

**December 31, 2020** – Salina Presbyterian Manor reported an essential health care worker tested positive for COVID-19 with a rapid point-of-care (POC) test. Testing will continue for residents and staff.

**December 30, 2020** – Aberdeen Heights tested 16 assisted living residents on Monday, December 28, and all 16 results were negative for COVID-19. This completes two rounds of testing with negative results for assisted living residents. One new case of COVID-19 was identified in employee surveillance testing. Employee surveillance testing will continue as required based on the St. Louis County positivity rate for COVID-19 testing.

**December 30, 2020** – Aberdeen Village announced six health care residents, an assisted living resident, six essential health care workers, two non-direct care employees and a contract therapist at Aberdeen Village have tested positive for COVID-19 in testing December 29. The Johnson County Health Department was notified. Mass testing will continue as required.

**December 30, 2020** – Aberdeen Village had its first COVID-19 vaccine clinic for staff and residents with 195 people participating. The campus is participating in the Pharmacy Partnership for Long-Term Care Program with CVS.

**December 30, 2020** – Arkansas City Presbyterian Manor reported two non-direct resident care employees tested positive for COVID-19 during surveillance testing after nearly two weeks with no new positive cases among staff or residents. No residents were exposed. Employee surveillance testing will continue.

**December 30, 2020** – Clay Center Presbyterian Manor reported another resident who tested positive for COVID-19 died. In addition, one essential health care worker and one assisted living

resident tested positive for COVID-19. Employee surveillance testing and resident testing will continue.

**December 30, 2020** – Emporia Presbyterian Manor reported one essential health care worker and one non-direct resident care employee tested positive for COVID-19. Testing will continue at the community.

**December 30, 2020** – Farmington Presbyterian Manor reported an essential health care employee tested positive for COVID-19. The health department was notified and employee surveillance testing will continue.

**December 30, 2020** – Manor of the Plains reported two employees and one contract service provider tested positive for COVID-19 at the campus. The health department was notified and surveillance testing will continue.

**December 30, 2020** – Newton Presbyterian Manor reported one resident who previously tested positive for COVID-19 died. All residents tested negative December 28. One non-direct resident care employee tested positive for the virus December 28 after testing negative on December 27. The health department has been notified and testing will continue at the campus.

**December 30, 2020** – Salina Presbyterian Manor reported five new cases of COVID-19 – three new cases among health care residents and two new cases among staff. The health department was notified and testing continues for residents and staff.

**December 30, 2020** – Topeka Presbyterian Manor reported one independent living resident tested positive for COVID-19. The resident will recover in their residence. Employee surveillance testing continues.

**December 30, 2020** – Wichita Presbyterian Manor reported six residents tested positive for COVID-19 and were placed in isolation, and four essential health care workers tested positive for the virus. The health department has been notified and testing will continue as the campus fights the outbreak.

**December 29, 2020** – Farmington Presbyterian Manor reported two health care residents and two essential health care workers tested positive for COVID-19. The health department was notified and community testing will continue.

**December 29, 2020** – Fort Scott Presbyterian Village staff had the opportunity to receive a first dose of the COVID-19 vaccine through a partnership with Community Health Center of Southeast Kansas. A second clinic was scheduled for January 26.

**December 29, 2020** – Wichita Presbyterian Manor reported one of the residents who previously tested positive for COVID-19 died and three residents began exhibiting signs and symptoms of COVID-19 and tested positive with rapid point-of-care tests. The health department has been notified and testing continues as the campus works to contain the outbreak.

**December 28, 2020** – Aberdeen Village is notified that an assisted living resident has tested positive for COVID-19 at an area hospital. The Johnson County Health Department was notified. Mass testing will continue as required.

Employee surveillance testing and resident testing will continue.

**December 28, 2020** – Manor of the Plains hosted its first COVID-19 vaccine clinic for residents and staff with 74 people participating. The campus is participating in the Pharmacy Partnership for Long-Term Care with Walgreens.

**December 28, 2020** – Rolla Presbyterian Manor reported one non-direct resident care employee tested positive for COVID-19 via a rapid point-of-care (POC) test. The Phelps County Health department was notified and employee surveillance testing continues.

**December 28, 2020** – Salina Presbyterian Manor received its second consecutive zero deficiency survey for infection control practices in the health care center at the community. The survey, conducted December 28, was done on behalf of the Centers for Medicare and Medicaid Services. The community was surveyed due to an ongoing outbreak in the health care center.

**December 28, 2020** – Salina Presbyterian Manor reported one resident who previously tested positive for COVID-19 has died. One health care resident began exhibiting signs and symptoms of COVID-19 and tested positive for the virus. The community acted swiftly to test any other health care residents who had the potential to have been exposed to the virus. One additional resident tested positive. The health department has been notified and testing continues for residents and staff.

**December 28, 2020** – Wichita Presbyterian Manor reported three residents tested positive for COVID-19 with rapid point-of-care (POC) tests on December 27. One essential health care employee tested positive with a drive-through POC test on December 28. The health department was notified and testing for residents and staff continues.

**December 26, 2020** – Parsons Presbyterian Manor reported one essential health care worker tested positive with a rapid point-of-care (POC) test after experiencing symptoms during a shift. The health department was notified and testing at the campus will continue.

**December 24, 2020** – Aberdeen Heights reports 10 additional independent living residents tested positive for COVID-19 following an outbreak in the independent living apartments. The residents will self-quarantine until cleared to leave isolation by the health department.

**December 24, 2020** – Aberdeen Village reported health care resident tested positive in mass resident testing Monday, December 21. The resident has discharged and will isolate and recover at home.

**December 24, 2020** – Manor of the Plains reported one non-direct resident care employee tested positive for COVID-19 during surveillance testing. The health department was notified. Employee surveillance testing will continue as required.

**December 24, 2020** – Salina Presbyterian Manor reported one health care resident and one non-direct resident care employee tested positive for COVID-19. The health department was notified and testing will continue for residents and staff.

In addition, the campus was notified that an assisted living resident tested positive at the hospital over the weekend. The resident remains hospitalized. Testing at the campus will continue.

These cases bring the total cases at our community to 10 employees and 15 residents since Monday, December 14. In addition, a resident who previously tested positive for COVID-19 died.

**December 18, 2020** – Parsons Presbyterian Manor reported two residents who previously tested positive for COVID-19 died. One non-direct resident care employee and one health care resident tested positive for the virus. The health department has been notified and testing continues at the campus.

**December 18, 2020** – Salina Presbyterian Manor reported one essential health care worker and one health care resident tested positive for COVID-19. The health department was notified. Testing continues for residents and staff.

**December 18, 2020** – Wichita Presbyterian Manor reported two assisted living residents and two employees tested positive for COVID-19. The health department was notified and testing continues for residents and staff.

**December 17, 2020** – Aberdeen Heights reports one resident who previously tested positive for COVID-19 has died, and an assisted living resident has tested positive for the virus. Regular testing will continue at the campus.

**December 14, 2020** – Arkansas City Presbyterian Manor received its second consecutive zero deficiency survey for infection control practices at the community. The survey, conducted the week of December 7, was done on behalf of the Centers for Medicare and Medicaid Services. This is the second zero deficiency survey the community received while fighting the ongoing outbreak at the campus.

**December 14, 2020** – Farmington Presbyterian Manor reported two essential health care workers tested positive for COVID-19 with rapid point-of-care (POC) tests. The health department has been notified and testing continues.

**December 14, 2020** – Salina Presbyterian Manor announced one health care resident tested positive for COVID-19. The health department was notified and testing will continue for residents and staff.

**December 12, 2020** - At the end of COVID-19 testing for the week of December 7 through December 11, Aberdeen Heights reports that 2 contract service providers, 6 employees and 5 residents tested positive. One memory care resident and one health care resident tested positive. Three independent living residents reported positive COVID-19 test results to the community after being tested off site. In addition, one resident who previously tested positive for COVID-19 died.

**December 11, 2020** - Three essential health care workers, a non-direct care employee and four assisted living residents tested positive for the COVID-19 virus at Aberdeen Village. The results came from the community's latest round of testing, which took place on Monday, December 7 and Wednesday, December 9, as well as one symptomatic resident who tested positive via rapid point-of-care (POC) testing. The essential health care workers and the non-direct care employee last worked on December 8 and December 10. They screened in before their shifts and wore personal protective equipment while working.

**December 11, 2020** – Two new cases of COVID-19 were identified through COVID-19 testing since December 7 at Arkansas City Presbyterian Manor, and one resident who tested positive for COVID-19 has died. The two new cases of COVID-19 are employees who were tested December 7 and December 9 as part of the community's ongoing employee surveillance testing. Health care and memory care residents also were tested December 7. All residents tested negative for COVID-19. The health department does not recommend continuing to test the health care residents, but memory care residents will be tested again December 14 due to a potential exposure reported last week.

**December 11, 2020** – One essential health care worker and one non-direct resident care employee have tested positive for COVID-19 at Wichita Presbyterian Manor. Both employees tested negative in surveillance testing completed November 30 and December 2. Testing will continue

**December 11, 2020** – Salina Presbyterian Manor reports three new cases of COVID-19 at the campus. One essential health care worker and two health care residents tested positive in testing this week. Employee and resident testing to continue.

**December 11, 2020** – One health care resident, one essential health care worker and two non-direct resident care employees tested positive for COVID-19 at Newton Presbyterian Manor since December 4, and three campus residents who previously tested positive for the virus have died. The Harvey County Health Department has been notified and recommends continuing with our outbreak and surveillance testing.

**December 11, 2020** – An essential health care worker and a non-direct care employee at Emporia Presbyterian Manor tested positive for COVID-19. The positive tests resulted from ongoing bi-weekly surveillance testing, which took place on Monday, December 7, and Wednesday, December 9. The employees last worked on December 6 and December 7, wearing personal protective equipment (PPE) while working and screening in before their shifts.

**December 11, 2020** – An essential health care worker and a non-direct care employee at Lawrence Presbyterian Manor tested positive for COVID-19 following testing on Monday, December 7, and Wednesday, December 9. The employees had not worked since November 23 and November 29, respectively. The individuals screened in prior to their last shift and wore personal protective equipment (PPE) while working. All other tests were negative.

**December 11, 2020** – Ongoing COVID-19 testing at Manor of the Plains identified two new cases of the virus this week. Both of the new cases are essential health care workers. The first employee last worked on Thursday, November 25. The second employee last worked Sunday, December 6. No additional cases were detected among residents and employees in testing Monday, December 7, or Wednesday, December 9.

**December 11, 2020** – One employee and one resident tested positive for COVID-19 this week at Parsons Presbyterian Manor. Parsons Presbyterian Manor is testing residents and staff twice a week. One health care resident tested positive in testing on Monday, December 7, and one essential health care worker tested positive in Thursday's testing. The employee is an essential health care worker who last worked December 3.

**December 10, 2020** – Parsons Presbyterian Manor received zero deficiencies on a focused infection control survey prompted by the COVID-19 cluster and outbreak at the community. The survey was conducted on behalf of the Centers for Medicare and Medicaid Services.

**December 10, 2020** – Two non-direct care employees at Farmington Presbyterian Manor tested positive for COVID-19. The employees last worked on December 9, screening in before their shifts and wearing personal protective equipment while at work. These were the only positive results from this round of testing.

**December 9, 2020** – Aberdeen Heights received zero deficiencies on a focused infection control survey at the community. The survey, conducted on behalf of the Centers for Medicare and Medicaid Services, was conducted in response to the community’s ongoing COVID-19 outbreak.

**December 9, 2020** – Fort Scott Presbyterian Village was pleased to announce that all residents and staff tested negative in the community’s latest round of weekly testing.

**December 9, 2020** – A Topeka Presbyterian Manor employee tested positive for COVID-19 following bi-weekly testing on Monday, December 7 and Tuesday, December 8. No residents tested positive. The employee last worked on November 7. They screened in prior to working and wore personal protective equipment (PPE) while in the building.

**December 8, 2020** – Newton Presbyterian Manor received its third consecutive zero-deficiency survey for infection control from the Centers for Medicare and Medicaid Services (CMS). Its last survey was November 17. The community had a zero deficiency survey in August during an outbreak at the campus as well.

**December 7, 2020** – Two employees and a resident of Aberdeen Village tested positive for COVID-19. An assisted living resident tested positive for the virus following testing on December 2. An essential health care worker tested positive for the virus following testing on Monday, November 30. The employee last worked on Tuesday, December 1, screening in before their shift and wearing personal protective equipment (PPE) while working.

A non-direct care employee also tested positive for the virus. The employee last worked on November 27, screening in before their shift and wearing personal protective equipment (PPE) while working. The test took place off campus and was not part of our ongoing surveillance testing. The employee notified us upon learning of the positive result.

**December 6, 2020** – At the end of COVID-19 testing for the week of November 30 through December 4, Aberdeen Heights reports that 8 residents and 3 employees tested positive last week. The new cases bring the 7-day total for the community to 11. In addition, six residents who previously tested positive for COVID-19 have died.

**December 6, 2020** – After two rounds of employee surveillance testing and one round of resident testing, Clay Center Presbyterian Manor detected only one new case of COVID-19 last week. The employee last worked December 1. The employee passed pre-shift screening and wore personal protective equipment as required. Testing to continue.

**December 6, 2020** – After a week with no new cases detected during employee surveillance testing, Wichita Presbyterian Manor had two employees test positive during surveillance testing November 30. Through contact tracing, one independent living resident has been identified as a possible close contact. Testing will continue.

**December 6, 2020** – One health care resident and three essential health care workers tested positive for COVID-19 at Newton Presbyterian Manor last week, and two residents who previously tested positive for the virus died at the community.

**December 6, 2020** - Ongoing COVID-19 testing at Manor of the Plains identified one new case of the virus. The employee is not involved in providing direct resident care. The case was identified with a rapid point-of-care test. No additional cases were detected among residents and employees in testing Monday, November 30, or Wednesday, December 2.

**December 4, 2020** – Two Salina Presbyterian Manor employees have tested positive for COVID-19 after two rounds of surveillance testing at the campus this week. The first employee, who last worked November 27, and the second employee last worked November 30. Six residents were identified as possible close contacts. The residents have been placed in isolation as a precaution pending COVID-19 testing next week.

**December 4, 2020** – Three residents and one employee tested positive for COVID-19 in the latest round of COVID-19 testing December 3 at Parsons Presbyterian Manor. We have notified the Labette County Health Department. This brings our total cases to 12 – 5 employees and 7 residents. Parsons Presbyterian Manor is considered a COVID-19 cluster, which means the senior living community has two or more non-household cases during a specified period of time. Testing will continue December 14.

**December 4, 2020** - Nine new cases of COVID-19 were identified through COVID-19 testing since November 27 at Arkansas City Presbyterian Manor, and five residents who tested positive for COVID-19 have died. All nine new cases were employees tested between November 27 and December 2. Two employees were identified through rapid point-of-care (POC) testing and seven were identified through employee surveillance testing. As of December 3, Arkansas City Presbyterian Manor no longer had any residents with active cases of COVID-19 on campus.

**December 4, 2020** – Four essential health care employees at Emporia Presbyterian Manor tested positive for COVID-19. One of the employees tested positive on November 27, which was also their last day worked. The second employee tested positive on November 29 at an off-campus location after experiencing symptoms. They last worked on November 25. The third employee tested positive on Monday, November 30, via rapid point-of-care (POC) testing after experiencing symptoms. Their last day worked was November 23. The final employee last worked on November 26, testing positive December 3 at an off-campus testing site.

**December 3, 2020** – A non-direct care employee at Lawrence Presbyterian Manor tested positive for COVID-19. The positive test resulted from our ongoing bi-weekly surveillance testing. The employee had not worked since November 23. The individual screened in prior to their last shift and wore personal protective equipment (PPE) while working. All other tests were negative.

**December 3, 2020** – A Rolla Presbyterian Manor resident who previously tested positive for COVID-19 passed away. Additionally, the community announced results from its latest round of

mass testing. A non-direct care employee tested positive as part of our ongoing surveillance testing. The employee last worked on November 24, screening in before their shift and wearing personal protective equipment while at work. This was the only positive result from this round of testing.

**December 3, 2020** – A Topeka Presbyterian Manor resident who previously tested positive for COVID-19 passed away at a local hospital. Additionally, the community announced results from its latest round of mass testing amid the outbreak. An Independent Living resident, two essential health care employees and a non-direct care employee tested positive for the virus. The resident was given a standard test after noticing symptoms consistent with COVID-19. The non-direct care employee was tested as part of our ongoing bi-weekly surveillance testing. The individual last worked on Tuesday, December 1. The essential health care employees last worked on Tuesday, December 1 and Wednesday, December 2. All positive employees screened in prior to working and wore personal protective equipment (PPE) while in the building.

**December 1, 2020** – At the end of COVID-19 testing for the week of November 23, Aberdeen Heights reports that 5 health care residents and 6 employees tested positive last week. The new cases bring the 7-day total for the community to 11, with 6 employees and 5 residents.

**December 1, 2020** - Four residents and four employees tested positive for COVID-19 over the weekend at Parsons Presbyterian Manor. Two essential health care workers tested positive on Saturday, November 28, via rapid point-of-care (POC) testing. The employees last worked on Friday, November 27, and Tuesday, November 24, screening in before their shifts and wearing personal protective equipment while at work. One health care resident tested positive November 28. The campus initiated testing for all residents and staff, and three additional health care residents and two additional staff members were identified. Testing will continue December 3.

**November 28, 2020** – All Aberdeen Village residents tested negative in the most recent round of ongoing testing, while two employees tested positive. An essential health care worker and a non-direct care employee tested positive for the virus via rapid point-of-care (POC) testing. The essential health care worker last worked on November 24. The non-direct care employee last worked on November 20. The individuals screened in before their shifts, wearing personal protective equipment (PPE) while working.

**November 27, 2020** – Topeka Presbyterian Manor lost an additional resident who previously tested positive for COVID-19, and more cases of COVID-19 were identified during this week's testing for the virus. The resident had been cared for by designated staff following Centers for Disease Control and Prevention (CDC) infection prevention protocols and physician's orders. The community continued to monitor residents for signs and symptoms of the virus. One health care resident tested positive for COVID-19 following testing which took place on Monday, November 23. The resident will be cared for in a designated area of the community by designated staff. In addition, two essential health care workers and one non-direct care

employee tested positive for the virus. The first essential health care worker last worked on November 20. The second essential health care worker last worked November 24. **November 25, 2020** – Arkansas City Presbyterian Manor received zero deficiencies on a focused infection control survey at the community November 25. The survey was conducted by the Centers for Medicare and Medicaid Services (CMS) and was prompted by the current COVID-19 outbreak.

**November 25, 2020** – A resident tested positive for COVID-19 at Fort Scott Presbyterian Village. The positive test resulted from Kansas Department of Health and Environment (KDHE) testing on November 20 following exposure from an employee who tested positive November 7. No other residents or employees were positive.

**November 25, 2020** - Farmington Presbyterian Manor announced that a non-direct care employee and a contract therapist tested positive for COVID-19. The non-direct care employee last worked November 23. The contract therapist last worked November 10. Both screened in before their shifts and wore personal protective equipment (PPE) while working.

**November 25, 2020** – One essential health care worker, two contract direct care providers and four residents have tested positive for COVID-19 at Newton Presbyterian Manor. In addition, 1 resident who previously tested positive for COVID-19 died at the community. All assisted living residents were negative for the virus. In the health care center, three new residents tested positive and one resident who tested positive with a rapid point-of-care test earlier in the week was confirmed positive. Two contract direct care providers tested positive and one employee who tested positive with a rapid POC test after showing signs and symptoms also was confirmed.

**November 25, 2020** – An essential health care employee, 4 health care residents, 1 assisted living resident and 2 independent living residents at Clay Center Presbyterian Manor have tested positive for COVID-19 this week. Residents were tested following a potential exposure when an employee tested positive for the virus last week. Residents in all levels of living and employee surveillance testing will continue Monday, November 30. Clay Center Presbyterian Manor is now considered a COVID-19 cluster. A cluster is two or more household cases of COVID-19 associated with a location during a specified period of time.

**November 25, 2020** – Eleven new cases of COVID-19 were identified through COVID-19 testing this week at Arkansas City Presbyterian Manor, and five residents who tested positive for COVID-19 have died. Two essential health care workers, one non-direct resident care employee and one health care resident tested positive with rapid point-of-care (POC) testing over the weekend. Four health care residents tested positive for COVID-19, and 3 employees tested positive for the virus November 23. One employee, who tested negative in both rounds of surveillance testing, was re-tested after starting to experience signs and symptoms of COVID-19 and tested positive November 24. The COVID-positive residents were placed in isolation to be cared for by designated employees according to CDC infection control and prevention protocols and physician's orders.

**November 25, 2020** – Rolla Presbyterian Manor lost four residents who previously tested positive for COVID-19, and two residents and two employees tested positive for the virus. The residents had been cared for in designated COVID-19 area and were cared for by designated staff who followed Centers for Disease Control and Prevention (CDC) infection prevention protocols and physician's orders. Additionally, two assisted living memory care residents and two essential health care workers tested positive for the virus. The first employee last worked November 23. The second employee last worked on November 18. Both employees passed pre-shift screening and wore personal protective equipment while at work.

**November 24, 2020** – With the COVID-19 pandemic continuing to affect our region, Aberdeen Heights reports that 8 health care residents, 2 independent living residents and 1 employee tested positive in testing late last week. The new cases bring the 7-day total for the community to 19, with 6 employees and 13 residents. Testing will continue.

**November 23, 2020** – Topeka Presbyterian Manor received its second zero-deficiency focused infection control survey from the Centers for Medicare and Medicaid Services (CMS) during its ongoing COVID-19 outbreak. It was the community's second zero-deficiency focused infection control survey in 20 days.

**November 23, 2020** – Arkansas City Presbyterian Manor received zero deficiencies on a focused infection control survey prompted by their current COVID-19 cluster and outbreak. The survey was conducted on behalf of the Centers for Medicare and Medicaid Services (CMS).

**November 21, 2020** – Three essential health care workers, one non-direct care employee and seven residents have tested positive for COVID-19 at Newton Presbyterian Manor. The seven health care residents have been placed in COVID-19 isolation and are being care for by designated staff, who are following Centers for Disease Control and Prevention infection control protocols and physician's orders. All four employees tested negative in surveillance testing on November 16. They each passed their pre-shift screenings and wore personal protective equipment as required.

**November 20, 2020** – Wichita Presbyterian Manor’s surveillance testing on Wednesday, November 18, identified two new cases of COVID-19. Both COVID-positive employees are essential health care workers. Testing will continue.

**November 20, 2020** – Two new positive cases of COVID-19 were revealed in the latest round of employee testing at Arkansas City Presbyterian Manor. The community also lost two more residents who previously tested positive for the virus this week. One essential health care worker tested positive November 18, and the other tested positive November 20.

**November 19, 2020** – Four residents passed away at Topeka Presbyterian Manor. The community continued to monitor residents for signs and symptoms of COVID-19 on each shift and cared for those residents who are positive in the COVID-19 isolation area. The community also tested 137 residents and employees as part of our ongoing outbreak testing. Test results revealed 3 new positive tests. Of the positives, 1 was a resident and 2 were staff.

**November 19, 2020** – Farmington Presbyterian Manor announced that one essential health care worker tested positive for the virus. On Monday, November 16, we tested 100 residents and 106 staff members. On Wednesday, November 18, we tested staff a second time. This essential health care employee was the only positive case among residents and staff. The essential health care employee last worked Tuesday, November 17. The individual screened in and wore personal protective equipment while working.

**November 19, 2020** – Manor of the Plains reports confirmation of one positive resident and one positive essential health care worker. The employee, who has been asymptomatic, last worked Wednesday. A health care resident tested positive with a rapid point-of-care test on Sunday, November 15. That result was confirmed with the receipt of Monday’s test results. The resident was placed in COVID-19 isolation to be cared for by designated staff members.

**November 19, 2020** – Through another round of outbreak testing at Aberdeen Heights, the community has identified nine new cases of COVID-19. Five employees, one contract service provider and three skilled nursing residents were identified as positive for COVID-19. One additional skilled nursing resident tested positive on Monday with a point of care test after exhibiting signs and symptoms of the virus.

**November 18, 2020** – Through rapid POC testing, Arkansas City Presbyterian Manor has identified 6 health care residents and 2 employees with COVID-19 since November 12. The campus tested 106 staff and health care residents on Monday, November 16. An additional 7 employees and 4 residents tested positive for the virus. The four newly diagnosed residents have been placed in COVID-19 isolation. Of the newly diagnosed employees, six are essential health care workers and one is a non-direct resident care worker.

**November 18, 2020** – One essential health care worker has tested positive for COVID-19 at Newton Presbyterian Manor this week, and one additional resident has succumbed to the

disease. The employee last worked November 17 in health care. The employee passed pre-shift screening and wore personal protective equipment as required.

**November 18, 2020** – Wichita Presbyterian Manor’s surveillance testing on Monday, November 16, identified two new cases of COVID-19. One employee is a non-direct resident care employee who last worked November 12. The employee has been self-quarantining because a close contact had tested positive for the virus. The second employee is an essential healthcare worker who last worked November 17 in assisted living. Testing will continue.

**November 18, 2020** – Three assisted living residents and an essential health care worker tested positive for COVID-19 at Fort Scott Presbyterian Village. Additionally, two previously positive employees who no longer had symptoms of the virus continued to test positive. We tested all residents and employees through the Kansas Department of Health and Environment following exposure from an employee who tested positive November 7. All other tests came back negative. The residents remained in their individual apartments, recovering under the care of designated staff. The essential health care worker last worked November 13 and screened in before their shift, wearing personal protective equipment (PPE) at all times.

**November 18, 2020** – An essential health care worker at Emporia Presbyterian Manor tested for COVID-19. The community tested 88 staff members via rapid point-of-care (POC) testing. All results came back negative. Additionally, 38 health care residents were tested on Monday. Those results were also negative.

**November 18, 2020** – A non-direct resident care employee at Clay Center Presbyterian Manor has tested positive for COVID-19 this week. The Clay County Health Department and Kansas Department of Health and Environment have been notified. All health care residents will be tested again next week, and employee surveillance testing will continue as required.

**November 17, 2020** – Newton Presbyterian Manor received its second consecutive zero deficiency focused infection control survey by the Centers for Medicare and Medicaid Services related to its ongoing COVID-19 outbreak. The community had no deficiencies on a focused infection control survey conducted in August during a previous COVID-19 outbreak.

**November 17, 2020** - Five health care residents have tested positive for COVID-19 at Newton Presbyterian Manor. Four residents tested positive in mass testing conducted November 12. One additional resident tested positive with a rapid point-of-care test on Sunday, November 15, after exhibiting signs and symptoms of the virus. All five residents have been moved to the COVID-19 isolation area to be cared for by designated staff. No new cases were revealed in employee surveillance testing Wednesday, November 11.

**November 17, 2020** - Three residents who previously tested positive for COVID-19 have died at Newton Presbyterian Manor. The residents were being cared for by designated employees in a special isolation area for COVID-19 positive residents. COVID-positive residents are cared for

according to Centers for Disease Control and Prevention (CDC) guidelines for transmission-based infection prevention protocols and physician's orders.

**November 15, 2020** – Rolla Presbyterian Manor lost a resident who previously tested positive for COVID-19. The resident had been cared for by designated staff in a special area designated for COVID-19 positive residents. COVID-positive residents are cared for according to Centers for Disease Control and Prevention (CDC) guidelines for transmission-based infection prevention protocols and physician's orders.

**November 15, 2020** – Aberdeen Heights announced that 7 health care residents are positive for the virus. 37 residents were tested as part of ongoing outbreak testing. The residents were placed in COVID-19 isolation to be cared for by designated staff.

**November 14, 2020** – Rolla Presbyterian Manor received word that two assisted living/memory care residents tested positive for the virus. The residents were given rapid point-of-care (POC) tests after noticing symptoms consistent with COVID-19.

**November 14, 2020** – Wichita Presbyterian Manor's surveillance testing on Wednesday, November 11, identified another case of COVID-19. Through contact tracing, three independent living residents have been identified as possibly being exposed to the COVID-positive employee.

**November 13, 2020** – Farmington Presbyterian Manor announced that two essential health care workers, one non-direct care employee and one health care resident tested positive for the virus. One essential health care employee last worked Wednesday, November 11. The other essential health care employee was last at work on Friday, November 6. The non-direct care employee last worked Wednesday, November 11. All screened in and wore personal protective equipment while working.

**November 13, 2020** – After two weeks with no new cases identified at the senior living community, Aberdeen Heights has uncovered four new cases of COVID-19 through surveillance and independent testing this week. Due to the potential exposures throughout the health care center, the campus followed the recommendation of its medical director, Dr. Alka Kapoor. All 37 residents in The Glen at Aberdeen Heights were tested Friday, November 13, for COVID-19.

**November 13, 2020** – Three non-direct care employees and two direct care employees at Aberdeen Village tested positive following mass testing, which took place on Tuesday, November 10. Two of the employees had already been off due to suspected COVID-19 exposure. The others will self-quarantine. All wore personal protective equipment during their last shift. Results from resident testing revealed two assisted living residents and two health care residents tested positive in mass testing conducted Monday, November 9, due to the COVID-19 outbreaks in those neighborhoods.

**November 13, 2020** – Topeka Presbyterian Manor lost two more residents who previously tested positive for COVID-19. The residents had been cared for by designated staff in a special area designated for COVID-19 positive residents. COVID-positive residents are cared for according to Centers for Disease Control and Prevention (CDC) guidelines for transmission-based infection prevention protocols and physician's orders.

**November 13, 2020** – A resident who previously tested positive for COVID-19 died at Rolla Presbyterian Manor. The resident was being cared for by designated employees in a special isolation area for COVID-19 positive residents. COVID-positive residents are cared for according to Centers for Disease Control and Prevention (CDC) guidelines for transmission-based infection prevention protocols and physician's orders.

**November 13, 2020** – Two employees have tested positive for COVID-19 at Manor of the Plains. Nearly 1 in 3 people tested for COVID-19 in Ford County test positive for the virus. One employee is a non-direct resident care employee who last worked November 12. The other employee is an essential health care worker who has not worked in nearly a month and was testing to be able to return to work this weekend. Both employees will quarantine at home until cleared to return to work.

**November 12, 2020** – Three employees and three residents have tested positive for COVID-19 at Newton Presbyterian Manor this week. Two health care memory care residents received rapid point-of-care tests at the community, one Monday and one Tuesday, after exhibiting signs and symptoms of COVID-19. One resident in assisted living memory care tested positive in mass testing completed Monday, November 9. The residents were moved to the designated COVID-19 isolation area to be cared for by designated staff.

**November 12, 2020** – A Topeka Presbyterian Manor resident who previously tested positive for COVID-19 died. The resident had been cared for by designated staff in a special area designated for COVID-19 positive residents. COVID-positive residents are cared for according to Centers for Disease Control and Prevention (CDC) guidelines for transmission-based infection prevention protocols and physician's orders.

**November 12, 2020** – Three direct care employees and one resident have tested positive at Wichita Presbyterian Manor. The first employee last worked November 10 in health care. The second employee last worked November 9 in memory care. The third employee last worked November 8 in PATH. All three passed pre-shift screening and wore personal protective equipment (PPE) as required. The resident has been placed in isolation and is being cared for by designated staff. Testing continues.

**November 12, 2020** – On Monday, November 9, Topeka Presbyterian Manor tested 164 employees and residents. This round of testing has revealed 4 staff members, and an agency contract caregiver and 4 health care residents to be positive for the virus. In addition, three health care residents tested positive via rapid point-of-care (POC) test after exhibiting signs and

symptoms of the virus. On Tuesday, November 10, we notified families of three health care residents, one essential health care worker and one non-direct care employee who tested positive. At that time, several results were pending from Monday's round of testing. Since that time, we learned of a non-direct care employee and one essential health care worker and an agency contract caregiver who were positive. The COVID-positive employees last worked on dates ranging November 10, 9 and 6. All screened in before their shifts and wore personal protective equipment.

**November 12, 2020** – A Salina Presbyterian Manor resident has tested positive for COVID-19 in continued outbreak testing at the senior living community. The resident, who lives in the PATH® (Post-Acute to Home) area, previously tested negative for the virus in last week's mass testing. Testing will continue.

**November 12, 2020** – An essential health care worker and a non-direct resident care employee at Clay Center Presbyterian Manor have tested positive for COVID-19. These cases of COVID-19 were detected during Centers for Medicare and Medicaid Services (CMS) mandated surveillance testing of our employees. The Clay County Health Department has recommended testing all health care residents and monitoring all residents for signs and symptoms of COVID-19.

**November 12, 2020** – One direct-care employee and one non-direct care employee tested positive for COVID-19 at Lawrence Presbyterian Manor. Additionally, a contract therapist tested positive. The direct-care employee last worked November 9 and screened in before their shift, wearing personal protective equipment (PPE) at all times. The contract therapist worked this morning and was sent home upon learning of the positive result. They screened in and wore PPE. The non-direct care employee last worked Wednesday, November 11. They screened in before their shift, wearing PPE while working. These were the first positive COVID-19 tests at the community in several months.

**November 12, 2020** - Through rapid POC testing, Arkansas City Presbyterian Manor has identified 10 health care residents and two employees with COVID-19 since November 6. On November 7, an additional 6 employees, 7 residents and 1 contract service provider tested positive for the virus. The seven newly diagnosed residents were asymptomatic. Of the newly diagnosed employees, five are essential health care workers and one is a non-direct resident care worker. The two employees previously diagnosed with rapid POC tests also were essential health care workers.

**November 11, 2020** – Three employees tested positive for COVID-19 at Emporia Presbyterian Manor. The two essential health care workers and a non-direct care staff member passed pre-shift screening and wore personal protective equipment (PPE) as required when last at work. The non-direct care employee and one of the essential health care employees last worked November 10. The second essential health care employee last worked on November 1. In addition, one resident was confirmed positive for COVID-19 after testing positive via rapid

point-of-care testing on November 9. That test was confirmed when we received the results of surveillance and outbreak testing at our campus. One additional essential health care worker, who reported signs or symptoms of COVID-19, tested positive for COVID-19 in rapid point-of-care testing. The employee last worked Friday, November 6, passing pre-shift screening and wearing PPE as required.

**November 11, 2020** – Rolla Presbyterian Manor tested 38 residents and 64 employees on Monday, November 9, as part of ongoing surveillance and outbreak testing. Testing confirmed positive results for three employees and eight residents who previously tested positive via rapid point-of-care (POC) testing. Additionally, it revealed five residents and five employees who had not previously been identified. The employees passed pre-shift screening and wore personal protective equipment as required during their last shifts. They last worked on various dates ranging November 10, 9, 4 and 3.

**November 11, 2020** – Two additional Arkansas City Presbyterian Manor residents who previously tested positive for COVID-19 have died. Arkansas City Presbyterian Manor will continue to work with the Cowley County Health Department and the Kansas Department of Health and Environment (KDHE) to stop the outbreak.

**November 11, 2020** – A second resident who previously tested positive for COVID-19 died at Topeka Presbyterian Manor. The resident had been cared for by designated staff in a special area designated for COVID-19 positive residents. COVID-positive residents are cared for according to Centers for Disease Control and Prevention (CDC) guidelines for transmission-based infection prevention protocols and physician's orders.

**November 10, 2020** – A resident who previously tested positive for COVID-19 died at Topeka Presbyterian Manor. The resident was being cared for by designated employees in a special isolation area for COVID-19 positive residents. COVID-positive residents are cared for according to Centers for Disease Control and Prevention (CDC) guidelines for transmission-based infection prevention protocols and physician's orders.

**November 9, 2020** – A resident who previously tested positive for COVID-19 at Salina Presbyterian Manor died. The resident had been cared for in the designated COVID-19 isolation area according to CDC infection prevention and control protocols and physician's orders.

**November 9, 2020** – A rapid point-of-care (POC) test uncovered a positive case of COVID-19 at Fort Scott Presbyterian Village. The case involved an essential health care worker who last worked on Wednesday, November 4. The employee passed the pre-shift screening and wore personal protective equipment (PPE) as required. The employee reported experiencing signs and symptoms and was administered a rapid POC test, which was positive.

**November 8, 2020** – A resident and two direct-care employees at Emporia Presbyterian Manor tested positive for COVID-19. Friday, November 6, we learned that one of our residents tested positive for the virus. While this was confirmed by our ongoing testing, which last took place on Wednesday, November 4, it was also confirmed by a local hospital, where the resident was taken Thursday night, due to a medical situation.

The resident, who lives in independent living, had been in isolation in our health care center following a prior hospitalization and was tested on Wednesday as part of our ongoing testing process. Thursday night, November 5, the individual returned to the hospital for medical attention. They notified us of the positive COVID-19 test. Shortly after, the results of the Wednesday test also came back positive. One employee tested positive at a local clinic after not feeling well. The individual last worked Thursday, November 5, and wore personal protective equipment (PPE) after screening in before their scheduled shift. The second employee last worked Friday, November 6. The employee passed pre-shift screening and wore PPE as required. The employee began to experience symptoms on Saturday and was administered a rapid point-of-care test on Sunday. The test result was positive.

**November 8, 2020** – Following COVID-19 testing for employees and residents late last week, Newton Presbyterian Manor has learned 4 employees and 4 residents are positive for the virus. Three of the four are essential health care workers and one is a non-direct care employee. With all the results in, three health care memory care residents have tested positive for COVID-19.

**November 7, 2020** – Two Salina Presbyterian Manor employees have tested positive for COVID-19. The Saline County Health Department recommended continuing with mass testing.

**November 6, 2020** -Seven residents of Aberdeen Village and three employees of the community tested positive for COVID-19. On Monday, November 2, we tested all assisted living and health care residents and employees on our campus. Seven residents tested positive. One was a health care resident. The other six residents were assisted living. Additionally, three non-direct resident care employees were positive for the virus.

**November 6, 2020** – Arkansas City Presbyterian Manor has identified 7 new cases and confirmed 3 rapid point-of-care tests in COVID-19 testing this week. In addition, another health care resident tested positive for the virus with a rapid test administered at the campus. The residents who tested positive are in isolation.

**November 5, 2020** - Rolla Presbyterian Manor received word that four residents and three employees tested positive for COVID-19. These test results were from follow-up testing related to positive cases that originated on October 27. In all, five total residents and four total staff had tested positive since that date.

**November 5, 2020** – Topeka Presbyterian Manor tested 170 residents and learned of 22 total positive tests. Of the positives, 14 were residents, 6 were employees, 1 was a contract employee and 1 was a confirmed test for an employee that previously tested positive via point-

of-care (POC) testing. This brought the total number of positive tests to 43 during the outbreak. 25 were residents, 18 were staff members, including 3 which were contract employees.

**November 5, 2020** - Wichita Presbyterian Manor learned three employees are positive for COVID-19 during a round of employee surveillance testing Monday, November 2. In addition, 45 health care and Post-Acute-to-Home (PATH) residents were tested due to an exposure to a third-party service provider who tested positive last week. All 45 residents were negative for COVID-19.

**November 5, 2020** – Three Manor of the Plains employees tested positive for COVID-19. One employee is a non-direct resident care employee and the second provides direct resident care but had not worked since October 15. Another employee also tested positive with a rapid point-of-care test, which was confirmed with testing November 4. Testing to continue.

**November 5, 2020** - Newton Presbyterian Manor's twice weekly surveillance testing has uncovered 3 new COVID-positive employees and confirmed the diagnosis of a fourth employee, whose rapid test was positive earlier in the week. Three of the four employees work in the health care center, and one employee works in assisted living memory care. Residents in assisted living memory care are tested for COVID-19 as a precaution.

**November 23, 2020** – Topeka Presbyterian Manor received a zero-deficiency focused infection control survey from the Centers for Medicare and Medicaid Services (CMS) during its ongoing COVID-19 outbreak.

**November 3, 2020** – Two more Emporia Presbyterian Manor employees tested for COVID-19 in surveillance testing at the community. 96 employees and 13 residents were tested for COVID-19. All 13 residents were negative. One direct care employee and one non-direct care employee tested positive. The direct care employee last worked Saturday, October 31, in memory care and passed the employee screening. The second employee last worked Thursday, October 29, and passed pre-shift screening. Both employees wore personal protective equipment as required.

**November 2, 2020** - Newton Presbyterian Manor announces that three residents and a direct-care employee have tested positive for COVID-19. The Harvey County Health Department has been notified and residents in the health care center will be retested later this week.

**November 2, 2020** – A resident who previously tested positive for COVID-19 has died at Arkansas City Presbyterian Manor, and another health care resident has tested positive for the virus. The Cowley County Health Department has been notified and recommends testing of all health care residents. The Cowley County Health Department has again determined we have a

COVID-19 cluster. A cluster is two or more non-household cases of COVID-19 associated with a location during a specified period of time.

**November 2, 2020** – Five employees at Salina Presbyterian Manor test positive for COVID-19 in employee surveillance testing October 30. The Saline County Health Department recommends testing all residents and staff November 4.

**October 31, 2020** – Two Manor of the Plains employees tested positive for COVID-19. The first employee, who provides direct resident care, has not worked since October 15. The employee took a vacation and quarantined for two weeks upon their return. The employee participated in surveillance testing in order to be cleared to return to work. Their test was positive. The second employee is a non-direct resident care employee who last worked October 31 and tested positive with a rapid point-of-care test November 1.

**October 30, 2020** - After a second round of outbreak testing for COVID-19 at Topeka Presbyterian Manor, the senior living community learned six additional residents and three additional caregivers were positive for the virus. On Tuesday, October 27, a health care resident tested positive with a rapid point-of-care test after experiencing signs or symptoms consistent with COVID-19. The resident was administered a standard COVID- 19 test to confirm the diagnosis on Wednesday. The results of the standard test also are positive. The senior living community conducted mass testing in assisted living and health care and tested all employees and contract service providers on Wednesday, October 28. Results received October 29 revealed 2 additional health care residents and 3 assisted living residents, 1 essential health care worker and 2 contract health care workers tested positive.

**October 29, 2020** – Three Emporia Presbyterian Manor employees tested for COVID-19. The two employees who tested positive the previous day were tested on Tuesday, October 27, as part of ongoing surveillance testing. The third employee was unavailable for surveillance testing due to a family situation.

**October 29, 2020** - Rolla Presbyterian Manor received word that a direct care employee tested positive for COVID- 19 as part of ongoing surveillance testing.

The individual last worked on Tuesday, October 27. The staff member screened in before their shift and wore personal protective equipment (PPE) while working.

The employee was tested on October 27 as part of ongoing surveillance testing. They began to notice symptoms on Wednesday, October 28 and sought testing at that time, which was negative. However, the results of the October 27 test came back, and the employee was positive.

**October 29, 2020** - Two essential health care workers and one non-direct resident care employee tested positive for COVID-19 at Manor of the Plains. The health department

recommended discontinuing dining and group activities and monitoring residents for signs and symptoms of COVID-19.

**October 29, 2020** – An essential health care worker at Clay Center Presbyterian Manor tested positive for COVID-19. This case of COVID-19 was detected during Centers for Medicare and Medicaid Services (CMS) mandated surveillance testing of employees. The Clay County Health Department recommended testing assisted living residents with direct contact with the employee and monitoring all residents for signs and symptoms of COVID-19.

**October 28, 2020** – Farmington Presbyterian Manor received word that an employee and a third-party contractor tested positive for COVID-19. The employee and contractor were administered rapid point-of-care tests on-site on Tuesday, October 27, which were positive. The St. Francois Health Department was notified. Weekly mass testing of residents and employees will continue.

**October 28, 2020** – Two residents of Aberdeen Village and four employees of the community tested positive for COVID-19. An assisted living resident was transported to a local hospital, where a COVID-19 test was administered. That test result was positive. The Johnson County Health Department was notified. Health care and assisted living resident testing schedules were set at the health department's direction.

**October 28, 2020** – Two health care residents were confirmed positive for COVID-19 at Arkansas City Presbyterian Manor after testing positive earlier in the week with rapid point-of-care tests at the community. The Cowley County Health Department was notified. Another round of testing was set to be conducted for health care residents the following week.

**October 28, 2020** - In ongoing surveillance testing at Newton Presbyterian Manor, four essential health care workers tested positive for COVID-19 in testing October 26. Two of the employees last worked on Tuesday, October 27 and two last worked October 28. All four passed pre-shift screening and wore personal protective equipment as required. The Harvey County Health Department has been notified and recommends testing all health care residents.

**October 27, 2020** – Two health care residents and one non-direct care employee tested positive for COVID-19 following the Salina Presbyterian Manor's routine employee surveillance testing and resident testing for the virus. The residents were placed in isolation and the employee quarantined at home. The Saline County Health Department recommends weekly testing of residents and staff.

**October 26, 2020** – Two essential health care worker at Arkansas City Presbyterian Manor tested positive for COVID-19. Both employees tested positive with rapid point-of-care tests on

Thursday, October 22. The positive cases were reported to the Cowley County Health Department. The health department recommended testing all health care residents.

**October 23, 2020** –Topeka Presbyterian Manor received news of 4 additional COVID-positive residents and 6 additional COVID-positive employees after testing staff and health care residents on October 23. Two of the employees were not involved in providing direct resident care and 4 were direct care employees in health care or assisted living. Due to the number of cases, the campus was considered a COVID-19 cluster.

**October 23, 2020** – Aberdeen Heights learned two non-direct resident care employees and one health care resident tested positive for the virus. Resident testing was scheduled per physician's orders.

**October 22, 2020** – An essential health care worker and a resident at Topeka Presbyterian Manor tested positive for COVID-19. As a precaution, the residents in the area where the employee last worked were placed in isolation and employees who had direct contact with the COVID-positive employee were placed in quarantine. The resident was administered a rapid point-of-care test on-site, which was positive. The Shawnee County Health Department and the Kansas Department of Health and Environment (KDHE) Epidemiology Hotline were notified. The health department recommended contact tracing and testing all employees and health care residents.

**October 22, 2020** – Continued weekly testing of health care residents at Aberdeen Village identified two more cases of COVID-19 among the residents. The Johnson County Health Department and Kansas Department of Health and Environment (KDHE) Epidemiology Hotline were notified. The health department recommended testing all health care residents weekly until 2 rounds of negative tests occur.

**October 15, 2020** – A Memory Care resident of Aberdeen Village tested positive for COVID-19. The resident was tested along with 143 other residents on Monday, October 12. All other tests were negative. The Johnson County Health Department and Kansas Department of Health and Environment (KDHE) Epidemiology Hotline were notified and recommended testing residents once per week over a period of two weeks, beginning on October 19.

**October 15, 2020** –Farmington Presbyterian Manor received new testing results from mass testing occurring on October 12. Of the residents tested, 107 tests were negative and 4 tests

were positive. The COVID-positive residents were moved to the COVID-19 isolation area and were being cared for by staff. Of the employee tests, 117 were negative and 4 were positive. The St. Francois County Health Department was notified and recommended continuing with the current testing strategy.

**October 14, 2020** – Manor of the Plains identified two more employees who tested positive for COVID-19 through the campus' ongoing surveillance testing. The Kansas Department of Health and Environment (KDHE) epidemiology hotline and Ford County Health Department were notified immediately. They did not recommend any additional testing other than the regular surveillance testing already taking place.

**October 9, 2020** – Two health care residents and a direct resident care employee at Farmington Presbyterian Manor tested positive for COVID-19. The positive tests resulted from ongoing testing at our community of both employees and staff. The St. Francois County Health Department was notified. Testing to continue as planned.

**October 7, 2020** – Aberdeen Heights announced that a part-time non-direct care employee tested positive for COVID-19. The positive test was due to the employee noticing symptoms and was not part of ongoing surveillance at the community. The St. Louis County Health Department was notified and relied upon for further direction.

**October 7, 2020** – A non-direct care employee of Aberdeen Village tested positive for COVID-19. The Johnson County Health Department and Kansas Department of Health and Environment (KDHE) Epidemiology Hotline were notified and recommended testing all health care residents once per week over a period of two weeks, beginning on October 12. The community followed their recommendations.

**October 7, 2020** – Manor of the Plains announced a non-direct resident care employee tested positive for COVID-19. Kansas Department of Health and Environment (KDHE) epidemiology hotline and Ford County Health Department were notified immediately. They did not recommend any additional testing other than the regular surveillance testing already taking place.

**October 7, 2020** – Surveillance testing at Wichita Presbyterian Manor October 5 revealed a new case of COVID-19 at the campus. The employee, who works in independent living, had passed

pre-shift screening and was not experiencing signs or symptoms of COVID-19. Through contact tracing, we determined that 1 additional non-direct care employee and 11 residents may have been exposed. The residents were asked to self-isolate and seek COVID-19 testing in 5 to 7 days.

**October 7, 2020** – A Salina Presbyterian Manor essential health care worker tested positive for COVID-19 during the campus' routine employee surveillance testing for the virus. The Saline County Health Department was notified. Testing to continue as scheduled.

**October 6, 2020** – Aberdeen Heights learned that an essential health care employee tested positive for COVID-19. The St. Louis County Health Department was notified. The campus will continue with employee surveillance testing as required by the Centers for Medicare and Medicaid Services.

**October 2, 2020** – Three direct resident care employees and one non-direct care employee at Farmington Presbyterian Manor tested positive for COVID-19. St. Francois County Health Department was notified. Weekly testing to continue for residents and staff.

**October 1, 2020** – Two additional cases of COVID-19 were identified at Arkansas City Presbyterian Manor through mass testing in memory care and employee surveillance testing. One resident of memory care and one essential health care worker who last worked September 30 in memory care tested positive for COVID-19. The Cowley County Health Department was notified. Testing to continue.

**September 30, 2020** – One Aberdeen Village health care resident tested positive for COVID-19. The health department was notified and recommended testing all health care residents October 5. Testing was set to continue until 2 rounds of negative tests occur.

**September 30, 2020** – A non-direct resident care employee at Manor of the Plains tested positive for COVID-19. The Kansas Department of Health and Environment (KDHE) epidemiology hotline and Ford County Health Department were notified.

**September 29, 2020** – One direct resident care employee and one non-direct resident care employee tested positive for COVID-19 at Farmington Presbyterian Manor. The St. Francois County Health Department was notified of the new positive tests. Testing to continue.

**September 28, 2020** – One Manor of the Plains assisted living resident tested positive for COVID-19. Testing to continue at the campus.

**September 25, 2020** – Following a contract direct care health care worker testing positive for COVID-19 on September 16, two Aberdeen Village memory care residents and a contract health care provider tested positive for the virus. The Johnson County Health Department and Kansas Department of Health and Environment (KDHE) Epidemiology Hotline were notified of the test results. These positive tests meant Aberdeen Village was officially designated as a COVID-19 cluster.

**September 25, 2020** – An independent living resident at Aberdeen Heights tested positive for COVID-19. The resident self-isolated in their apartment. The community will continue to cooperate with the St. Louis County Health Department and any guidance they provide.

**September 25, 2020** – Arkansas City Presbyterian Manor tested all residents and employees for COVID-19 and received word of three additional cases of the virus. A second essential health care employee, who sought testing independently after learning of an exposure by a close contact, also tested positive. Due to the number of cases in memory care and both employees and residents testing positive, Presbyterian Manor was officially considered to have a COVID-19 cluster in memory care. The Cowley County Health Department was notified. Another round of testing was scheduled.

**September 23, 2020** - Wichita Presbyterian Manor learned two essential health care workers are positive for COVID-19 following surveillance testing for the virus at the campus earlier in the week. Families, residents and employees were notified regarding the positive employees. The county health department affirmed the campus' plan to test residents who had potential exposure on September 28.

**September 22, 2020** - An employee at Rolla Presbyterian Manor tested positive for COVID-19. The employee notified the community that several close contacts had tested positive, and when the employee began to show signs and symptoms, they asked to be tested for COVID-19. The Phelps County Health Department was notified of the positive case.

**September 21, 2020** - Arkansas City Presbyterian Manor announced that two memory care residents tested positive for COVID-19. The community conducted contact tracing and have notified the Cowley County Health Department and the Kansas Department of Health and Environment (KDHE) Epidemiology Hotline. Testing to continue.

**September 20, 2020** – A third essential health care worker at Farmington Presbyterian Manor tested positive for COVID-19. The employee’s surveillance test September 15 was negative, however, the employee began to experience symptoms of COVID-19 and sought testing.

**September 19, 2020** – A second essential health care worker at Farmington Presbyterian Manor tested positive for COVID-19 in the community’s surveillance testing for the virus September 15. Residents will be tested September 21 and employee surveillance testing will be conducted as planned.

**September 18, 2020** - After its third round of surveillance testing, Manor of the Plains identified three cases of COVID-19 among 3 direct-care staff and 1 COVID-positive resident. The Kansas Department of Health and Environment (KDHE) Epidemiology Hotline and Ford County Health Department were notified and recommended mass testing of all residents the following week, coordinated with the community’s surveillance testing dates.

**September 18, 2020** - A second essential health care worker at Arkansas City Presbyterian Manor tested positive for COVID-19 in the community’s surveillance testing for the virus September 15. The Cowley County Health Department was notified. The health department recommended testing memory care residents.

**September 18, 2020** – Farmington Presbyterian Manor learned an essential health care worker who last worked September 8 tested positive for COVID-19 in employee surveillance screening.

**September 17, 2020** – The Centers for Medicare and Medicaid Services (CMS) issued new guidance on in-person indoor and outdoor visitation at skilled nursing facilities.

**September 17, 2020** - Topeka Presbyterian Manor announced that a third party, non-direct resident care contractor tested positive for COVID-19. The Shawnee County Health Department and the Kansas Department of Health and Environment (KDHE) Epidemiology Hotline were notified. The employee had no resident contact and no additional testing was recommended.

**September 17, 2020** - In its second week of surveillance testing, Aberdeen Village discovered two positive cases of COVID-19. These case of COVID-19 were detected during Centers for Medicare and Medicaid Services (CMS) mandated surveillance testing of employees conducted September 15, bringing the 7-day total for cases to 2 employees and 1 contracted health care provider. The Johnson County Health Department and Kansas Department of Health and Environment (KDHE) Epidemiology Hotline were notified. The health department recommended placing the residents in memory care and the health care neighborhoods where the contractor worked in quarantine and testing the residents in five days and again a week later to ensure sufficient viral load for testing accuracy.

**September 16, 2020** - Farmington Presbyterian Manor announced that an essential healthcare employee tested positive for the virus. The St. Francois County Health Department recommended testing all health care residents on September 17, and again four days later. The employee who tested positive is recovering outside of the community.

**September 16, 2020** - Two independent living residents tested positive for COVID-19 at Arkansas City Presbyterian Manor after a potential exposure off-campus. The health department recommended testing all independent living and assisted living residents for COVID-19 during the next round of employee surveillance testing.

**September 16, 2020** - A Heart & Soul Hospice of Wichita direct-patient care employee tested positive for COVID-19. The employee quarantined at home. The hospice notified the Sedgwick County Health Department and performed contact tracing to determine who the employee had contact with during the last shift worked. Patients and their family members were notified of the positive test.

**September 15, 2020** – Aberdeen Heights learned that an independent living resident has tested positive for COVID-19. The resident and the resident’s spouse self-quarantined after learning they had been exposed by a close contact who they had recently visited.

**September 14, 2020** - Parsons Presbyterian Manor’s COVID-19 outbreak was closed, according to the Labette County Health Department. With no new cases identified at the community since August 16, two full incubation periods passed with no new positive cases of COVID-19.

**September 12, 2020** - An essential health care worker at Arkansas City Presbyterian Manor tested positive for COVID-19 in the community’s first round of surveillance testing for the virus. The residents in the health care center were placed in isolation and employees took COVID-19 precautions.

**September 11, 2020** - Wichita Presbyterian Manor announced that a direct resident care employee tested positive for COVID-19. This case of COVID-19 was detected during Centers for Medicare and Medicaid Services (CMS) mandated surveillance testing of employees. Contact tracing determined that the employee had contact with several residents and one other employee during their shift. The Sedgwick County Health Department recommended testing those in the neighborhood where the employee worked.

**September 11, 2020** - An essential health care worker who last worked September 8 tested positive for COVID-19 at Fort Scott Presbyterian Village. The Bourbon County Health Department was notified and recommended isolating the resident for 14 days and monitoring for symptoms. No additional testing was recommended.

**September 10, 2020** - Aberdeen Village discovered a non-direct care employee was positive for COVID-19 after starting regular surveillance testing of employees at the community. This case of COVID19 was detected during Centers for Medicare and Medicaid Services (CMS) mandated surveillance testing of employees. The Johnson County Health Department did not recommend

additional testing since the employee did not have direct contact with any other employees during their shift.

**September 8, 2020** - Heart & Soul Hospice of Farmington learned September 8 that a direct-patient care employee tested positive for COVID-19. The hospice acted swiftly to notify the St. Francois County Health Department and perform contact tracing to determine who the employee had contact with during their last shifts worked. Patients and their family members were notified of the positive test.

**September 8, 2020** – PMMA’s communities began their first round of employee surveillance testing mandated by the Centers for Medicare and Medicaid Services (CMS) for all skilled nursing facilities. Surveillance testing requires all employees, agency employees, volunteers, hospice, lab and therapy providers at a campus to be tested on a frequency determined by that county’s COVID-19 testing positivity rate.

**September 7, 2020** - Newton Presbyterian Manor announced that a non-direct resident care employee tested positive for COVID-19. Contact tracing determined that the employee did not have direct contact with any residents or employees during their shift, during which personal protective equipment (PPE) was worn.

**September 4, 2020** - Topeka Presbyterian Manor announced that a non-direct resident care employee tested positive for COVID-19. The Shawnee County Health Department and the Kansas Department of Health and Environment (KDHE) Epidemiology Hotline were notified.

**September 4, 2020** - A resident who previously tested positive for COVID-19 died at Lawrence Presbyterian Manor, as the community received good news from COVID-19 testing and the Douglas County Health Department. The resident was being cared for by the COVID-19 Rapid Response Team in a designated area of the community. The community tested health care residents and employees on September 1. All tests were negative for the virus. The Douglas County Health Department did not recommend additional testing and has cleared the campus of the COVID-19 cluster designation.

**September 4, 2020** - Manor of the Plains identified another case of COVID-19. The case was identified through the community’s new employee screening process, which includes a COVID-19 test.

**September 4, 2020** - A memory care resident tested positive for COVID-19 at Rolla Presbyterian Manor in campus-wide testing at the community.

**August 31, 2020** – A non-direct resident care employee at Manor of the Plains tested positive for COVID-19. The employee last worked August 26 and passed the employee pre-shift

screening. The health department recommends testing the potentially exposed employees Sept. 1.

**August 30, 2020** – Rolla Presbyterian Manor announced an essential health care worker has tested positive for COVID-19. The Phelps County Health Department recommends testing all residents and employees at the community this week. Testing will be done September 2.

**August 28, 2020** – Farmington Presbyterian Manor received good news with their second round of mass testing of residents and employees August 25 and 26. All employees and residents tested were negative for the virus. The St. Francois County Health Department recommended mass testing again September 1 and 2.

**August 28, 2020** - A second resident who previously tested positive for COVID-19 has died at Parsons Presbyterian Manor. The resident was being cared for by the COVID-19 Rapid Response Team in a designated area of the community. Parsons Presbyterian Manor will continue to work with the Labette County Health Department, KDHE, CMS and the CDC to stay current on all recommendations for resident care and safety.

**August 27, 2020** - Aberdeen Village has learned another non-direct resident care employee has tested positive for COVID-19. The Johnson County Health Department does not recommend additional testing at this time because the employee has not worked since August 15 and their exposure can be traced to their out of state trip.

**August 27, 2020** – Lawrence Presbyterian Manor reported two employees tested positive in follow-up testing August 26. Both employees, who are essential healthcare workers, tested negative for COVID-19 on August 18. The Douglas County Health Department recommended re-testing all health care residents and employees who meet the CDC guidelines for close contacts with possible exposure.

**August 27, 2020** - A resident who previously tested positive for COVID-19 died at Parsons Presbyterian Manor. The resident was being cared for by the COVID-19 Rapid Response Team in a designated area of the community.

**August 26, 2020** - Aberdeen Heights once again reports a non-direct resident care employee has tested positive for the virus. Residents and employees who meet the criteria will be asked to self-quarantine and be tested for COVID-19 with residents and employees of The Glen, which was already planned this week.

**August 26, 2020** – The Centers for Medicare and Medicaid Services (CMS) announced new rules requirement skilled nursing facilities to test employees regularly based upon county

transmission rates. Communities in counties with less than 5% transmission rates are required to test monthly, communities in counties with transmission rates between 5 and 10% are required to test weekly, and communities in counties with transmission rates greater than 10% are required to test twice a week. The rule was effective immediately. PMMA began working on plans for implementation of the new rules at all 16 communities.

**August 23, 2020** – An essential health care worker at Aberdeen Heights tested positive for COVID-19. The St. Louis County Health Department has recommended mass testing for all employees of The Glen, as well as residents in memory care and the health care center.

**August 23, 2020** – In mass testing at Farmington Presbyterian Manor, an essential health care employee and a contract health care worker tested positive for COVID-19. These cases brought the community's 7-day total to 3 positive employees. The St. Francois County Health Department recommended mass testing later in the week.

**August 22, 2020** - Fort Scott Presbyterian Manor has good news to share following a second wave of testing for COVID-19 at the community. All residents and employees have tested negative for the virus. Because all residents and employees tested negative for the virus, the Bourbon County Health Department is not recommending further testing at the community at this time.

**August 19, 2020** – Emporia Presbyterian Manor learned an essential health care employee tested positive for COVID-19. Per Flint Hills Community Health Department, all health care residents and employees will be tested for COVID-19 August 24.

**August 19, 2020** - Heart & Soul Hospice of Farmington (Mo.) learned that a non-direct resident care employee tested positive for COVID-19. Through contact tracing, no other employees and no patients met the CDC definition of close contact. No additional testing was required by the St. Francois County Health Department.

**August 18, 2020** – Farmington Presbyterian Manor learned a direct resident care employee tested positive for COVID-19. The St. Francois County Health Department recommended mass testing later in the week.

**August 17, 2020** – Manor of the Plains tested 132 residents and employees August 13 after another employee tested positive for COVID-19. All 132 tests were negative. The Ford County Health Department will not require any additional testing. The community will continue with the preventive measures in place for combatting COVID-19.

**August 16, 2020** – Three more residents and an additional direct resident care employee tested positive for COVID-19 at Parsons Presbyterian Manor in mass testing conducted over the weekend. Two are health care residents and one is an assisted living resident. All three were moved to the designated COVID-19 area, where they will be cared for by the COVID-19 Rapid Response Team. The employee will continue to quarantine at home. This brings the total number of cases to 8 residents and 5 employees in the past 7 days.

**August 16, 2020** – Three residents at Lawrence Presbyterian Manor tested positive for COVID-19. The community tested 10 residents and 4 employees at the direction of the Douglas County Health Department after an employee tested positive for the virus August 11. Seven residents and all 4 employees tested negative. The health department recommends campus-wide testing. Due to the number of positive cases, the community is now considered a COVID-19 cluster.

**August 15, 2020** – A Parsons Presbyterian Manor essential health care worker tested positive for COVID-19, bringing the campus' total to 5 residents and 4 employees positive for the virus. The Labette County Health Department was notified and did not recommend any additional contact tracing due to the length of time since the employee last worked and the community's planned mass testing on August 15 and 16.

**August 14, 2020** – Newton Presbyterian Manor tested 50 residents and 134 employees August 10 in mass testing. All the tests were negative.

**August 14, 2020** – A second resident at Fort Scott Presbyterian Village has tested positive for COVID-19 in the campus-wide testing August 13. The community tested 71 employees and residents. Due to the presence of two or more cases of COVID-19 at the community within the past 7 days, the community is now considered a COVID-19 cluster.

**August 13, 2020** – A resident at Fort Scott Presbyterian Village has tested positive for COVID-19. The resident began showing signs and symptoms of COVID-19 and reported them to staff August 12. The resident was tested for COVID-19 and the positive result was returned today. The resident will be cared for in isolation by the COVID-19 Rapid Response Team. The Bourbon County Health Department recommended mass testing for all residents and employees.

**August 11, 2020** – A direct-resident care employee at Lawrence Presbyterian Manor tested positive for COVID-19. The employee last worked August 9 in the health care center and passed the employee screening. The employee was tested on August 10 and notified the campus of the test on August 11. The Douglas County Health Department recommended contact tracing and testing any employees and residents who had potential exposure.

**August 9, 2020** – Parsons Presbyterian Manor tested 114 residents and employees for COVID-19 after 2 residents and 1 employee tested positive August 7 and 8. Three additional residents and two additional employees tested positive.

**August 8, 2020** – A health care resident at Parsons Presbyterian Manor began showing signs and symptoms of COVID-19. The resident and the resident's roommate were tested for COVID-19, and both were positive for the virus. The residents were moved to the designated COVID-19 area to be cared for by the COVID-19 Rapid Response Team. The Labette County Health Department recommended mass testing for the campus, which was done August 8 and 9.

**August 7, 2020** – A non-direct resident care employee at Parsons Presbyterian Manor tested positive for COVID-19. The community conducted contact tracing and identified 4 employees who were at exposure risk. They are self-quarantining at home and will be tested for COVID-19 before returning to work.

**August 7, 2020** – An essential health care worker at Manor of the Plains who last worked August 6 tested positive for COVID-19 in a rapid test. The Ford County Health Department recommends testing all residents and employees for COVID-19 within 7 days.

**August 5, 2020** – Newton Presbyterian Manor tested 138 employees and 47 residents for COVID-19. Of those tested, 3 employees and 1 resident tested positive for the virus. The Harvey County Health Department was notified of the test results, and designated the community a COVID-19 cluster. Clusters are defined as two or more non-household COVID-19 cases identified in a certain place in a specified time frame. The health department recommended re-testing in 7 days. The positive resident and the resident's roommate were placed in isolation in a designated COVID-19 area to be cared for by the COVID-19 Rapid Response Team. The employees are recuperating at home and will return to work when they meet CDC and KDHE guidelines for returning to work.

**August 4, 2020** – **Aberdeen Village** received zero deficiencies on a focused infection control survey conducted by the Kansas Department of Aging and Disability Services (KDADS) on August 4.

**August 3, 2020** – A second Newton Presbyterian Manor essential health care worker tested positive for COVID-19 after learning a close contact outside work tested positive for the virus. The employee last worked July 27 and passed the pre-shift employee screening.

**August 2, 2020** - A Fort Scott Presbyterian Village non-direct resident care employee tested positive for COVID-19 Saturday, August 1.

**July 29, 2020** - An essential health care worker at Newton Presbyterian Manor tested positive for COVID-19. The Harvey County Health Department recommends testing all health care residents and all campus employees for COVID-19.

**July 29, 2020** – Manor of the Plains received word that all residents and employees tested negative for COVID-19 in campus-wide testing conducted July 28 after an essential health care worker tested positive on July 24.

**July 27, 2020** - — Clay Center Presbyterian Manor received zero deficiencies on a focused infection control survey conducted by the Kansas Department of Aging and Disability Services (KDADS) July 27.

**July 24, 2020** – An essential health care worker at Manor of the Plains who last worked July 23 tested positive for COVID-19. The Ford County Health Department has recommended testing the all residents and employees.

**July 16, 2020** - Lawrence Presbyterian Manor has zero deficiencies on a focused infection control survey for assisted living conducted July 16. The survey was conducted by its licensing agency, the Kansas Department of Aging and Disability Services (KDADS).

**July 15, 2020** – Emporia Presbyterian Manor gets zero deficiencies on an infection control survey for assisted living conducted by the Kansas Department of Aging and Disability Services (KDADS).

**July 14, 2020** – Clay Center Presbyterian Manor gets zero deficiencies on a nursing facility focused infection control survey conducted on behalf of the Centers for Medicare and Medicaid Services (CMS).

**July 12, 2020** – Aberdeen Village notified a non-direct resident care employee tested positive for COVID-19. The employee last worked July 8 and passed employee screening.

## PMMA (Presbyterian Manors of Mid-America) Response Timeline

**July 9, 2020** – Missouri’s Department of Health and Senior Services releases plan for reopening nursing homes, assisted living and residential care facilities and declared all Missouri communities to be in Phase 1 of reopening.

**July 9, 2020** – Wichita Presbyterian Manor notified an essential health care worker tested positive for COVID-19. The employee last worked June 21 and passed the employee screening. The employee was next scheduled to work June 29. The employee called in sick and was advised to get a COVID-19 test. The medical community and CDC advise that the incubation period for COVID-19 varies from host-to-host, but that most individuals who get infected and develop symptoms will do so within at least 14 days. Because the employee has not been on campus for 18 days, there is not a risk that the employee transmitted COVID-19 on our campus.

**July 8, 2020** – The Ford County Health Department declares the outbreak at Manor of the Plains closed after all residents and employees tested negative for COVID-19 in testing conducted June 30. It was the second round of testing with all negative results.

**July 8, 2020** – Wichita Presbyterian Manor Presbyterian Manor gets zero deficiencies on a nursing facility focused infection control survey conducted on behalf of the Centers for Medicare and Medicaid Services (CMS), and zero deficiencies on an adult care home (assisted living) focused infection control survey by the Kansas Department of Aging and Disability Services (KDADS).

**July 8, 2020** – Salina Presbyterian Manor gets zero deficiencies on a nursing facility focused infection control survey conducted on behalf of the Centers for Medicare and Medicaid Services (CMS).

**July 7, 2020** – Arkansas City Presbyterian Manor gets zero deficiencies on an adult care home (assisted living) focused infection control survey by the Kansas Department of Aging and Disability Services (KDADS).

**July 1, 2020** – Lawrence Presbyterian Manor gets zero deficiencies on a nursing facility focused infection control survey conducted on behalf of the Centers for Medicare and Medicaid Services (CMS).

## PMMA (Presbyterian Manors of Mid-America) Response Timeline

**June 30, 2020** – Fort Scott Presbyterian Village gets zero deficiencies on an adult care home (assisted living) focused infection control survey by the Kansas Department of Aging and Disability Services (KDADS).

**June 30, 2020** – Aberdeen Village gets zero deficiencies on a nursing facility focused infection control survey conducted on behalf of the Centers for Medicare and Medicaid Services (CMS).

**June 28, 2020** – PMMA released a template reopening plan to its communities in Kansas and Missouri to begin planning and working with their local teams on procedures specific to their locations for reopening dining, activities and visitation. Kansas communities were required to submit plans to their local health departments for review. Missouri communities continued to wait for guidance from the Missouri Department of Health and Senior Services.

**June 24, 2020** – Manor of the Plains received zero deficiencies on a nursing facility focused infection control survey conducted on behalf of the Centers for Medicare and Medicaid Services (CMS), and an adult care home focused infection control survey by the Kansas Department of Aging and Disability Services (KDADS).

**June 24, 2020** – Topeka Presbyterian Manor gets zero deficiencies on a nursing facility focused infection control survey conducted on behalf of the Centers for Medicare and Medicaid Services (CMS).

**June 23, 2020** – Topeka Presbyterian Manor gets zero deficiencies on an adult care home (assisted living) focused infection control survey by the Kansas Department of Aging and Disability Services (KDADS).

**June 23, 2020** – Arkansas City Presbyterian Manor gets zero deficiencies on a nursing facility focused infection control survey conducted on behalf of the Centers for Medicare and Medicaid Services (CMS).

**June 23, 2020** – Salina Presbyterian Manor notified a non-direct-resident care employee tested positive for COVID-19.

**June 22, 2020** – Arkansas City Presbyterian Manor notified another non-direct-resident care employee tested positive for COVID-19. The community announced plans to test all residents and employees for COVID-19.

## PMMA (Presbyterian Manors of Mid-America) Response Timeline

**June 19, 2020** – Emporia Presbyterian Manor notified all COVID-19 tests for residents and employees from June 12 were negative. No additional testing was recommended by the Flint Hills Community Health Center.

**June 17, 2020** – Arkansas City Presbyterian Manor notified an employee tested positive for COVID-19. The employee last worked June 10. The Cowley County Health Department recommended contact tracing and testing employees who had direct contact with the positive employee. Seven members of the team were tested.

**June 17, 2020** – The Kansas Department of Aging and Disability Services releases guidance for assisted living community and home plus reopening.

**June 12, 2020** – Emporia Presbyterian Manor notified a second employee tested positive for COVID-19.

**June 12, 2020** – The Kansas Department of Aging and Disability Services releases guidance for skilled nursing community reopening.

**June 10, 2020** – Clay Center Presbyterian Manor notified an assisted living resident, who recently returned to the campus following a hospital stay, tested positive for COVID-19. The resident, who was in isolation due to the hospital stay, was tested for COVID-19 after the community learned the resident may have been exposed while off campus. The Clay County Health Department recommended testing of all residents and employees.

**June 10, 2020** – Aberdeen Heights gets zero deficiencies on a nursing facility focused infection control survey conducted on behalf of the Centers for Medicare and Medicaid Services (CMS).

**June 4, 2020** – Emporia Presbyterian Manor notified a non-direct resident care employee tested positive for COVID-19.

**June 3, 2020** – Parson Presbyterian Manor received zero deficiencies on a nursing facility focused infection control survey conducted on behalf of the Centers for Medicare and Medicaid Services (CMS).

**May 30, 2020** – A health care resident living in The Glen at Aberdeen Heights tests positive for the novel Coronavirus 2019 (COVID-19). The resident was diagnosed with pneumonia and was subsequently tested for COVID-19 at the direction of Dr. Alka Kapoor, Aberdeen Heights' medical director, as part of her standard protocol. The health department recommended June 1

that all Aberdeen Heights employees and residents in The Glen, which includes assisted living, health care and memory support, be tested for COVID-19.

**May 28, 2020** – Farmington Presbyterian Manor gets zero deficiencies on a nursing facility focused infection control survey conducted on behalf of the Centers for Medicare and Medicaid Services (CMS).

**May 23, 2020** – Manor of the Plains reported a cluster of COVID-19 infections to the Centers for Disease Control and Prevention (CDC) and the Ford County Health Department after 1 resident and 1 additional employee tested positive for the virus on May 23.

**May 20, 2020** – Manor of the Plains was notified a second essential health care employee tested positive for COVID-19. Employees and family members were notified of the positive test and the health department recommendations.

**May 18, 2020** – The Centers for Medicare and Medicaid Services (CMS) releases guidance for states to begin reopening skilled nursing facilities to visitors. The authority to determine how skilled nursing facilities reopen was given to states. CMS also announced plans for focused infection control surveys.

**May 7, 2020** – Manor of the Plains was notified an essential health care employee tested positive for COVID-19. The employee last worked April 26. The employee passed the employee screening for their shift April 26, and was not scheduled to work again until May 9. On May 6, the employee was tested for COVID-19 and the results were received May 7. Manor of the Plains contacted the Kansas Department of Health and Environment (KDHE) epidemiology hotline and notified the state about the positive test. KDHE did not consider the staff member to be infectious during the last shift worked 11 days prior and recommended no further action be taken. Employees and family members were notified of the positive test and KDHE's recommended response.

**April 30, 2020** – Newton Presbyterian Manor notified an essential health care employee tested positive for COVID-19. The employee last worked April 21. The employee is in isolation and quarantined at home.

The employee passed the employee screening for their shift April 21, but the employee was sent home during the shift when they started feeling unwell. The employee next reported for work April 23, but did not pass the screening and was sent home. The employee was tested April 24 for COVID-19, and the test was negative. The employee did not return to work. On April 28 when the employee was still not feeling well, the employee was tested a second time, and tested positive for COVID-19.

## PMMA (Presbyterian Manors of Mid-America) Response Timeline

The Harvey County Health Department advised Newton Presbyterian Manor to monitor residents in health care and memory care and other staff members for five days for any signs or symptoms of respiratory illness and signs of COVID-19.

**April 1, 2020** – Aberdeen Heights notified an independent living resident receiving treatment at a local hospital tested positive for COVID-19. The resident had been off-campus since March 25.

The state of Missouri has issued guidance to hospitals and senior living communities to ensure the resident is free of COVID-19 symptoms before the resident can return to the campus.

Independent living residents were notified and were strongly advised to adhere to the no visitor “rule,” and limit the number of medically non-essential appointments, events and gatherings attended off campus.

**March 23, 2020** – Parsons Presbyterian Manor notified a non-direct care staff member tested positive for COVID-19 in a neighboring county. The employee had not had a temperature and was not displaying other symptoms of COVID-19.

The community acted swiftly to ensure the safety of residents and other staff members. All residents placed in isolation for the next 14 days. During that time, residents to be checked for fever and other signs and symptoms of COVID-19 at each shift change. Residents were already being checked daily for fever and symptoms of COVID-19. Families and care partners were notified. All staff members are following CDC guidelines and best practices as these are continually updated.

Staff members who had direct contact with the affected staff member were placed on 14-day home quarantine and monitored for symptoms.

**March 17, 2020** – Heart and Soul Hospice, a wholly owned service of PMMA, releases statement on protocols in use to ensure health of hospice patients on service and to assure referring agencies that both locations are still accepting new patients.

**March 17, 2020** – A COVID-19 information page is added to the Heart & Soul Hospice website based on recommendations by the CDC and the National Hospice and Palliative Care Organization. The website is shared by the two locations. Previously, prevention information had been shared on the hospices’ Facebook pages.

**March 16, 2020** – PMMA released a new LIMITED ACCESS poster updating the in-person visitor exception to end-of-life situations only per March 13 CMS guidance. Visitor questionnaire updated to include questions about domestic travel.

## PMMA (Presbyterian Manors of Mid-America) Response Timeline

**March 16, 2020** – PMMA released communications to staff about increased access to telehealth through company health plan, whether a participating employee or not, and lifted restrictions on prescription refills for maintenance medications. Separate memo addresses travel and PTO. Employees who travel domestically to places with active COVID-19 cases, on cruise ships or internationally will not be allowed to return to work and will be expected to observe a 14-day quarantine upon return.

**March 14, 2020** – PMMA communities discontinue all communal dining and group activities, per CMS guidance on March 13, 2020. Residents educated on principles of social distance (6-foot between individuals at all times), and encouraged to practice the principles in conducting activities of daily life. PMMA communities begin screening all employees and checking for fever before starting a shift.

**March 13, 2020** – PMMA moves all communities to LIMITED ACCESS in response to CMS guidance. Community websites are updated to explain LIMITED ACCESS.

**March 13, 2020** – PMMA institutes weekly COVID-19 update calls with corporate staff and PMMA community leaders.

**March 13, 2020** – PMMA's corporate marketing team meets with community marketers to discuss marketing strategies and tactics for LIMITED ACCESS communities.

**March 13, 2020** – First case of COVID-19 is announced in Sedgwick County. Three additional communities in Sedgwick and surrounding counties are added to the LIMITED ACCESS list. Information released later reveals the case is a Butler County man who was tested at a Wichita hospital.

**March 12, 2020** – PMMA posts a blog explaining the difference between LIMITED ACCESS and Visitation Discouraged on all PMMA community site blogs and the PMMA blog.

**March 10, 2020** – PMMA adopts CMS guidelines released March 9 creating two levels of visitation for senior health care centers. Three communities are placed on LIMITED ACCESS due to confirmed COVID-19 cases in their county or a surrounding county. Under the March 9 recommendations, access was limited except in the cases of end-of-life situations and where the visitor was necessary for the care and wellbeing of the resident. All other PMMA communities are placed on discouraged visitation, meaning visitation was discouraged unless absolutely necessary.

**March 9, 2020** – PMMA launches social media communications regarding COVID-19 on all community Facebook pages as well as the PMMA and hospice Facebook pages. Updates continue there throughout the crisis.

**March 7, 2020** – COVID-19 information pages are added to all 16 community websites and the corporate website. The same information is provided to charter members at Aberdeen Ridge through a members-only area of the Aberdeen Ridge site the week of March 9.

**March 7, 2020** – Kansas and Missouri announce first possible cases of COVID-19 identified.

**March 6, 2020** – PMMA distributes a family letter regarding COVID-19 to all of its 16 communities for residents, families, volunteers and guests. Posters warning against visiting campuses if displaying of signs of COVID-19 or having recent international travel are distributed to PMMA communities and hung at entrances prior to weekend visits beginning. Additional COVID-19 resources are sent to communities as well to help teams in efforts to prevent COVID-19 from entering the buildings.

**March 6, 2020** – PMMA distributes letter to employees and resources for dealing with illness via PMMA Employee newsletter. The employee letter and resources from CDC also are provided for all PRN and agency staff.

**March 3, 2020** – PMMA has first interdisciplinary novel Coronavirus 2019 call with all of its communities and corporate staff. Work begins on letters to residents, families and employees and posters for entry doors to all communities.

**Mid-January 2020** – PMMA began having dialogue with our teams and communities about the COVID 19 virus. We looked at our infection control practices and policies, reviewed hand hygiene education with staff and residents, and began the process of preparation for this pandemic.
