GENERAL CONTRACT FOR SERVICES

This contract for Services is made effective _____ (mm/dd/yy) by and between Stretch & Catch® Reading Center and said Client_____.

1. DESCRIPTION OF SERVICES. Beginning _____ (mm/dd/yy) Stretch & Catch® will provide to Client, Educational Services.
2. PAYMENT: Invoices will be sent at the beginning of each month through QuickBooks. Invoices are required to be paid in full before the beginning of each month's first session. Cancellations must be made 24 hours in advance in order to receive a make-up session. Make-up sessions must be made within the same month. Monthly payments are \$60 per 30 minute sessions. Every month you will receive an invoice. The invoice will list the days your child will be at the Stretch & Catch® Reading Center. If you know in advance that your child is unable to make a session, you must email stretchandcatch@gmail.com to schedule a make-up class. All make up sessions must be done within that same month.
You can prepay in advance for a FIFTEEN 30-minute session package for \$800. Prepaid sessions must have all 15 sessions scheduled in advance. There are no make-up sessions with this package. The Stretch & Catch® Reading Center also offers a TEN 45-minute session package for \$800. Prepaid sessions must have all 10 sessions scheduled in advance. There are no make-up sessions with this package. Packages of 15 must be used within 16 weeks and packages of 10 must be used within 11 weeks. If the invoice is not paid when due, the student cannot attend the session. If you wish to use a credit card to pay the balance, there will be a 3.5% charge.
3. TERM: This Agreement is effective throughout the child's enrollment at Stretch & Catch® Reading Center.
