Admission into Full Communion with the Catholic Church

The baptism of adults, at least of those who have completed their fourteenth year, is to be referred to the diocesan Bishop (Canon 863) through the Chancery. Likewise, application for permission to receive baptised Christians into Full Communion with the Catholic Church and to confirm previously-baptised Catholics is to be made on this form to the Chancery. The form is to be submitted *before* the requested sacraments are celebrated.

If there is doubt as to whether a person was baptised or whether a baptism was conferred validly, and after serious enquiry this doubt persists, the person is to be baptised conditionally. Those baptised in a non-Catholic ecclesial community are not to be baptised conditionally unless there is a serious reason for doubting the validity of their baptism, on the ground of the matter or the form of words used in the baptism, or of the intention of the adult being baptised or of that of the baptising minister.

The ordinary minister of confirmation is a Bishop. For validity, a priest wishing to confer the sacrament of confirmation must have the faculty to do so, either from the universal law or by way of a special grant from the competent authority (Canons 882-884).

*In so far as possible, a person being baptised is to be assigned a sponsor. In the case of an adult baptism, the sponsor's role is to assist the person in Christian initiation (Canon 872). In the case of confirmation, the sponsor's function is to take care that the person confirmed behaves as a true witness of Christ and faithfully fulfils the duties inherent in this sacrament (Canon 892). To be admitted to undertake the office of sponsor, a person must:

1. be suitable for this role and have the intention of fulfilling it;
2. be not less than sixteen years of age;
3. be a Catholic who has been confirmed and has received the blessed Eucharist, and who lives a life of faith which befits the role to be undertaken;
4. not be either the father or the mother of the person being baptised or confirmed.

The registration of baptism, reception and confirmation is to be made as follows:

All baptisms (except conditional baptisms) are to be entered in the parish register of baptisms.

The conferral of conditional baptism is to be recorded in the parish register of reception.

The reception into Full Communion of those previously baptised in another ecclesial community is to be entered in the parish register of reception.

For all of the above, an entry is to be made in the index at the back of the register of reception.

The confirmation of a previously-baptised Catholic is to be made in the parish confirmation register and a notification sent to the place of baptism.

Protocol Numbers given by the Chancery should be entered in the margin of the respective parish registers.
